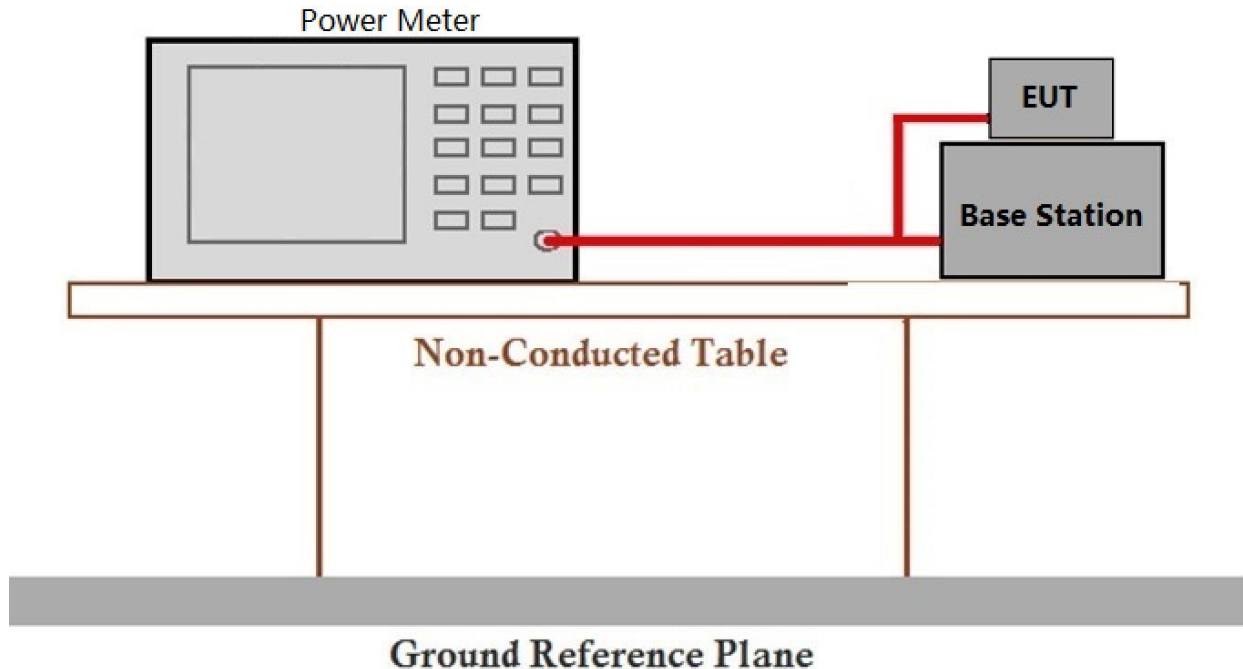

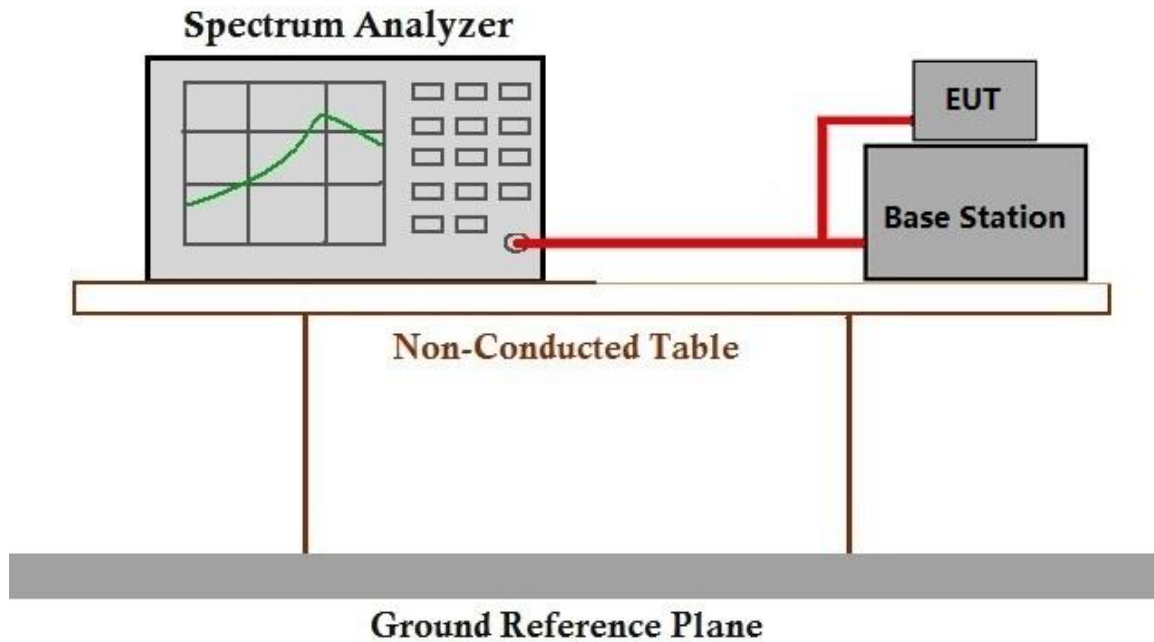

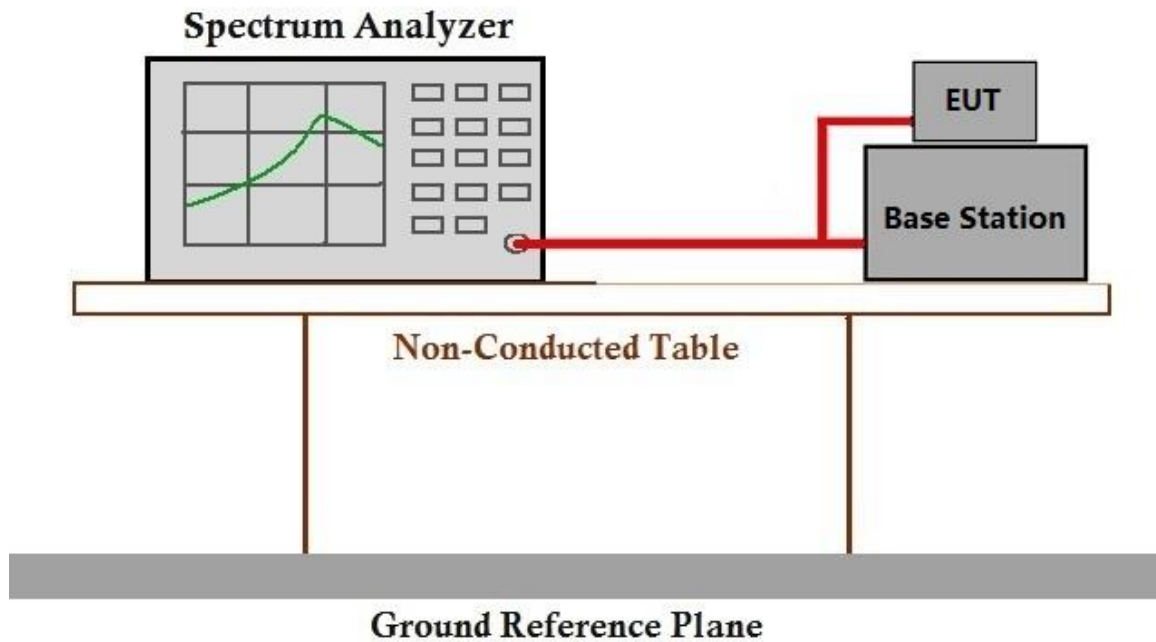

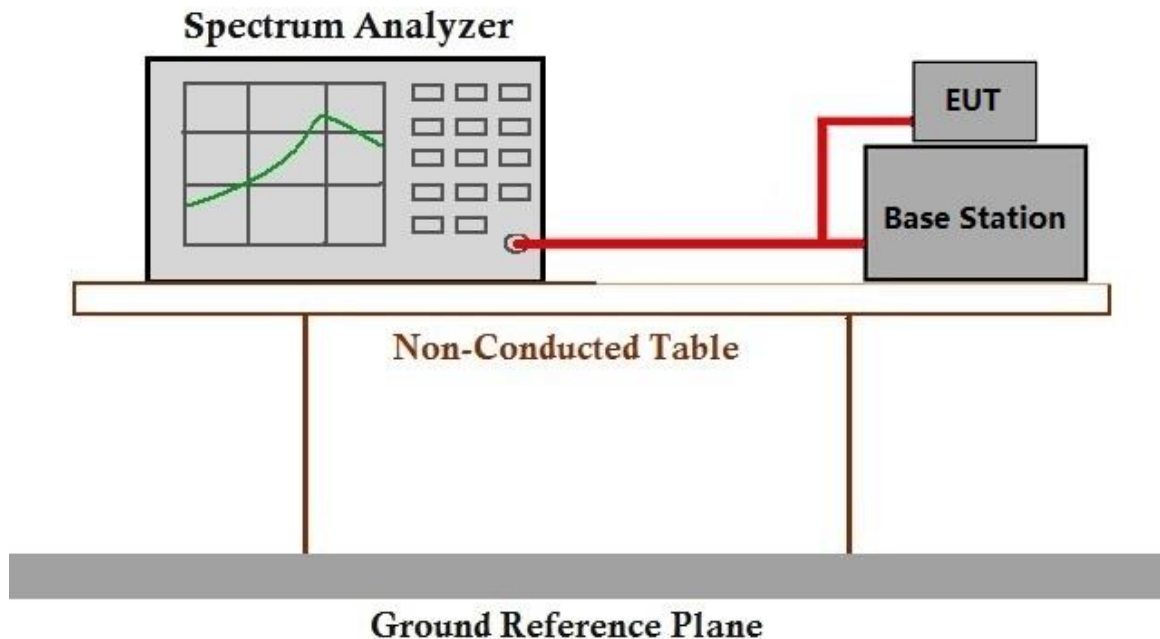

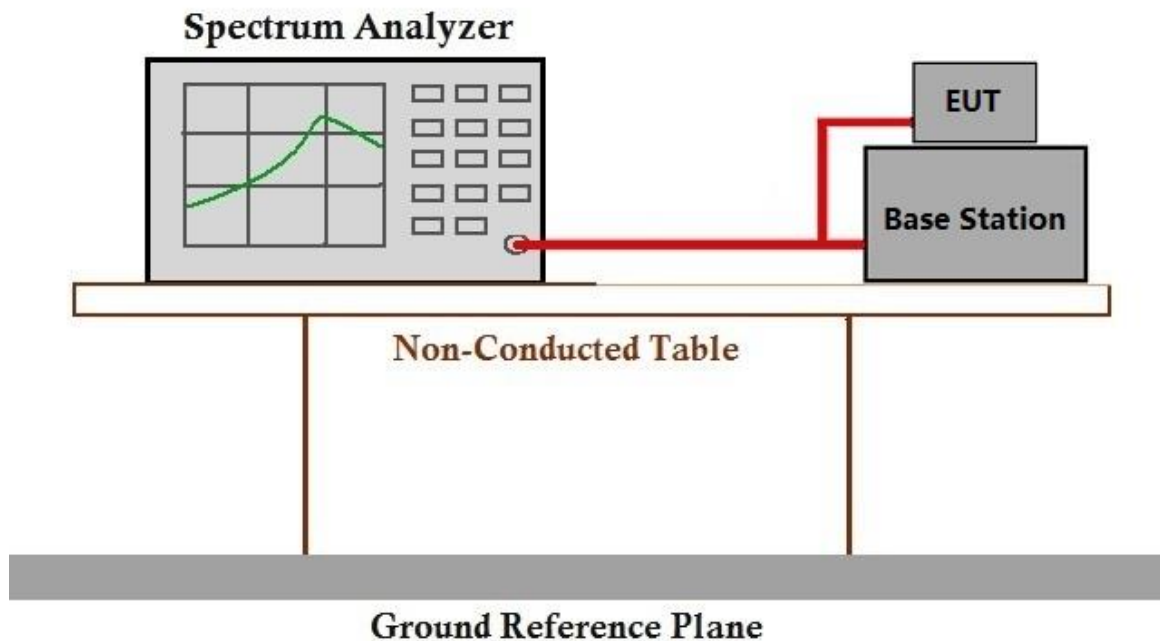

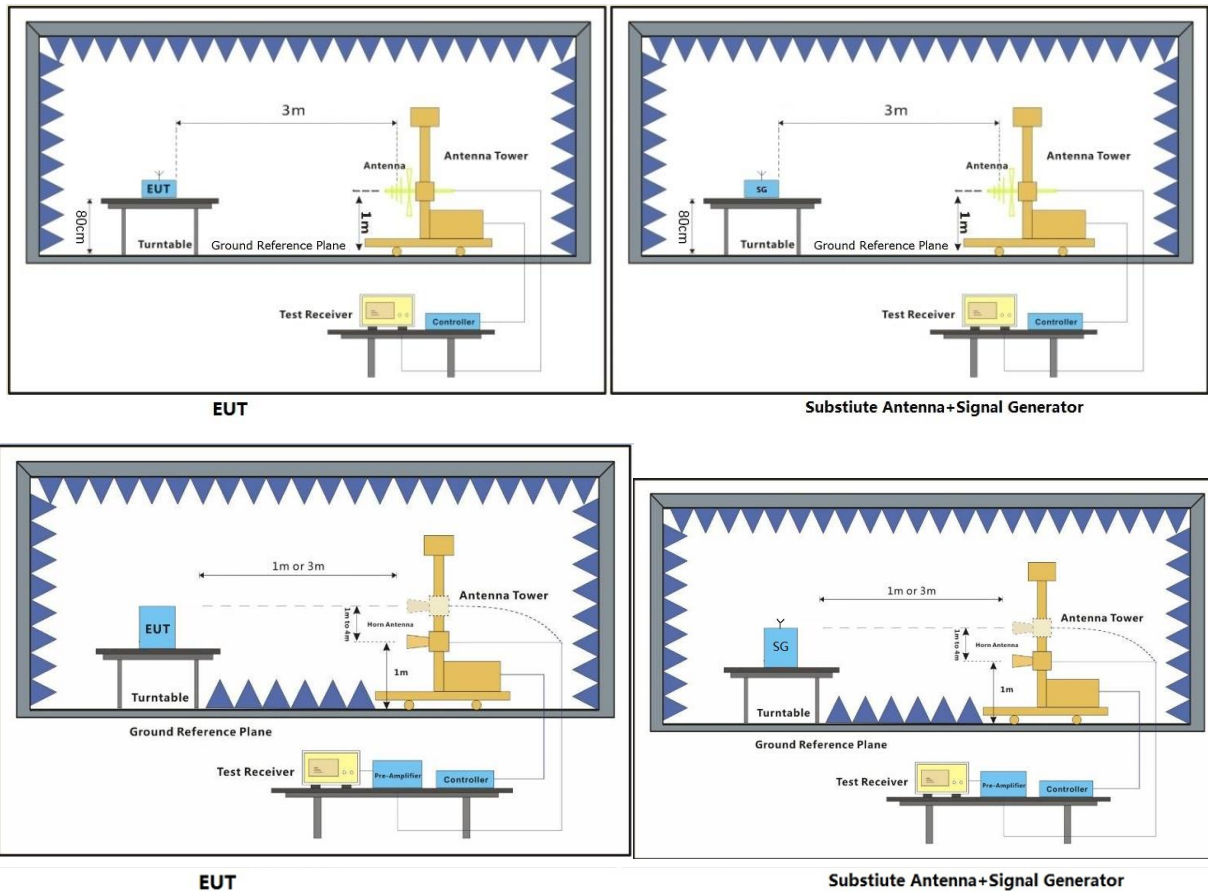

- (10) Replace the antenna with a proper Antenna (substitution antenna).
- (11) The substitution antenna shall be oriented for vertical polarization and, if necessary, the length of the substitution antenna shall be adjusted to correspond to the frequency of transmitting.
- (12) The substitution antenna shall be connected to a calibrated signal generator.
- (13) If necessary, the input attenuator setting of the measuring receiver shall be adjusted in order to increase the sensitivity of the measuring receiver.
- (14) The test antenna shall be raised and lowered through the specified range of the height to ensure that the maximum signal is received.

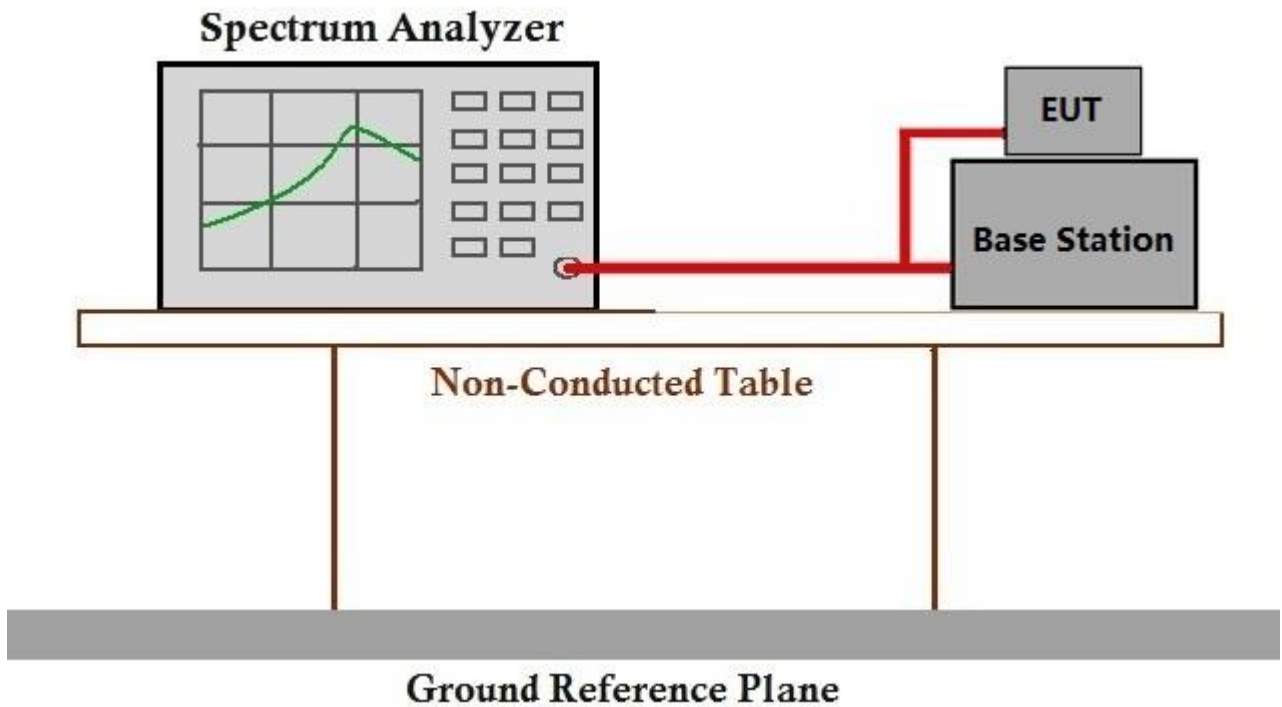

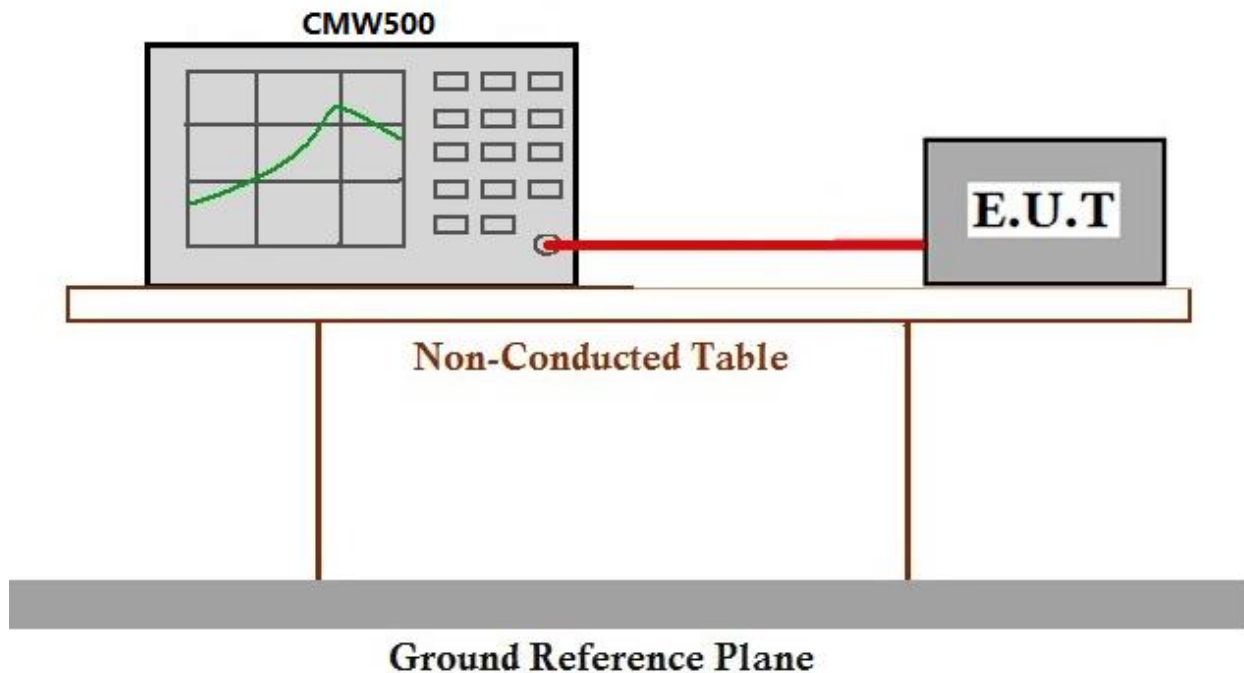
