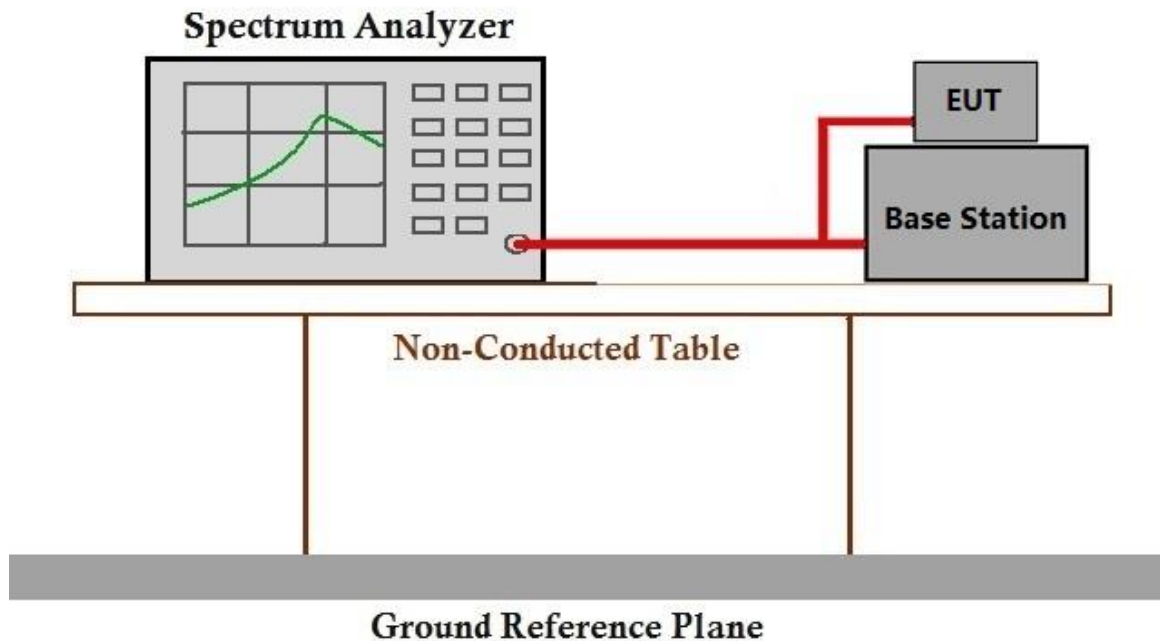

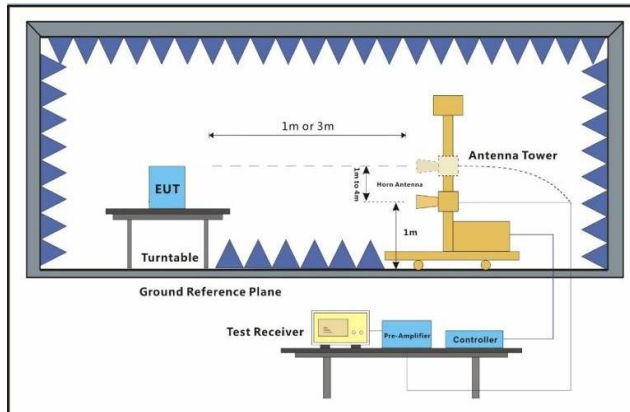
6.6.2 Test Setup Diagram



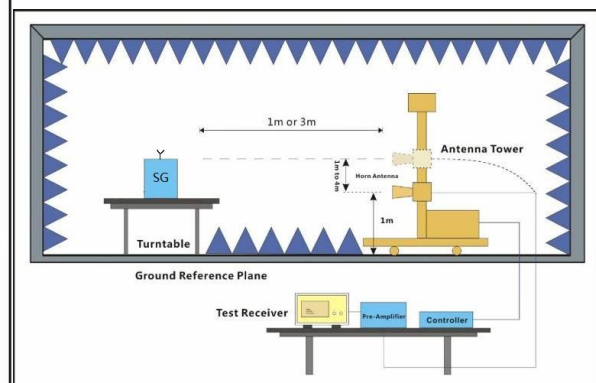

6.6.3 Measurement Procedure and Data

- (1) On a test site, the EUT shall be placed on a turntable and in the position closest to the normal use as declared by the user.

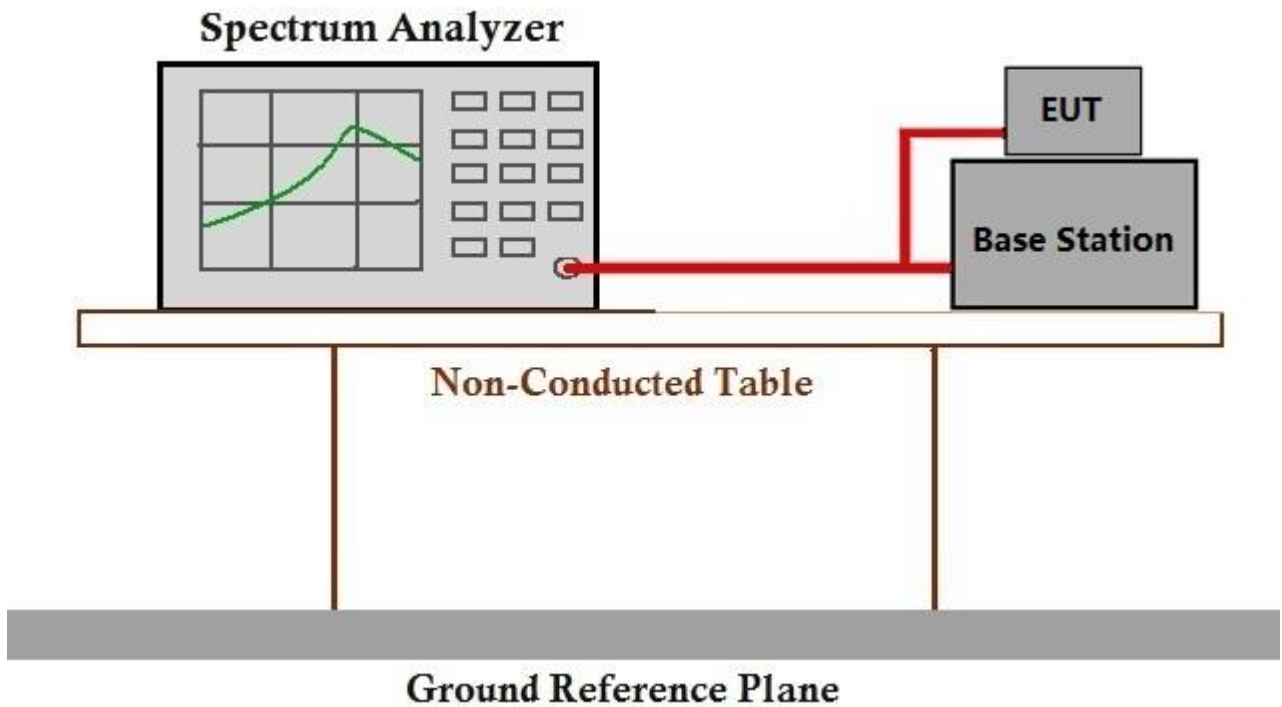

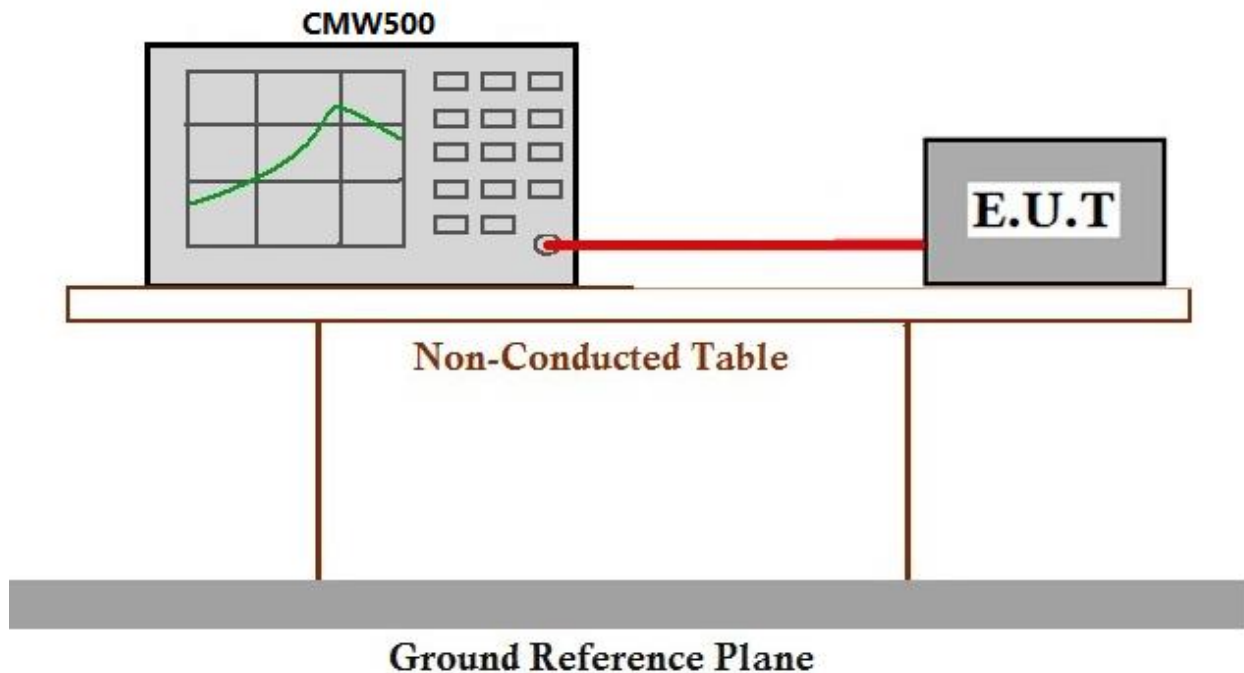
