Cover Letter for re-use of Test Data

To Whom It May Concern:

The initial application has been granted according to 47CFR Part 15.407 for FCC ID: **V65E4810**. The new equipment to be Granted in this new application, according to FCC ID: **V65E4830**, only differs from the initial version (FCC ID: **V65E4810**) with the only 1 following point:

1. The PCBs used in the E4810 and E4830 are identical..
2. There is no change to the WiFi or BT layout or components from the E4810 to the E4830 since the boards are identical.
3. The RFIC in the E4830 is a pin for pin drop in replacement for the RFIC in the E4810. The update may be related to different cellular bands being supported.
4. The GNSS device was added to the E4830, this was unpopulated in the E4810.
5. The barometric pressure sensor was added to the 4830, this was unpopulated in the E4810.

The described above do not affect the radio characteristics (802.11a/b/g/n) of the equipment. Consequently, radio test data retrieved from the initial application FCC ID: **V65E4810** can be re-used for the FCC ID: **V65E4830** equipment.

However, Based on our knowledge and our engineering judgment of the device design, the changes made, the format and amount of spot-check test data are decided as below,

1. Sample amount: 3
2. Spot-check rule part, frequency band and test items
3. Spot-check measurement result refer to the test report of FCC ID: **V65E4830** equipment.
