## 4 RF Exposure Evaluation

### 4.1 RF Exposure Compliance Requirement

#### 4.1.1 Limits

Friis Formula

Friis transmission formula:  $P_d = (P_{out} * G) / (4 * \pi * R^2)$

Where

$P_d$  = power density in mW/cm<sup>2</sup>

$P_{out}$  = output power to antenna in mW

G = gain of antenna in linear scale

$\pi$  = 3.1416

R = distance between observation point and center of the radiator in cm

$P_d$  is the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

#### 4.1.2 Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.



#### **4.1.3 EUT RF Exposure Evaluation**

Antenna Gain: 4.1dBi

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 2.570 in linear scale.

Output Power Into Antenna & RF Exposure Evaluation Distance:

The distancer (4th column) calculated from the Fries transmission formula is far greater than 20 cm separation requirement.
