GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The Jiangxi Midea Guiya Green Lighting Electrical Co., Ltd's model: GYS18GU/2700K, GYS26GU/2700K (FCC ID: VGZGYS18GUS26GU) (the "EUT") in this report was a CFL, which was measured approximately: 6.0 cm (L) x 4.5 cm (W) x 10.9 cm (H) for model GYS18GU/2700K, 6.0 cm (L) x 4.5 cm (W) x 11.8 cm (H) for model GYS26GU/2700K, and rated input voltage: AC 120V/60Hz.

Note: The serial product, model GYS18GU/2700K, GYS18GU/4100K, GYS26GU/2700K and GYS26GU/4100K are electrically identical, they just have different power, color temperature, size and choke trans, which was explained in the attached declaration letter, and we selected GYS18GU/2700K and GYS26GU/2700K to test.

** All measurement and test data in this report was gathered from production sample serial number: 1110009 (Assigned by BACL, Shenzhen). The EUT was received on 2011-10-14.*

Objective

This test report is prepared on behalf of Jiangxi Midea Guiya Green Lighting Electrical Co., Ltd in accordance with Part 2-Subpart J, and Part 18-Subparts A, B and C of the Federal Communication Commissions rules and regulations.

The objective of the manufacturer is to determine compliance with FCC Part 18 limits.

Test Methodology

All measurements contained in this report were conducted with MP-5, FCC Methods of Measurements of Radio Noise Emissions from ISM Equipment, February 1986. All measurement was performed at Bay Area Compliance Laboratories Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 382179. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.

Additionally, Bay Area Compliance Laboratories Corp. (Shenzhen) is an ISO/IEC 17025 accredited laboratory, and is accredited by National Voluntary Laboratory Accredited Program (Lab Code 200707-0).





Applicable Standard

Conduction limits. For the following equipment, when designed to be connected to the public utility (AC) power line the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies shall not exceed the limits in the following tables. Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal using a 50 μ H/50 ohms line impedance stabilization network (LISN).



Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on CISPR 16-4-4, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of any conducted emissions measurement at Bay Area Compliance Laboratories Corp. is ± 2.4 dB ($k=2$, 95% level of confidence).

EUT Setup



- Note: 1. Support units were connected to second LISN.
 2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

The setup of EUT is according with MP-5: 1986 measurement procedure. Specification used was with the FCC Part 18 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The EUT was connected to a 120 VAC/60 Hz power source.

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 450 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Test Procedure

During the conducted emission test, the EUT was connected to the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.



Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-4, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Bay Area Compliance Laboratories Corp. (Shenzhen) is ± 4.0 dB (k=2, 95% level of confidence).

EUT Setup



The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the FCC MP - 5.

The EUT was connected to 120 VAC/60 Hz power source.

EMI Test Receiver Setup and Spectrum Analyzer Setup

The system was investigated from 9 kHz to 30 MHz.

During the radiated emission test, the EMI test receiver and Spectrum Analyzer were set with the following configurations:

Corrected Amplitude Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

$$\text{Corrected Amplitude} = \text{Meter Reading} + \text{Antenna Factor} + \text{Cable Loss}$$
