

## Troubleshooting

- Operating System requests for Device Driver installation
  - If AT77UR200 has been connected to the PC before software installation, then uninstall the device in device manager and restart the setup in the correct order.
  
- Fingerprint image poor quality
  - Improve finger swipe by:
    - starting at last knuckle joint and swiping to finger tip,
    - keeping finger flat against sensor
    - maintaining consistent pressure over sensor throughout swipe
