





2. Connect the power sensor to the PC.
3. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
4. Record the maximum power from the software.



### Test Graphs of DTS Bandwidth





**Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands**




### Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands








