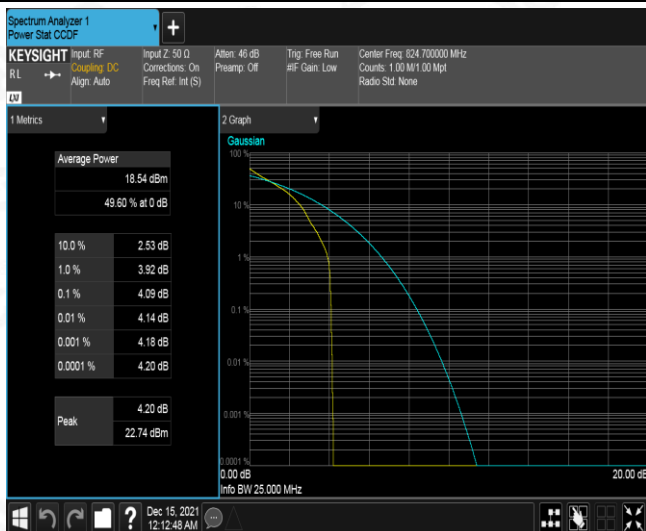

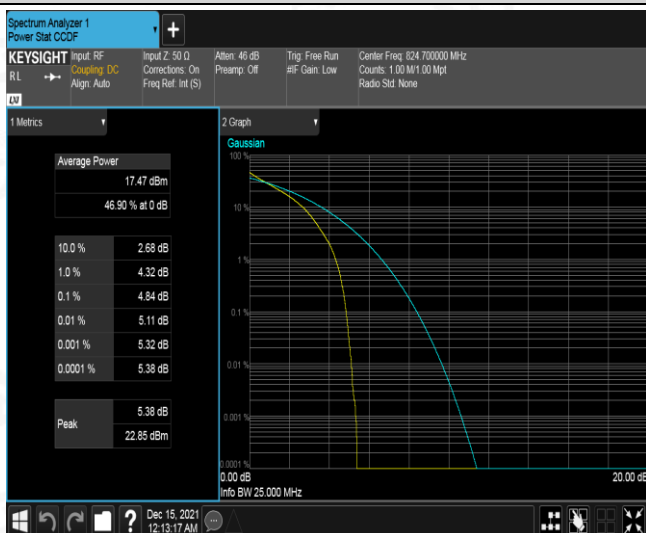

Band5-1.4MHz-QPSK-20407-6RB#0

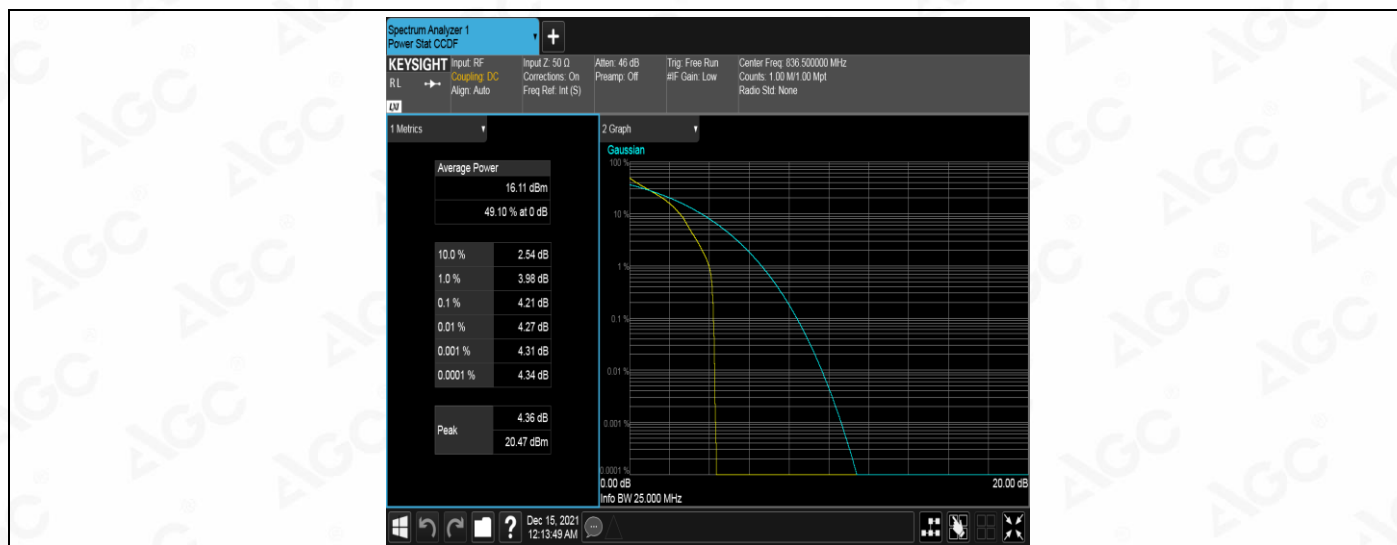


Band5-1.4MHz-QPSK-20525-1RB#0

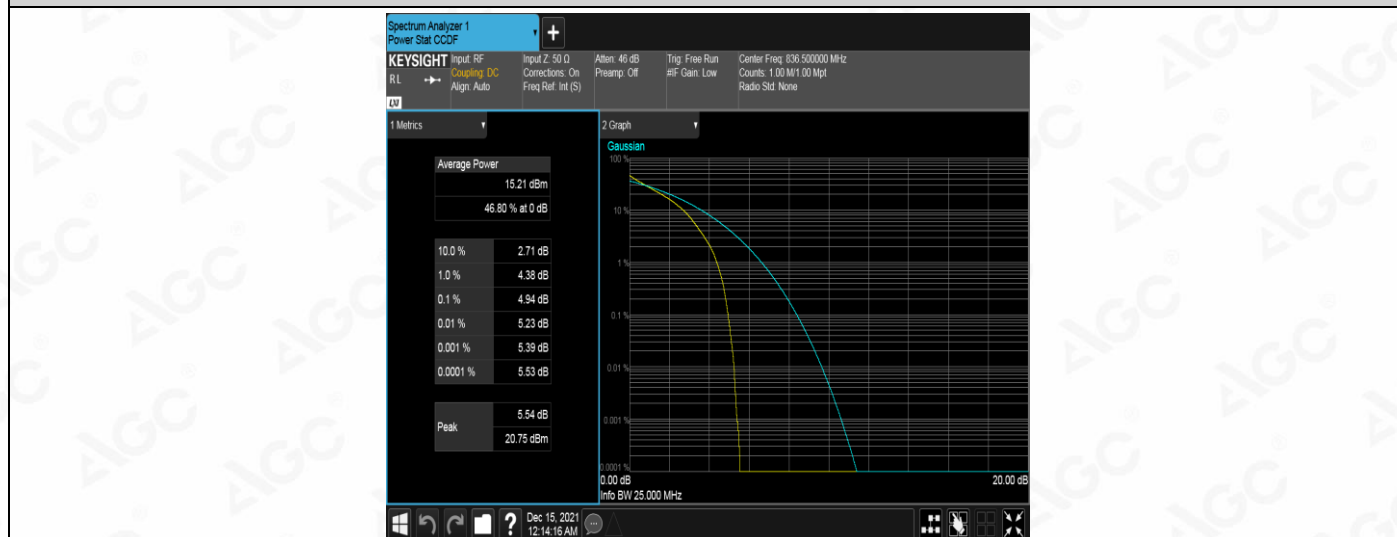

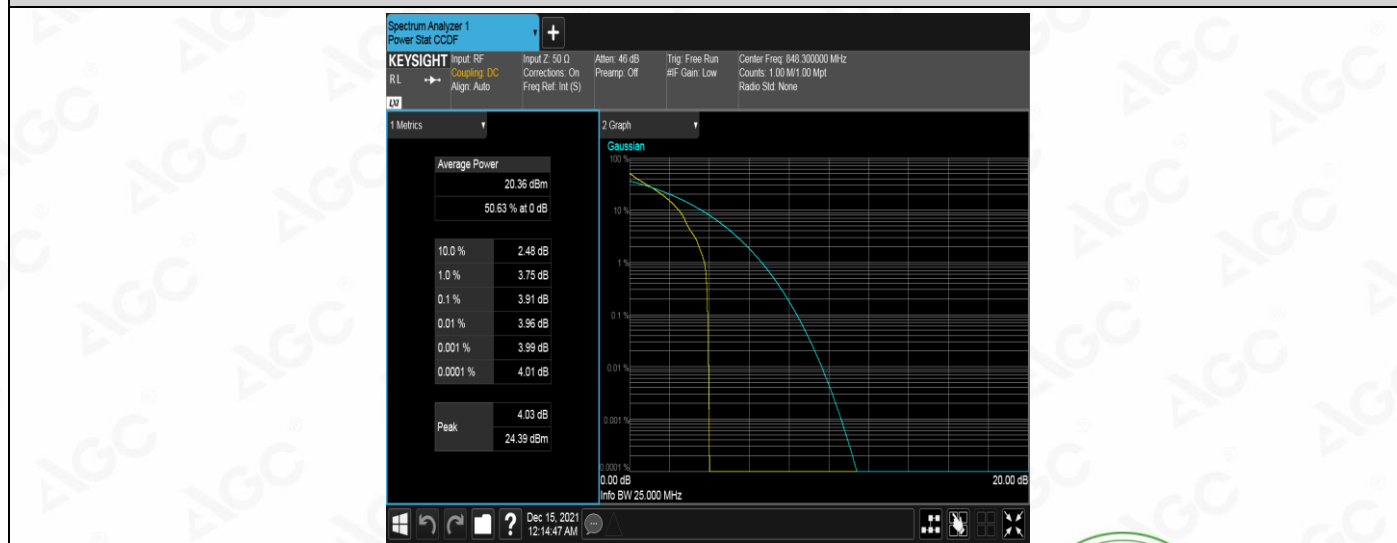




Band5-1.4MHz-QPSK-20525-6RB#0
