**Band7-20MHz-16QAM-21350-1RB#0**

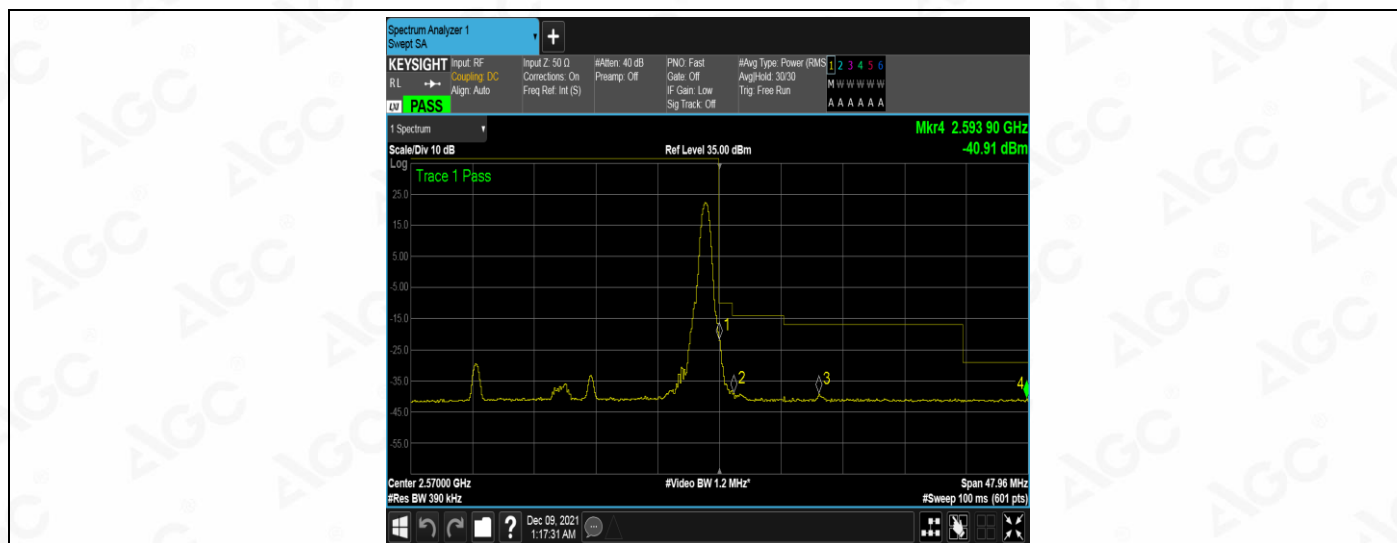

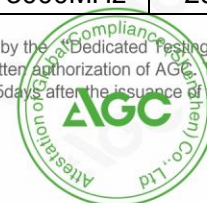

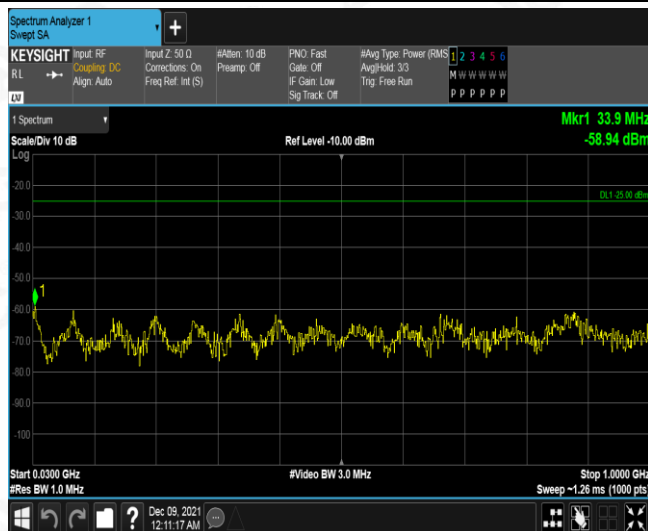
