### 5 SAR Evaluation

## **5.1** RF Exposure Compliance Requirement

### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v05r02

4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 5.1.2 Limits

At frequencies below 100 MHz, the following may be considered for SAR test exclusion:

- a) The power threshold at the corresponding test separation distance at 100 MHz in below step 1) is multiplied by  $[1 + \log(100/f(MHz))]$  for test separation distances > 50 mm and < 200 mm
- b) The power threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by  $\frac{1}{2}$  for test separation distances  $\leq$  50 mm.
- 1) [Power allowed at numeric threshold for 50 mm in step 1) + (test separation distance 50 mm)·( f(MHz)/150)] mW, at 100 MHz to 1500 MHz

### 5.1.3 EUT RF Exposure

The maximum conducted output power specified is -31.43dBm = 0.0007mW

The source- based time-averaging conducted output power

= 0.0007 \* Duty Cycle mW= 0.0004mW

The SAR Exclusion Threshold Level for 27.145MHz when the minimum test separation distance is < 50mm:

- = 474 \* [1 + log(100/f(MHz)]/2
- = 371.2 mW

Since the source-based time-averaging conducted output power is well below the SAR low threshold level, so the EUT is considered to comply with SAR requirement without testing.
