1.0 General Description

1.1 Product Description

The equipment under test (EUT) is a receiver with 96 channels operating at 640.1MHz to 663.9 MHz used for Tour Guide System. The EUT is power by 2 AAA batteries.

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

1.2 Related Submittal(s) Grants

This is a single application for certification of a receiver.

1.3 Test Methodology

Radiated emission measurements were performed according to the procedures in ANSI C63.4 (2003). All radiated measurements were performed in a Semi-anechoic Chamber. Preliminary scans were performed in the Semi-anechoic Chamber only to determine worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the **“Justification Section”** of this Application.

1.4 Test Facility

The Semi-chamber facility used to collect the radiated data is **Interterk Testing Services Shenzhen Ltd. Kejiyuan Branch** and located at 6F, D Block, Huahan Building, Langshan Road, Nanshan District, Shenzhen, P. R. China. This test facility and site measurement data have been fully placed on file with the FCC.

2.0 **System Test Configuration**

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2003).

The device was powered from 2 new AAA batteries.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. The step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The unit was operated standalone and placed in the center of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was placed on turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

The frequency range from 30MHz to 5GHz was searched for spurious emissions from the device. Only those emissions reported were detected. All other emissions were at least 20 dB below the applicable limits.

2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it received continuously.

2.3 Special Accessories

There are no special accessories necessary for compliance of this product.



3.0 Emission Results

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

INTERTEK TESTING SERVICES

3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CF - AG$$

where FS = Field Strength in dB μ V/m
RA = Receiver Amplitude (including preamplifier) in dB μ V
CF = Cable Attenuation Factor in dB
AF = Antenna Factor in dB
AG = Amplifier Gain in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows:

$$FS = RR + LF$$

where FS = Field Strength in dB μ V/m
RR = RA - AG in dB μ V
LF = CF + AF in dB

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29 dB is subtracted, giving a field strength of 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

RA = 52.0 dB μ V/m	RR = 23.0 dB μ V
AF = 7.4 dB	LF = 9.0 dB
CF = 1.6 dB	
AG = 29.0 dB	
FS = RR + LF	
FS = 23 + 9 = 32 dB μ V/m	

$$\text{Level in } \mu\text{V/m} = \text{Common Antilogarithm } [(32 \text{ dB}\mu\text{V/m})/20] = 39.8 \mu\text{V/m}$$

8.1 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services Shenzhen Ltd. Kejiyuan Branch in the measurements of superheterodyne receivers operating under the Part 15, Subpart B rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.4 - 2003. The local oscillator of the superheterodyne receiver is stabilized prior to measurement by generating a typical or an unmodulated CW Signal at the operating frequency of the receiver. The signal is usually generated as CW with a Marconi 2022D signal generator and a short whip antenna and is at a level of several hundred to several thousand mV/m. If a modulated signal is used, it will be noted.

The equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the groundplane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axis to obtain maximum emission levels. The antenna height and polarization are also varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings.

The frequency range scanned is from 30MHz to 5000MHz.

INTERTEK TESTING SERVICES

8.1 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements were made as described in ANSI C63.4 - 2003.

The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Measurements are normally conducted at a measurement distance of three meters. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.
