

EN Testing the Reception

Leave at least 20ft (6m) of distance between the Parent and the Child Unit. Have one person begin speaking softly at first, and gradually louder, into the MIC on the Baby Unit. Have another person check the audio quality and other various functions on the Parent Unit.

Repeat the above test in various places where BabyFigure™ is to be used.

Troubleshooting

Link light does not light at all	BabyFigure™ is not turned on	Turn on the Power button

Audio feedback volume (squealing)	Child Unit is too close to the Parent Unit	Move the Parent Unit further away from the Child Unit

Link light blinks	Out of range	Operate Parent Unit closer to the Child Unit

◆ Audible Beep Troubleshooting

There are 2 types of Audible Beep and each signifies a different alert.

1. Out of Audio Link Range : Bring the Parent Unit closer to the Child Unit.
2. Paging the Parent Unit : Trace the beep to locate the Parent Unit.
