

4. TEST CONDITIONS AND RESULTS

4.1. Conducted Emissions Test

TEST CONFIGURATION



TEST PROCEDURE

- 1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.4.
- 2 Support equipment, if needed, was placed as per ANSI C63.4.
- 3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.4.
- 4 The EUT received DC9 V power from the battery.
- 5 All support equipments received AC power from a second LISN, if any.
- 6 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8 During the above scans, the emissions were maximized by cable manipulation.

4.2. Occupied Bandwidth and Emission Mask

PROVISIONS APPLICABLE


According to FCC 2.1049 (c) (1), for radiotelephone transmitter, other than single sideband or independent sideband transmitter, when modulated by a 2.5 kHz tone at an input level 16 dB greater than that necessary to produce 50 percent modulation. According to §74.861(e)(5), the operating bandwidth shall not exceed 200 kHz.

MEASUREMENT PROCEDURE

According to TIA-603 for additional Test Set-Up procedures, the occupied bandwidth of emission was measured with a Spectrum Analyzer connected to the antenna terminal while EUT was operating in 2.5kHz tone at an input level 16 dB greater than that necessary to produce 50 percent modulation. Then mark the -26dB Bandwidth and record it.


- 1). The EUT was placed on a turntable which is 0.8m above ground plane.
- 2). Set EUT as normal operation
- 3). Set SPA Center Frequency = fundamental frequency , RBW=3 KHz,VBW= 10 KHz, Span =100 KHz.
- 4). Set SPA Max hold. Mark peak, -26dB.

TEST SETUP BLOCK DIAGRAM








Emission Mask: input with 5 kHz AF, 50% modulation + 16dB.

Emission Mask: input with 15 kHz AF, 50% modulation + 16dB.








(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

TEST PROCEDURE

- 1). On a test site, the EUT shall be placed on a turntable, and in the position closest to the normal use as declared by the user.
- 2). The test antenna shall be oriented initially for vertical polarization located 3m from the EUT to correspond to the transmitter.
- 3). The output of the antenna shall be connected to the measuring receiver and either a peak or quasi-peak detector was used for the measurement as indicated on the report. The detector selection is based on how close the emission level was approaching the limit.
- 4). The transmitter shall be switched on; if possible, without the modulation and the measurement receiver shall be tuned to the frequency of the transmitter under test.
- 5). The test antenna shall be raised and lowered through the specified range of height until the measuring receiver detects a maximum signal level.
- 6). The transmitter shall then be rotated through 360° in the horizontal plane, until the maximum signal level is detected by the measuring receiver.
- 7). The test antenna shall be raised and lowered again through the specified range of height until the measuring receiver detects a maximum signal level.
- 8). The maximum signal level detected by the measuring receiver shall be noted.
- 9). The measurement shall be repeated with the test antenna set to horizontal polarization.
- 10). Replace the antenna with a proper Antenna (substitution antenna).
- 11). The substitution antenna shall be oriented for vertical polarization and, if necessary, the length of the substitution antenna shall be adjusted to correspond to the frequency of transmitting.
- 12). The substitution antenna shall be connected to a calibrated signal generator.
- 13). If necessary, the input attenuator setting of the measuring receiver shall be adjusted in order to increase the sensitivity of the measuring receiver.
- 14). The test antenna shall be raised and lowered through the specified range of the height to ensure that the maximum signal is received.
- 15). The input signal to substitution antenna shall be adjusted to the level that produces a level detected by the measuring receiver, that is equal to the level noted while the transmitter radiated power was measured, corrected for the change of input attenuation setting of the measuring receiver.
- 16). The input level to the substitution antenna shall be recorded as power level in dBm, corrected for any change of input attenuator setting of the measuring receiver.
- 17). The measurement shall be repeated with the test antenna and the substitution antenna oriented for horizontal polarization

4.4. Modulation Characteristics

PROVISIONS APPLICABLE

- a). According to CFR 47 section 2.1047(a), for Voice Modulation Communication Equipment, the frequency response of the audio modulation circuit over a range of 100 to 5000Hz shall be measured.
- b). According to CFR 47 section 74.861(e)-3, any form of modulation may be used. A maximum deviation of ± 75 KHz is permitted when frequency modulation is employed.


MEASUREMENT METHOD

Modulation Limit

- 1). Configure the EUT as shown in figure 1, adjust the audio input for 60% of rated system deviation at 1KHz using this level as a reference (0dB) and vary the input level from -20 to +20dB. Record the frequency deviation obtained as a function of the input level.
- 2). Repeat step 1 with input frequency changing to 300, 1000, 3000 and 14000Hz in sequence.

Audio Frequency Response


- 1). Configure the EUT as shown in figure 1.
- 2). Adjust the audio input for 20% of rated system deviation at 1 KHz using this level as a reference (0dB).
- 3). Vary the Audio frequency from 100 Hz to 30 KHz and record the frequency deviation.
- 4) Audio Frequency Response = $20\log_{10}$ (Deviation of test frequency / Deviation of 1 KHz reference).





4.5. Frequency Stability Measurement


PROVISIONS APPLICABLE

- According to FCC Part 2 Section 2.1055 (a)(1), the frequency stability shall be measured with variation of ambient temperature from -30°C to +50°C centigrade.
- According to FCC Part 2 Section 2.1055 (a)(2), for battery powered equipment, the frequency stability shall be measured with reducing primary supply voltage to the battery operating end point, which is specified by the manufacture.
- According to FCC Part 74 Section 74.861(e)-4, the frequency tolerance must be maintained within 0.005%.

MEASUREMENT PROCEDURE

- Setup the configuration per figure 1 for frequencies measurement inside an environment chamber, Install new battery in the EUT.
- Turn on EUT and set SA center frequency to the EUT radiated frequency. Set SA Resolution Bandwidth to 1KHz and Video Resolution Bandwidth to 1KHz and Frequency Span to 50KHz. Record this frequency as reference frequency.
- Set the temperature of chamber to 50°C. Allow sufficient time (approximately 30 min) for the temperature of the chamber to stabilize. While maintaining a constant temperature inside the chamber, turn the EUT on and measure the EUT operating frequency.
- Repeat step 2 with a 10°C decreased per stage until the lowest temperature -30°C is measured, record all measured frequencies on each temperature step.





