To Whom It May Concern:

NeuroPace, Inc. ("NeuroPace") requests that the information contained in the items enumerated below and pertaining to the above-referenced grant issued on 10/3/2012 be corrected to be withheld from public disclosure in accordance with FCC 47 CFR Section 0.457(d) and 0.459 effective immediately.

On 8/27/2012, NeuroPace responded to FCC's email request for technical information, dated 5/4/2012, with technical responses such that the FCC engineer could fully and easily understand the operation of the device in question. Note that the exhibits labeled 'Response to FCC questions Cover letter' and 'Response email Cover letter' contain the same technical information.

Both exhibits contain technical information of the nature found in the block diagram and operational description are included within the email responses listed as exhibits 'Response to FCC questions – Cover letter' and 'Response email – Cover letter'. Specifically, the answer to question #6 contains information such that the FCC engineer could understand the radiated emissions profile of a specific frequency range. To fully understand the emissions in that frequency range, detailed technical information including internal clocking frequencies about two devices, FCC ID WBWRF300 and the related device FCC ID WBW902, was shared with FCC and was assumed to remain confidential.

FCC previously granted permission to keep the block diagram and operational description long term confidential on the same device (FCC ID WBWRF300) as noted by FCC in a letter dated 10/3/2012. Similar technical email responses to FCC written for a related device (Wand W-02, FCC ID WBW902) were kept confidential. NeuroPace requests the same permission for the RNS-300M.

If the exhibits listed above are not able to be corrected to long term confidential for any reason, NeuroPace requests that the exhibits in the table above are replaced by exhibits that contain the same text but that are split into two sections: a public one which contains all questions made by FCC along with NeuroPace answers to
