

1.6 Maximum Permissible Exposure (MPE) Evaluation

In this application we seek modular approval to the MV-370, MV-372 GSM/GPRS class10 VOIP gateway station. Based on the FCC OET Bulletin 65 Supplement C and 47 CFR §2.1091, we have concluded that the MV-370, MV-372 module will comply with the FCC rules on RF exposure for mobile devices in cellular band and PCS band. The following analysis will demonstrate such compliance. The analysis will be done in two US bands.

Operation in cellular band (824.2MHz – 848.8 MHz)

The ERP of MV-370, MV-372 in cellular band is 27.12dBm max. ERP at GSM/GPRS mode. The resulted power density at a distance of 20 cm can be deducted as follows:

$$\text{EIRP} = 27.12 + 2.14 = 29.26 \text{ dBm} = 843.33 \text{ mW}$$

$$\text{Power Density} = \text{EIRP} * \text{Duty Cycle} / (4 \pi R^2)$$
$$= 843.33 * 0.25 / (4 * \pi * 20^2) = 0.042 \text{ mW/cm}^2$$

where Duty Cycle is 0.125 for GSM operation (class 10) and R is 20 cm.

The MPE limit for General Population/Uncontrolled Exposure is shown in the FCC OET Bulletin 65 Supplement C and can be calculated as follows:

$$\text{MPE limit} = 824 / 1500 = 0.55 \text{ mW/cm}^2$$

As we can see the resulted power density is below the MPE limit, therefore MV-370, MV-372 in cellular band is compliant with the FCC rules on RF exposure.

The EIRP of MV-370, MV-372 module in PCS band is 19.28dBm max. EIRP. The resulted power density at a distance of 20 cm can be deducted as follows:

$$\text{EIRP} = 19.28 \text{ dBm} = 84.72 \text{ mW}$$

$$\text{Power Density} = \text{EIRP} * \text{Duty Cycle} / (4 \pi R^2)$$

$$= 84.72 * 0.25 / (4 * \pi * 20^2) = 0.004 \text{ mW/cm}^2$$

where Duty Cycle is 0.25 for GPRS operation (class 10) and R is 20 cm.

The MPE limit for General Population/Uncontrolled Exposure is shown in the FCC OET Bulletin 65 Supplement C and can be calculated as follows:

$$\text{MPE limit} = 1.0 \text{ mW/cm}^2$$

As we can see the resulted power density is below the MPE limit, therefore MV-370, MV-372 in PCS band is compliant with the FCC rules on RF exposure.
