In response to your comments regarding the application for certification of the device referenced above please find our response below:

1.) The IC test site registration for Professional Testing (EMI) Inc. at Round Rock, TX (test site # 3036A-2) has expired. Please provide an amended IC application form listing the new test site and test site address on the IC application form and in the test report. You can provide more information in the test report on the address situation for your company headquarters than you can provide on the IC application form.

The test site is now listed under 3036B-1. The test report has been updated to reflect this as well as a statement with an explanation of the location of our test sites.

2.) John Stokes is still listed as the contact person for Fountain People, Inc. (Fountain) on the FCC Grantee Code Database (See exhibit entitled "GranteeSearchResult.pdf"). The FCC database has not been changed as you stated. Please take care of this matter. I suggest you contact Ms. Marianne Bosley by email at Marianne@atcb.com.

Documentation has been updated to provide a contact that is consistent with the FCC database. The FCC database was updated to show Jerry Elbel as the contact.

3.) The IC confidentiality request letter does not agree with the FCC confidentiality request letter. The IC letter only lists two exhibits as being confidential (the block diagram and schematics) but the FCC letter lists three exhibits as being confidential (the block diagram, the schematics and the operational description). Either submit a new IC confidentiality letter that lists the same three exhibits listed on the FCC letter for confidentiality or submit a new FCC confidentiality letter that lists the same two exhibits listed on the IC confidentiality letter.

Our client would rather not revise any more documentation. There is no proprietary data in the operational description so leaving the confidentiality request off for Canada is acceptable.

4.) The submitted IC representative letter is not acceptable. The company name, address and individual in this letter do not agree with this information on the IC application form. The submitted IC rep letter lists Ben Hewson of Celltech Labs as the rep but the IC application lists Michelle Clark of Play N Park Design Company as the rep. Please either submit a new IC representative letter that agrees with the information shown on the IC application form or submit a new IC application form that lists the company name, address and individual shown in the IC representative letter.

The application form RSP-100 has been updated to match the new representative..

5.) The model number shown on the revised FCC & IC equipment label still has the model number misspelled. Please submit a new equipment label with the model number “Wireless Activator” shown on it.

The misspelling on the label has been corrected.
