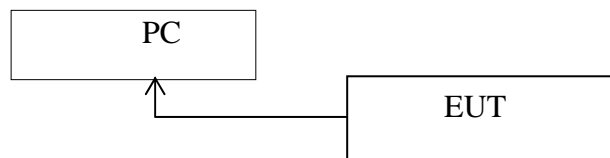

6.1. Test Equipment

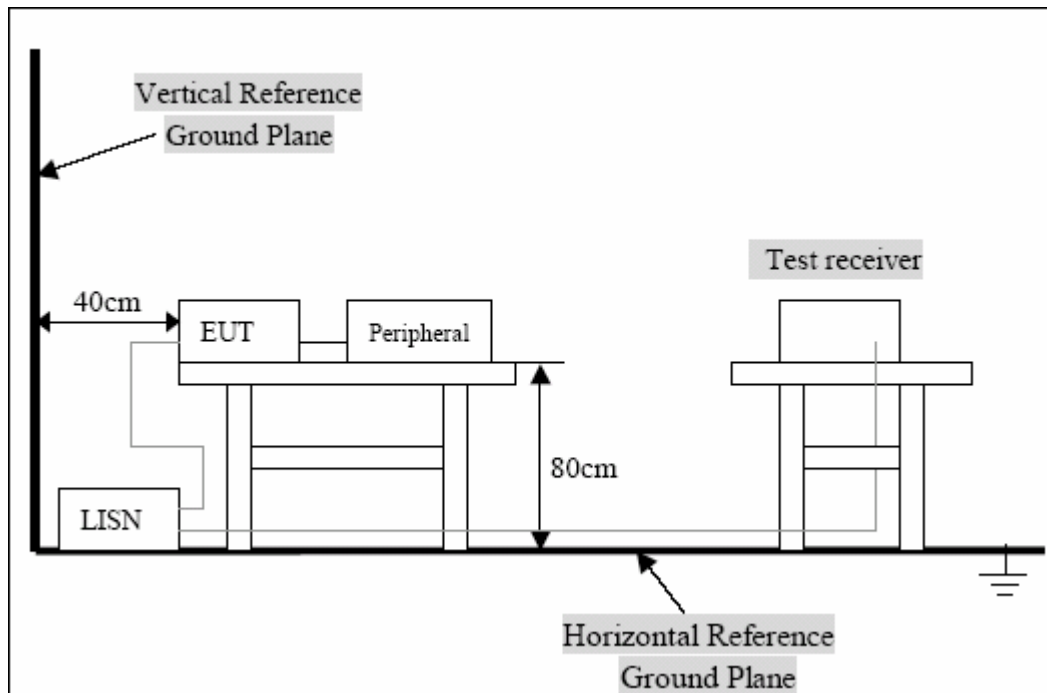

6.2. Test Procedure

The EUT and simulators are connected to the main power through a line impedance stabilization network (L.I.S.N.). This provides a 50ohm/50uh coupling impedance for the measuring equipment. The peripheral devices are also connected to the main power through a LISN that provides a 50ohm/50uh coupling impedance with 50ohm termination.

Both sides of A.C. Line are checked for maximum conducted interference. In order to find the maximum emission, the relative positions of equipment and all of the interface cables must be changed according to ASIN C63.4:2003 on conducted measurement. Conducted emissions were measured over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9KHz.

6.4. Configuring of the EUT

The EUT was configured according to ASIN C63.4:4-2003. Enable the signal transmitted from the external antenna from EUT to receiver. All interface ports were connected to the appropriate peripherals. All peripherals and cables are listed below.

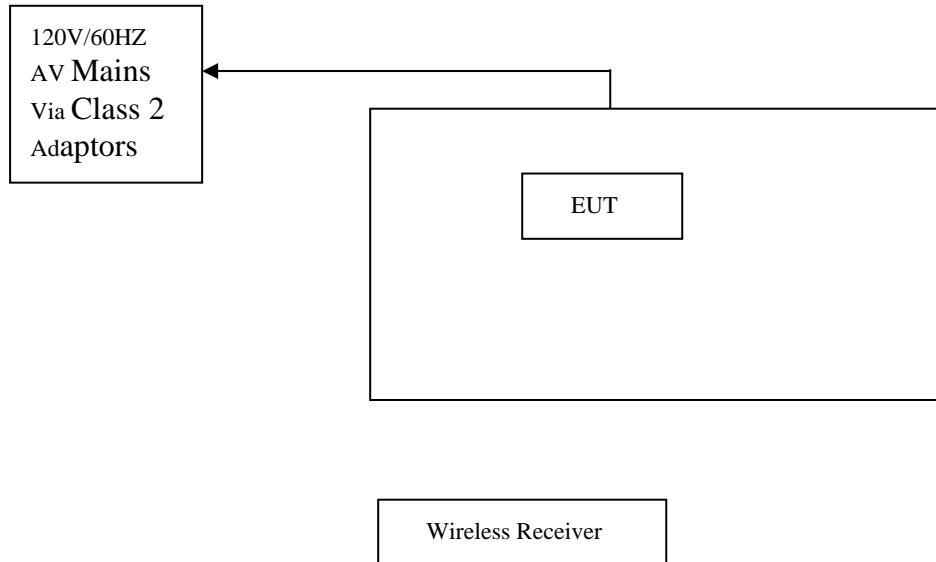
Note:

Below 1GHZ, the channel low, middle, high were pre-tested, The channel low, worst case one, was chosen for conducted and radiated emission test.

Above 1GHZ, the channel low, middle, high were tested individually.

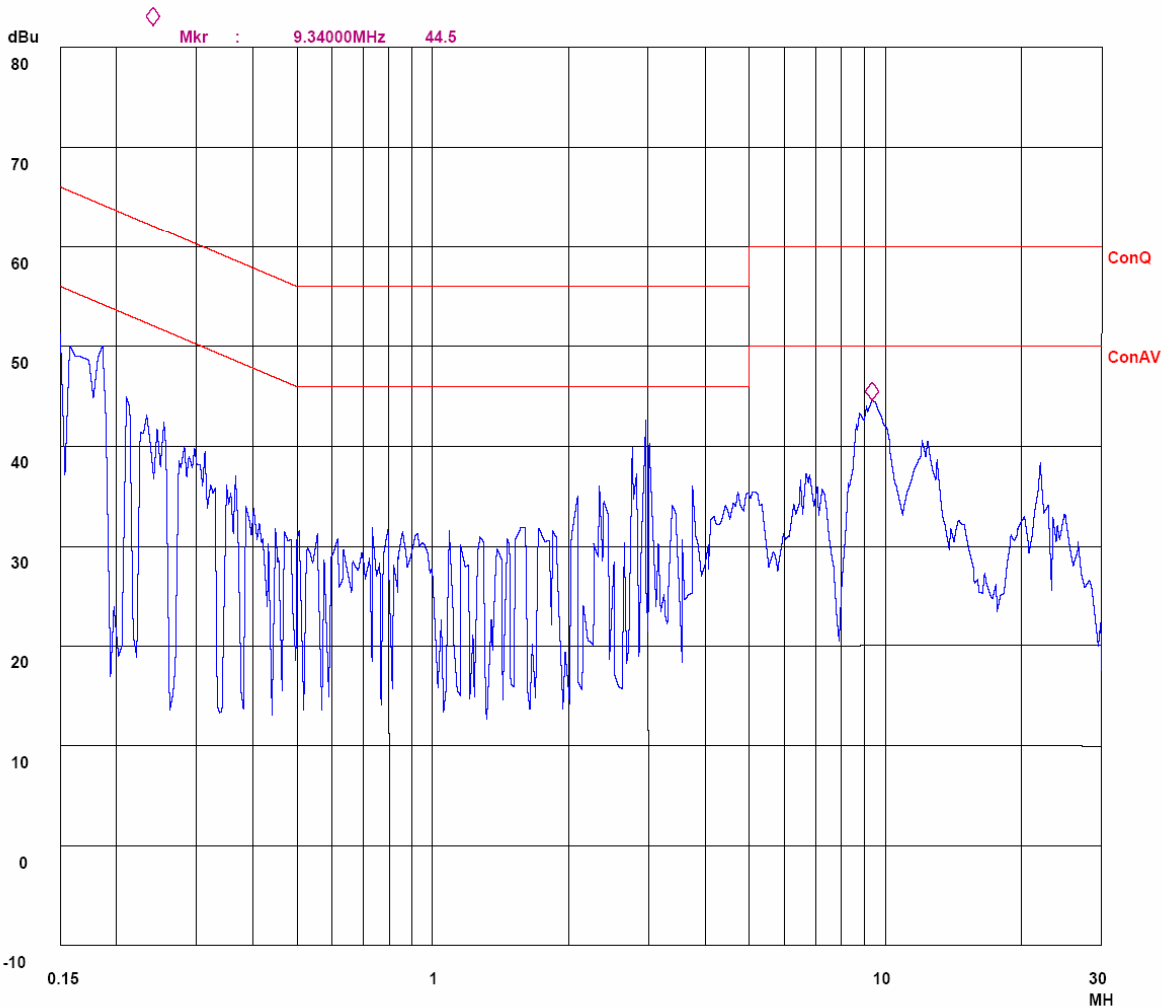

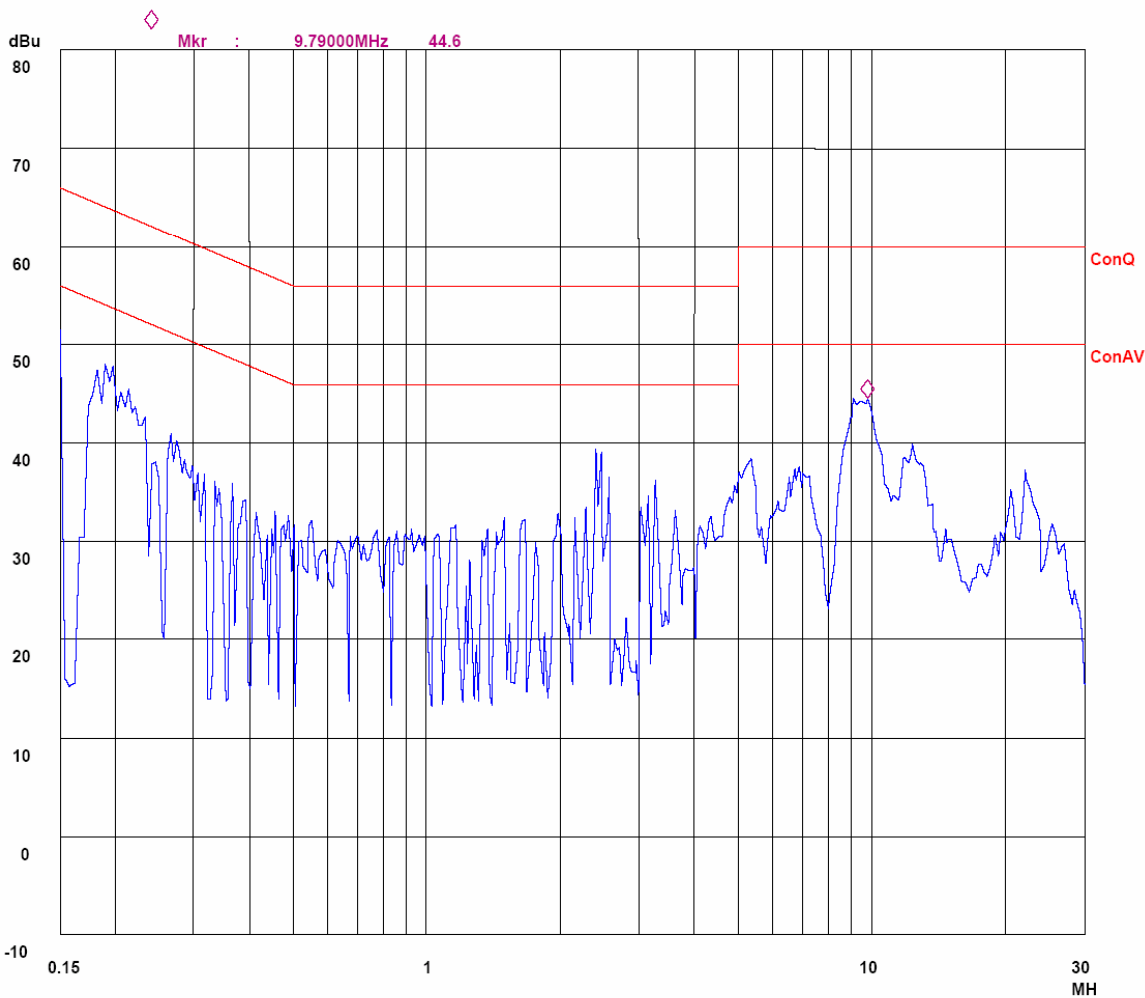

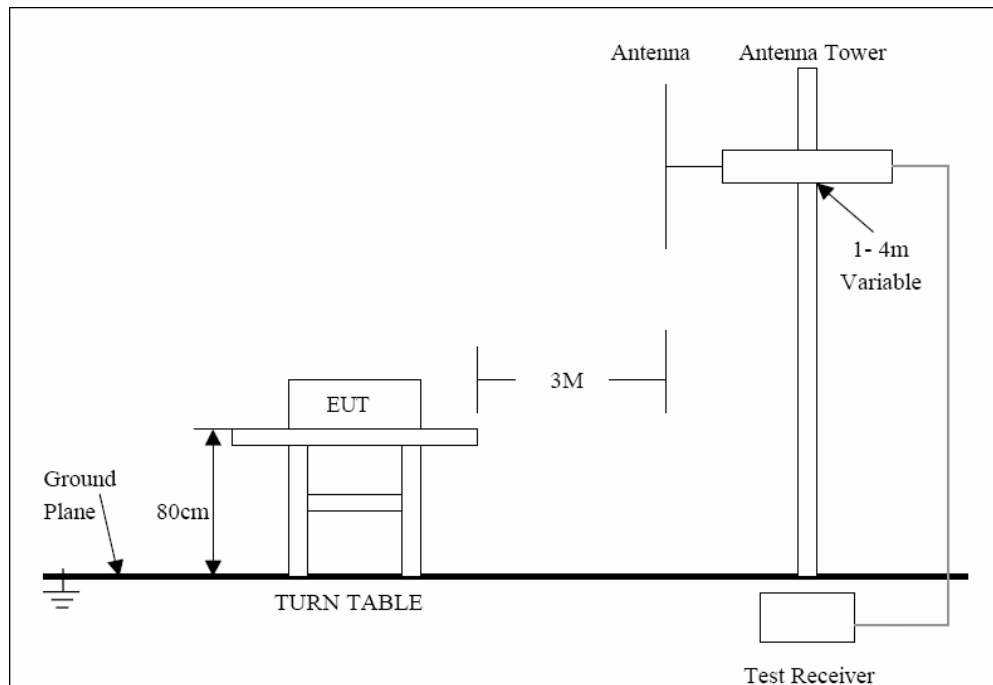
7.1. Test Equipment

7.2. Test Procedure

1. The EUT was tested according C63.4-2003. The radiated test was performed at FCC Registration laboratory .
2. The EUT, peripherals were put on the turntable which table size of 1m×1.5m, table high 0.8m. All set up is according to ANSI C63.4-2003.
3. The frequency spectrum from 30MHz to 1 GHz was investigated. All readings from 30MHz to 1 GHz are quasi-peak values with a resolution bandwidth of 120 KHz. All readings are above 1GHz , peak values with a resolution bandwidth of 1 MHz. Measurements were made at 3 meters.
4. The antenna high is varied from 1m to 4m high to find the maximum emission for each frequency.
5. Maximizing procedure was performed on the six(6) highest emissions to ensure EUT compliance is with all installation combinations. All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 Db of specification limit), and are distinguished with a "QP" in the data table.
6. The antenna polarization: Vertical polarization and Horizontal polarization.

8.2. Test Procedure

1. The EUT was tested according C63.4-2003.The radiated test was performed at FCC Registration laboratory .
2. The transmitter output was connected to the spectrum analyzer via a low lose cable.

Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

8.5. Band Edge FCC 15.249(d) Limit

In any 100kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 50dB below that in the 100kHz bandwidth within the band that contains the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).
