2. EVALUATION METHOD

According to 447498 D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances \leq 50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR.}$

Where $f(\text{GHz})$ is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation

3. CALCULATION

BR/EDR:

$$P_t = -0.325 \text{ dBm} = 0.93 \text{ mW}$$

The value of the Maximum output power P_t is referred to the test report of the CFR47 §15.247.

The result for RF exposure evaluation SAR=(0.93mW / 5mm). $[\sqrt{2.441\text{GHz}}]=0.29<3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR.

BLE 1M:

$$P_t = 0.268 \text{ dBm} = 1.06 \text{ mW}$$

The value of the Maximum output power P_t is referred to the test report of the CFR47 §15.247.

The result for RF exposure evaluation SAR=(1.06mW / 5mm). $[\sqrt{2.402\text{GHz}}]=0.33<3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR.

BLE 2M:

$$P_t = 0.157 \text{ dBm} = 1.04 \text{ mW}$$

The value of the Maximum output power P_t is referred to the test report of the CFR47 §15.247.

The result for RF exposure evaluation SAR=(1.04mW / 5mm). $[\sqrt{2.402\text{GHz}}]=0.32<3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR.

4. CONCLUSION

The SAR evaluation is not required.
