

## **Summary**

This test report supports an application for class II permissive change of a transmitter operating pursuant to 47 CFR 15.231(e). The product is the Sushi 433. The operating frequency is 433.9MHz. It is powered by +3VDC coin cell batteries. Fresh batteries were used during all testing. Line Conducted Emissions was not performed.

Class II permissive change is requested due to the enclosure's change. Please see attached class II permissive change request letter for more details.

We found that the product met the above requirements without modification. The test sample was received in good condition.

## **Test Methodology**

Testing was performed according to ANSI C63.4-2009 and ANSI C63.10-2009. Radiated emissions were maximized by rotating the device around its three orthogonal axes, as well as varying the test antenna's height and polarity. The EUT's antenna cannot be maximized separately. Only fundamental and spurious emissions were checked.

Frequency range investigated: 30MHz – 1000MHz

Measurement distance: 3m

This device has no receiver portion.

(B) NOTWITHSTANDING ANY PROVISION TO THE CONTRARY CONTAINED HEREIN, AND INrecognition of the relative risks and benefits to Client and the company associated with the testing services contemplated hereby, the risks have been allocated such that under no circumstances whatsoever shall the liability of the company to Client or any third party in respect of any claim for loss, damage or expense, of whatsoever nature or magnitude, and howsoever arising, exceed an amount equal to five (5) times the amount of the fees paid to the company for the specific services which gave rise to such claim or U.S.\$10,000, whichever is the lesser amount.

16. The Company shall not be liable for any loss or damage resulting from any delay or failure in performance of its obligations hereunder resulting directly or indirectly from any event of force majeure or any event outside the control of the Company. If any such event occurs, the Company may immediately cancel or suspend its performance hereunder without incurring any liability whatsoever to Client.

17. Company's services, including these Conditions, shall be governed by, and construed in accordance with, the local laws of the country where the Company performs the tests or, in the case of tests performed in the United States of America, the laws of Massachusetts without regard to conflicts of laws principles. If any aspect(s) of these Conditions is found to be illegal or unenforceable, the validity, legality and enforceability of all remaining aspects of these Conditions shall not in any way be affected or impaired thereby. Any proceeding related to the subject matter hereof shall be brought, if at all, in the courts of the country where the Company performs the tests or, in the case of tests performed in the United States of America, in the courts of Massachusetts. Client waives the right to interpose any counterclaim or setoffs of any nature in any litigation arising hereunder.
