



### Precautions

### Compatibility

This device can be paired as a hands-free kit with any compatible Bluetooth enabled devices. Each time can only connected with one Bluetooth device.

### Instructions

#### Transmitter (TX) Mode:

1. Press and hold Power Button for 3 seconds to power on. The device powers on in TX (Transmitter) mode by default. Transmit mode is used to send audio from a wired headphone jack, such as an airplane TV or treadmill at the gym, to your wireless earbuds or headphones.
2. The device will automatically search for and connect to available Bluetooth speakers, headphones, or other Bluetooth-enabled devices. Ensure your Bluetooth device is in pairing mode and is not connected to another device.
3. The blue indicator light will stop flashing once the transmitter is connected. Connect the aux cable to the transmitter and connect the other end to the aux port of the entertainment system. A double aux adapter is included for airplanes.

#### Receiver (RX) Mode:

##### Music Streaming Function:

1. To switch to receiver mode, press the mode button once and the indicator light will turn flashing green. In RX (receiver) mode, connect a non-wireless device (speaker, DVD player, or wired earphones) to a Bluetooth device using a 3.5mm audio cable.
2. Pair the device with your mobile phone, tablet, or gaming console via Bluetooth. Select "Monster BT1009" on your bluetooth device to connect and complete pairing.
3. Play your music, and enjoy high-quality sound through your connected speaker, stereo, or earphones.
4. Press the "Play/Pause Answer/Hang up" button once to Play/Pause music.

##### Hands-Free Function:

1. Press the "Play/Pause Answer/Hang up" button once to answer or hang up an incoming phone call.
2. Press and hold the "Play/Pause Answer/Hang up" button for 3 seconds to reject a phone call.

1. Press the "Play/Pause Answer/Hang up" button twice to dial the last phone call.
2. During a conversation, press and hold the "Play/Pause Answer/Hang up" button for 3 seconds to switch to private calling mode.

#### Voice assistant

1. Short press the "mode button" to switch mode(RX or TX).
2. Press and hold the "mode button" for 3 seconds to active SIRI assistant.

#### Note:

The device powers on in TX mode (blue indicator) by default. To switch between modes, press the "Mode" button.

#### Charging the Wireless Audio Adapter

1. When the battery power is low, the indicator light flashes red;
2. You can charge this Bluetooth receiver with the USB-C charging cable in the package;
3. In the charging status, the indicator is on solid red, and it goes off when the device is fully charged.
