

## 7 Antenna Requirement

### 7.1 E.U.T. test conditions

**Test Power:** DC 3V

**Requirements:** 15.31(e) For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.

Pursuant to Part 15.31(c) For swept frequency equipment, measurements shall be made with the frequency sweep stopped at those frequencies chosen for the measurements to be reported.

Test frequency is the lowest channel: 0 channel (2402MHz), middle channel: 39 channel (2440MHz) and highest channel: 78 channel (2480MHz) with fixed at channel.

## 7.2 Antenna Requirement

### Standard requirement:

15.203 requirement:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

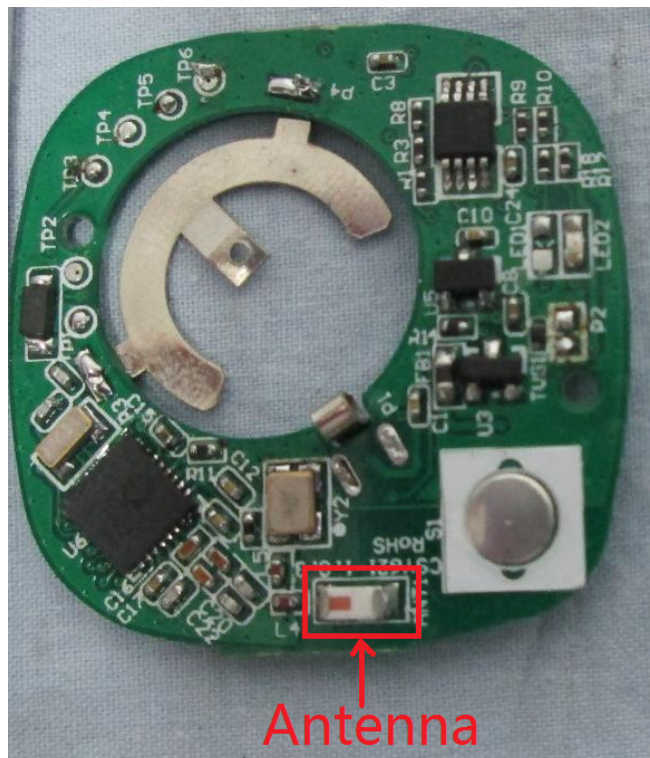
15.247(b) (4) requirement:

The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

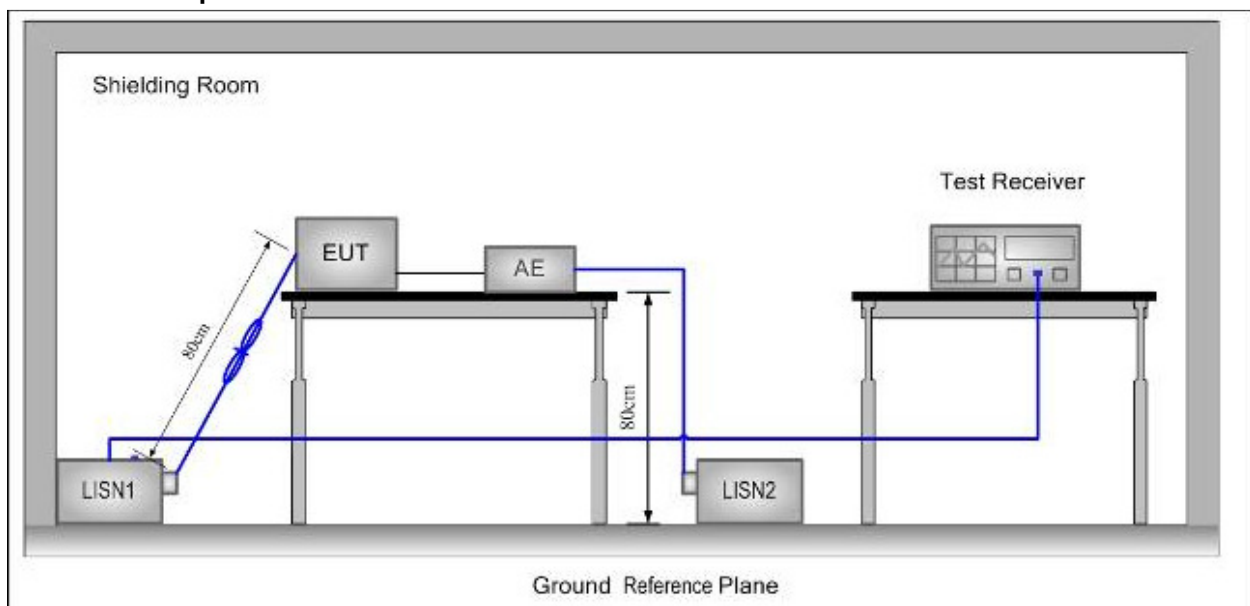

#### Test Procedure:

1. The mains terminal disturbance voltage was measured with the EUT in a shielded room.
2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides 50Ω/50μH + 5Ω linear impedance. The power cables of all other units of the EUT were connected to a second LISN, which was bonded to the ground reference plane in the same way as the LISN for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded
3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN was placed 0.8 m from the boundary of the unit

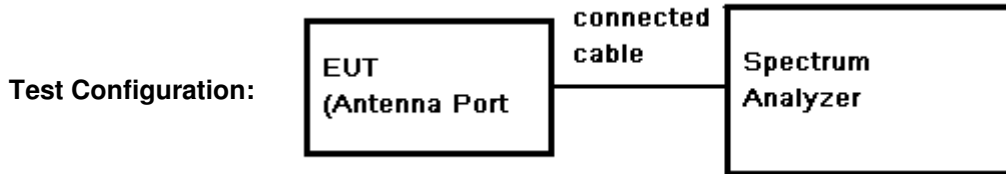
under test and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance was between the closest points of the LISN and the EUT. The mains lead of EUT excess 0.8m was folded back and forth parallel to the lead so as to form a horizontal bundle with a length between 0.3m and 0.4m. All other units of the EUT and associated equipment were at least 0.8 m from the LISN.

Remark: Pre-scan was performed with peak detected on all ports, Quasi-peak & average measurements were performed at the frequencies at which maximum peak emission level were detected. Pretest under all modes; choose the worst case mode (in Middle channel) record on the report. Please see the attached Quasi-peak and Average test results.

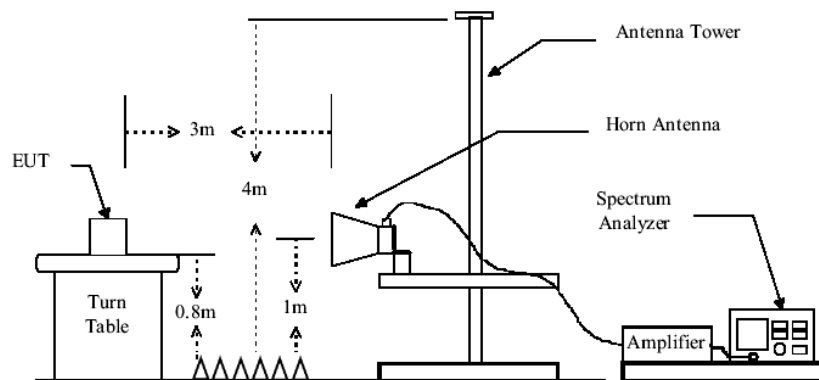

**Test Procedure:**

The procedure used was ANSI Standard C63.10:2009. The receiver was scanned from 9KHz to 25GHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. For intentional radiators, measurements of the variation of the input power or the radiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. The worst case emissions were reported.

Low noise amplifier was used below 1GHz, High pass Filter was used above 3GHz. Between 1G and 3GHz; we did not use any amplifier or filter.

Test were performed for their spatial orthogonal(X, Y, Z), the worst test data (X orthogonal) was submitted.

- 1) For this intentional radiator operates below 25 GHz. the spectrum shall be investigated to the tenth harmonic of the highest fundamental frequency. And above the third harmonic of this intentional radiator, the disturbance is very low. So the test result only displays to 5rd harmonic.
- 2) As shown in Section, for frequencies above 1000 MHz, the above field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation.

The test only perform the EUT in transmitting status since the test frequencies were over 1GHz only required transmitting status.
