


Photo 8: Back side with 15mm




Photo 9: Front side 10mm






Photo 10: Back side 10mm




Photo 11: Left side 10mm







Photo 14: Bottom side 10mm




Photo 15: Front side 0mm






Photo 21: PD Back Side 2mm




