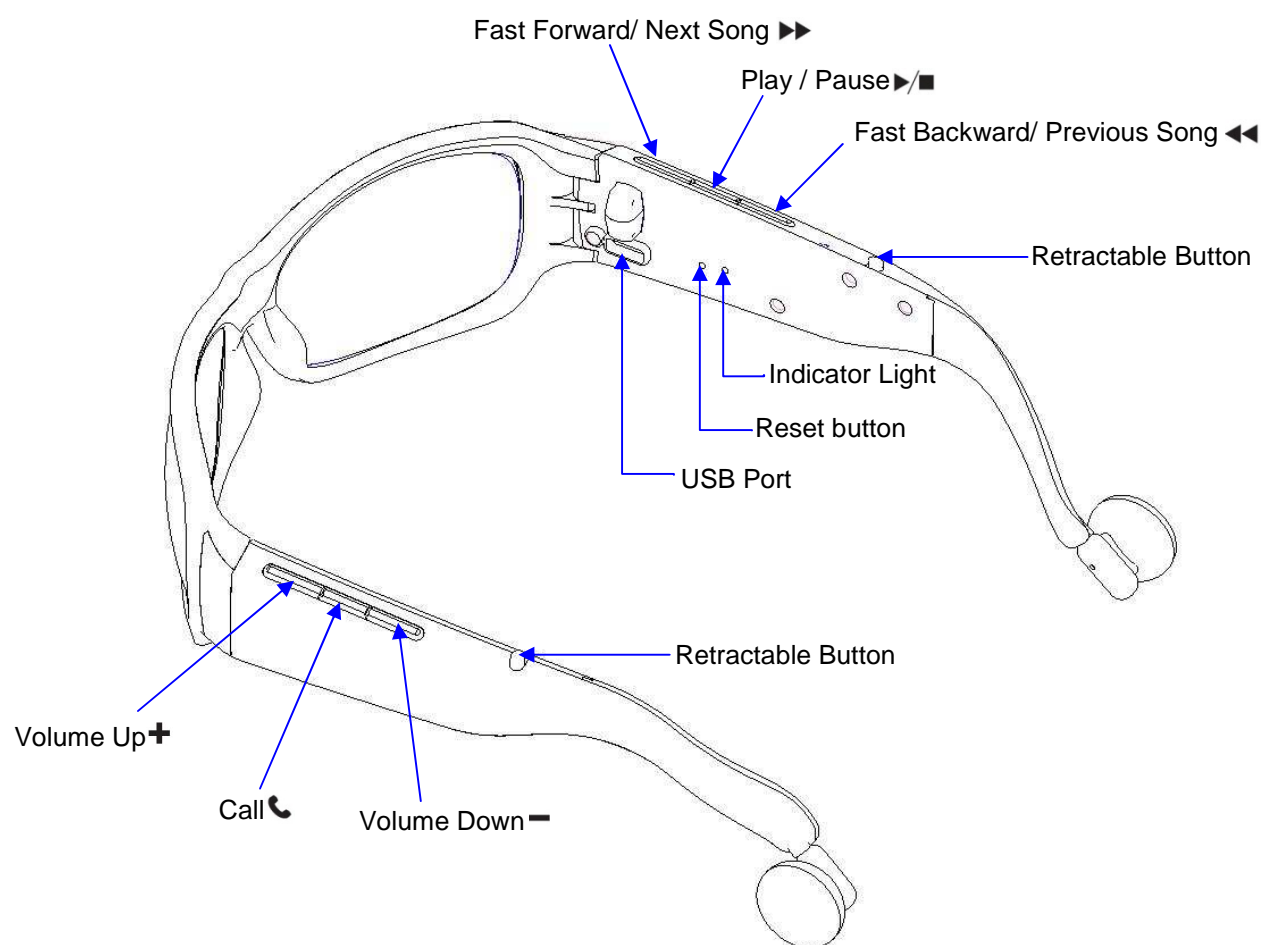

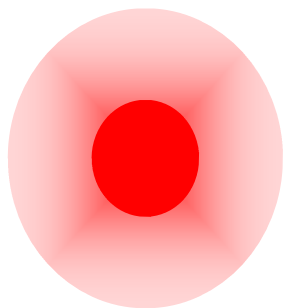
INTRODUCTION

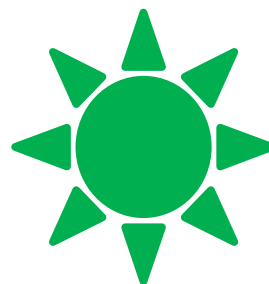

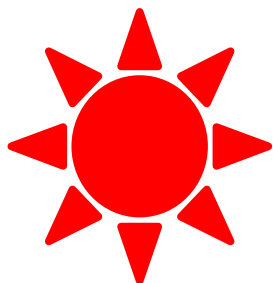

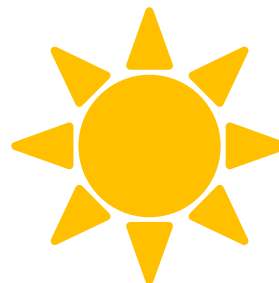

GETTING STARTED

Charging the Battery

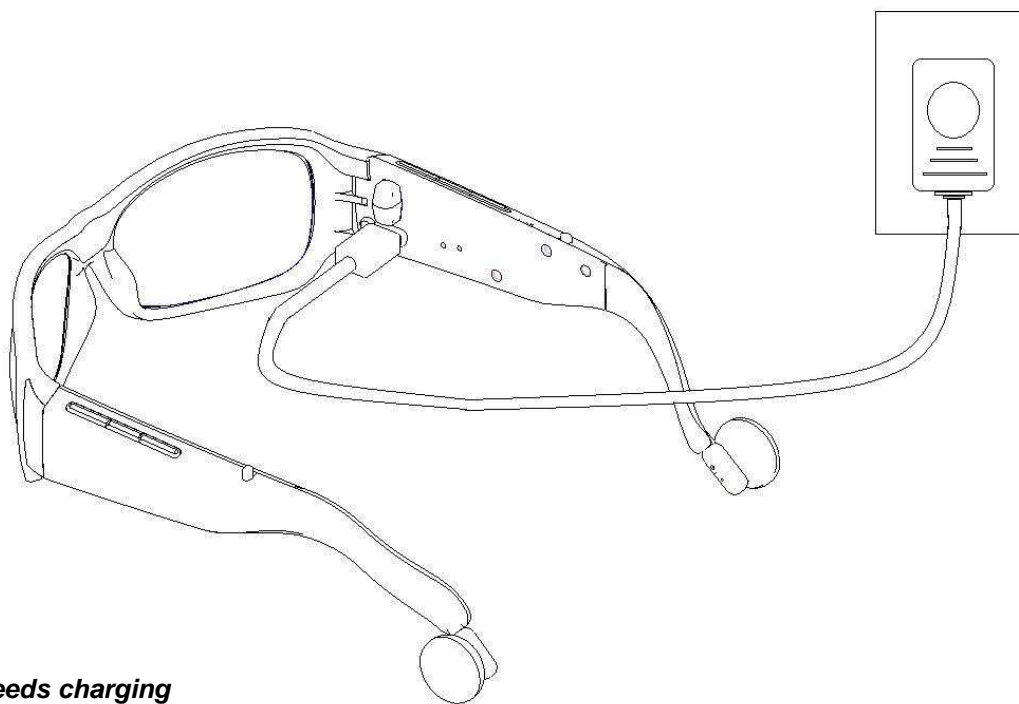
Eyewear provides over 70 hours of standby time, up to 7 hours of talk time or 5 hours of music playback time when fully charged.

To charge Eyewear:

1. Plug the micro USB connector cable to your computer USB port. To charge Eyewear via the wall charger, connect the micro USB connector cable to the bundled adaptor before plugging it into an electrical outlet.
2. Plug the other end of the charging cable into Eyewear.
3. The light indicator will indicate that Eyewear is in charging mode. When charging is complete, the indicator light will turn off.

Note:

If the battery is completely discharged, it may take a few minutes before the charging indicator becomes active.



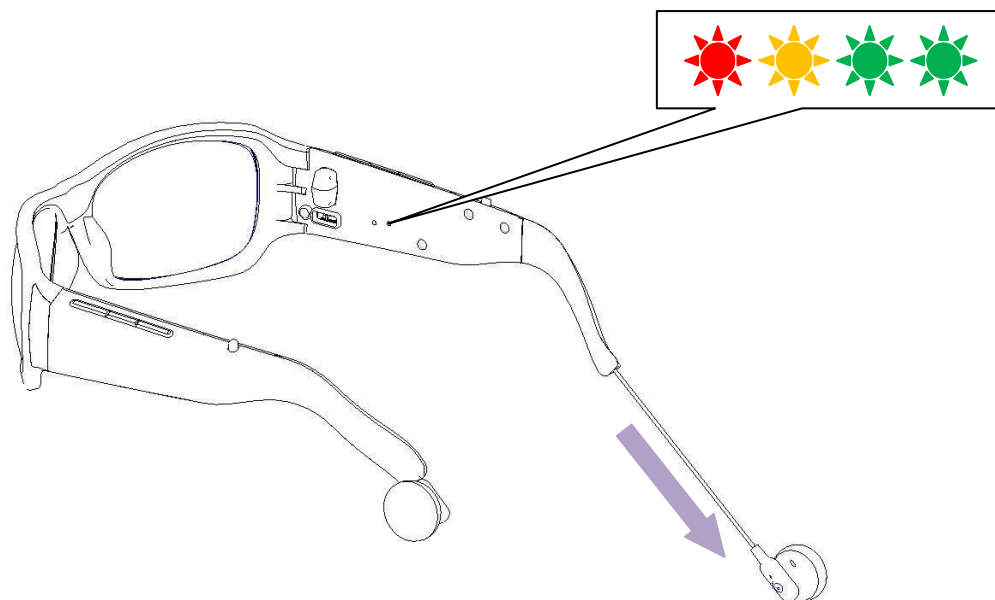
Battery needs charging



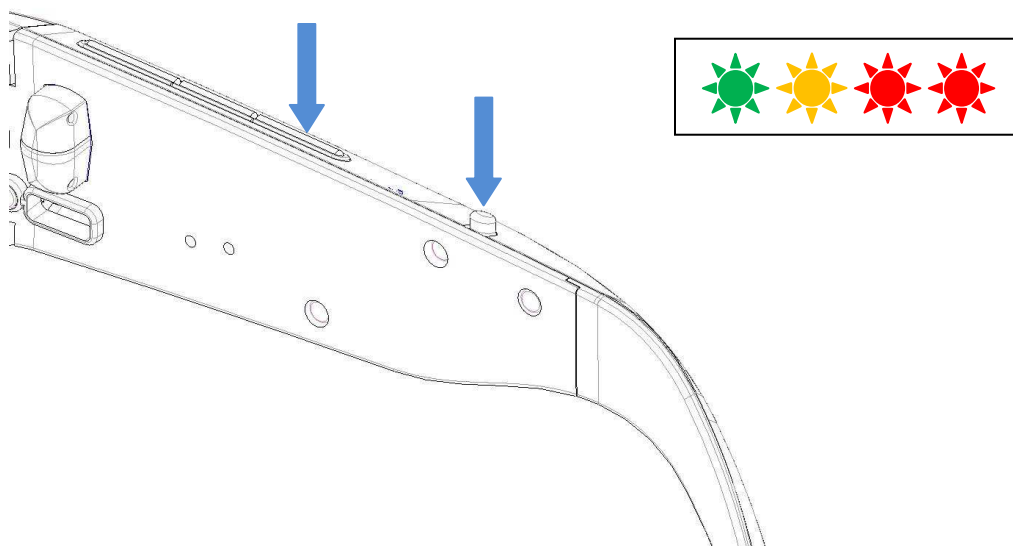
Charging in progress

Turning On and Off Eyewear

To turn Eyewear on, pull down the right earpiece. A voice prompt “Hello” will be heard and the indicator light should flash from red > amber > green > green.

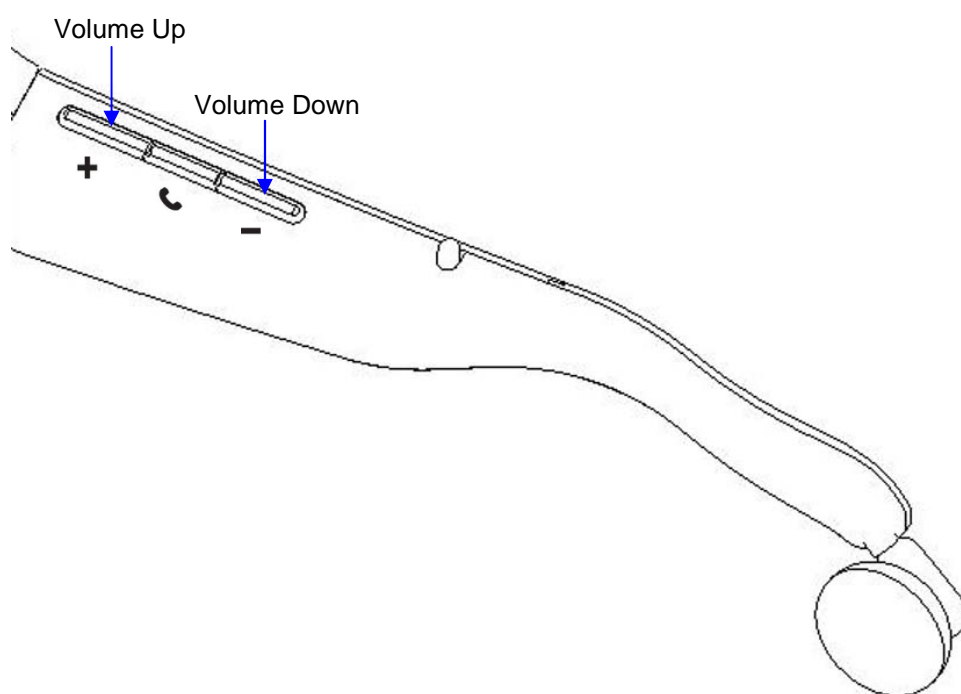


To turn Eyewear off, press and hold the Fast Backward/Previous ◀ button and then press the right Retractable button. A voice prompt “Goodbye” will be heard and the indicator light should flash from green > amber > red > red.



Adjusting the Volume

You may use the Volume Up **+** and Volume Down **-** buttons on the left stem to adjust the volume.



- To increase speaker volume, press the front volume **+** button repeatedly until the desired volume is achieved.
- To decrease speaker volume, press the back volume **-** button repeatedly until the desired volume is achieved.

Note:

When adjusting the speaker volume while Eyewear is in phone mode, a single high-pitch tone will be heard when the maximum or minimum volume level is reached. This tone does not apply when adjusting music volume.


USING EYEWEAR

Pairing Eyewear with Your Phone And/Or Music Device

Before using your Eyewear to make a call or listen to your favorite music, it must first be paired with your phone or music device. Your Bluetooth-enabled phone or music device must support the following:

- Bluetooth Advanced Audio Distribution Profile (A2DP) (for wireless audio streaming)
- Bluetooth Audio/ Video Remote Control Profile (AVRCP) (for wireless control of music)

To pair Eyewear with your phone:

1. Ensure that the Bluetooth feature in your phone/music device is turned on. For more information on how to turn on the Bluetooth feature, please refer to the user guide that accompanies your phone/music device.
2. With Eyewear turned on, press and hold the Call  button until the indicator light turns red.
3. Search for Bluetooth devices using your phone/music device. For more information on how to search for Bluetooth devices, please refer to the user guide that accompanies your phone/music device.
4. Select **EYEWEAR** from the list of discovered devices from your phone/music device. Follow the onscreen prompts to confirm the selection.
5. When prompted, enter the passkey "0000" (four zeros). When pairing is successful, the indicator light flashes green four times and you will hear the voice prompt "Pairing Successful". Eyewear is now ready for use.

Note:

- Eyewear can store pairing information for up to 8 different devices. Once pairing is established, Eyewear will automatically connect to the last connected device each time it turns on and is within range. To connect to another device in its memory list of paired devices, the connection from that device to Eyewear must be initiated first.
- Two different devices (such as a phone and an MP3 player) can be wirelessly connected to the Eyewear at the same time. However, two similar devices (such as two phones) cannot.









To initiate a connection to Eyewear:

1. Go to the connection list in your phone/music device. For more information on viewing the connection list, please refer to the user guide that accompanies your phone/ music device.
2. Select **EYEWEAR** from your phone/music device.

Alternatively,

1. To connect to your phone, press the Call ☎ button. Eyewear will connect to the phone it was last connected to.
2. To connect to your music player, press the Play/Pause ▶/■ button. Eyewear will connect to the music device it was last connected to.

Call Functions

Function	
Turn Eyewear on	Pull down the right-hand side speaker
Answer a Call	Press the Call  button
Adjust Volume	Press the Volume Up  button to increase the volume
	Press the Volume Down  button to decrease the volume
Mute the microphone	Press and hold the Volume Down  button until the voice prompt “Muted” is heard. Repeat the procedure to release from mute, voice prompt “Un-mute” is heard
End a Call	Press the Call  button
Turn Eyewear off	Press and hold the Fast Backward/Previous  button and then press the right Retractable button
Change ring tones	Press Volume up  and Next song  to toggle and select between 5 different tones

Note:

When communication between Eyewear and your phone is interrupted (ie. when Eyewear is out of range), Eyewear will attempt to re-establish the connection.












After 10 minutes of unsuccessful attempts, the Eyewear will turn off.

Profiles





Eyewear supports both Handsfree and Headset profiles. However, the availability of these profiles is subject to the profiles supported by your phone.

The tables below illustrate the functionalities supported for each profile:

Transfer call from Eyewear to Phone	Press the Call  button twice
Answer 2 nd incoming call	Press and hold the Call  button
Continue current call, reject 2 nd incoming call	Press Call  button and Volume up 
End current call, answer 2 nd incoming call	Press Call button  and Volume down 

Headset Profile

Function	
Dial by Voice	Short press the Call  button and speak the name or command
Redial last dialled number	Press and hold the Call  button
Transfer call from Phone to Eyewear	Short press the Call  button while call is connected
Transfer call from Eyewear to Phone	Press the Call  button twice

Controlling Music

With Eyewear, you can enjoy wireless stereo audio from a Bluetooth-enabled phone or other music devices.

Function	
Turn Eyewear on	Pull down the right-hand side speaker
Play music	Press the Play/Pause ►/■ button
Stop music	Press and hold the Play/Pause ►/■ button
Pause/Resume music	Press the Play/Pause ►/■ button
Skip to next song	Press the Fast Forward/Next Song ►► button
Play previous song	Press the Fast Backward/Previous Song ◀◀ button
Turn Eyewear off	Press and hold the Fast Backward/Previous ◀◀ button and then press the right Retractable button
Adjust music volume	Press the Volume Up + button to increase the volume
	Press the Volume Down - button to decrease the volume

To make or receive a call, press the Call ☎ button. The music control buttons will be deactivated during the call. Once the call ends, the music will automatically resume.










Note:

Some music players do not support the feature that pause the music in the event of an incoming call. For these music players, Eyewear will mute the music when there is an incoming call.

- The languages supported are English and Russian.
- Press Previous Song ◀ and Volume Down ▮ to toggle and select the language.
- The default shall be English, and the selection sequence is English and Russian.

With continuous usage at high volume, your ear may get accustomed to the sound level, which may cause permanent damage to your hearing. Use the Eyewear at a safe volume.

AVOID DISTRACTION

It is dangerous, and in some states or country, illegal to use headsets while driving a motor vehicle, motorcycle or bicycle. Do avoid placing or receiving calls while operating automotive, equipment to reduce the risk of accidents or injury. Use caution while using your Eyewear when engaging in ANY activities that requires your full attention. It is advisable to remove the speakers from your ears or turning off the sound to prevent any distraction while engaging in such activities to avoid accident or injury.

AVOID MOISTURE

The Eyewear is not waterproof and using it in or near water or other liquids, or wet locations, may cause electric shock and serious injury. CLEANING AND MAINTAINANCE

Your new Eyewear comes with a pouch for cleaning and storage. Hand wash and air-dry the pouch regularly. When cleaning your lenses, use only mild soap and water and dry by gently blotting with the pouch provided.

Please note the following when cleaning your Eyewear:

- The Eyewear is not waterproof. Moisture may damage the electronic circuitry. Do not rinse or immerse any part of the Eyewear. Keep the Eyewear dry at all times.
- Before cleaning, make sure the Eyewear is unplugged from the wall charger or computer.
- Do not clean the lenses with soaps, detergents, ammonia, alkaline cleaners, abrasive cleaning compounds or solvents. These substances may damage the lens coatings or leak into the Eyewear and damage the electronic circuitry.
- Should a lens become scratched, it should be replaced immediately to ensure your vision is not affected.

FIRMWARE UPGRADE

The Eyewear is firmware upgradeable via the micro USB port. Check the company website, www.trispecs.com, for any latest released firmware updates and downloads.
