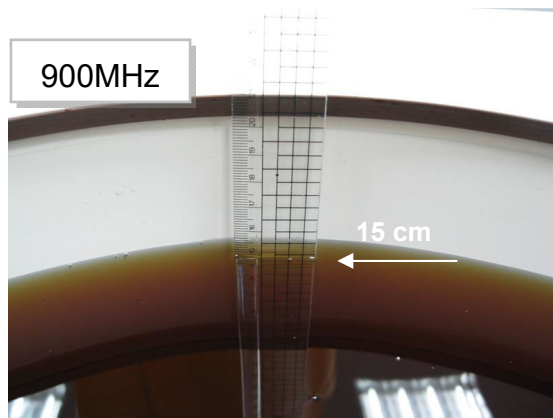
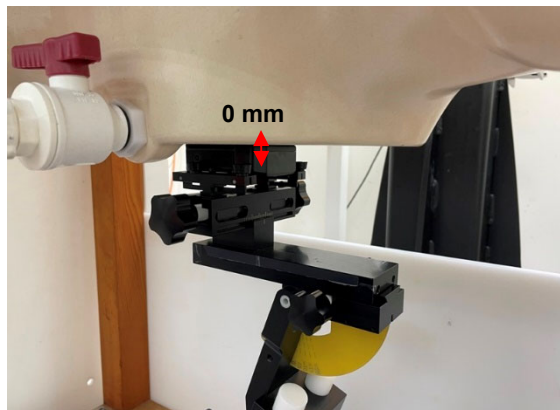

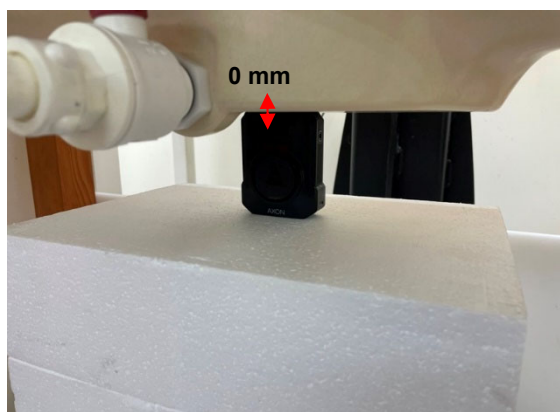

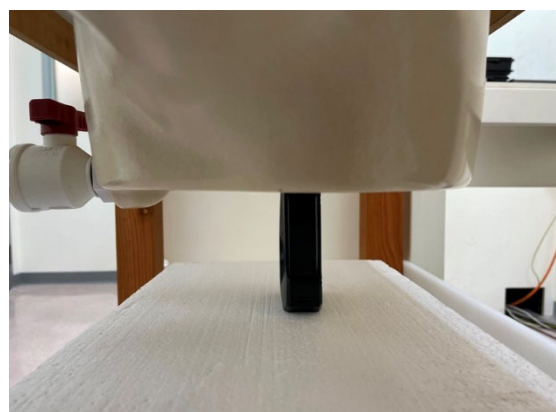
Photograph 1. Body, Back Surface, 0mm



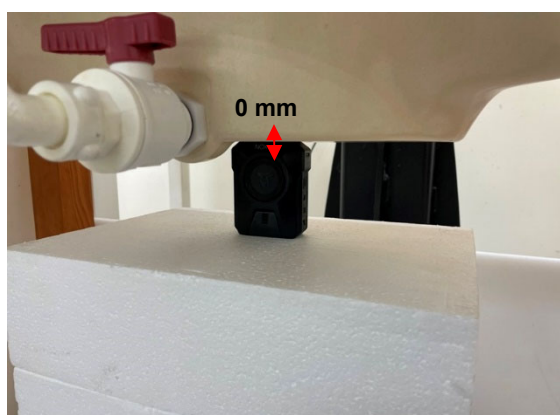
Photograph 2. Body, Back Surface, 0mm



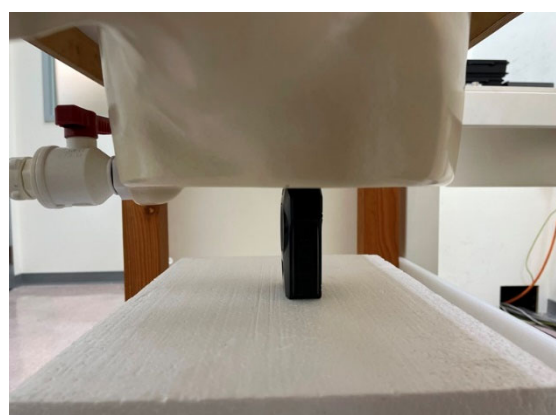
Photograph 3. Body, Top Edge, 0mm

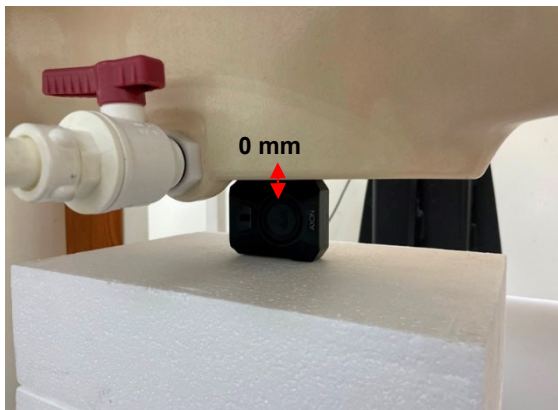


Photograph 6. Body, Bottom Edge, 0mm

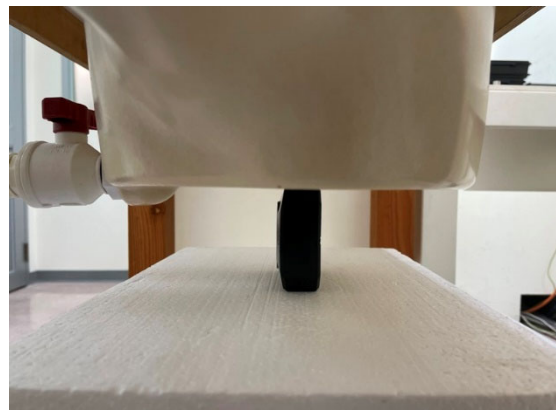

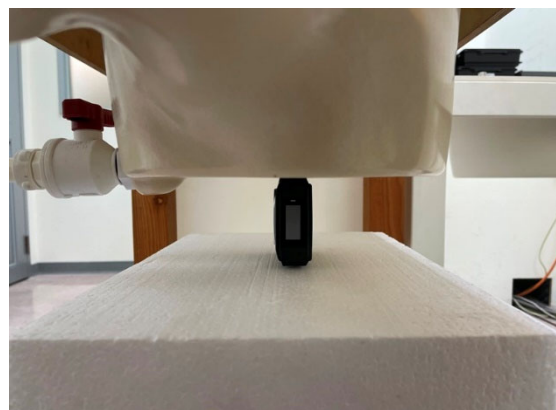

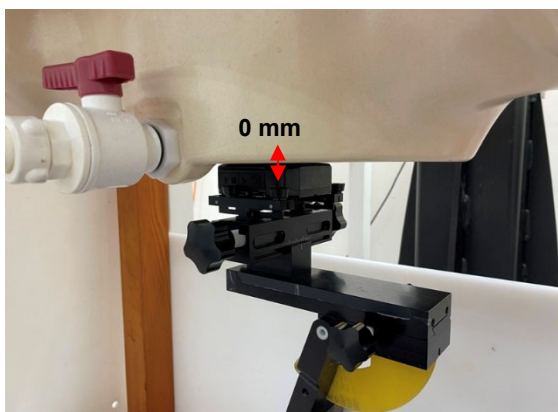
Photograph 8. Body, Right Edge, 0mm

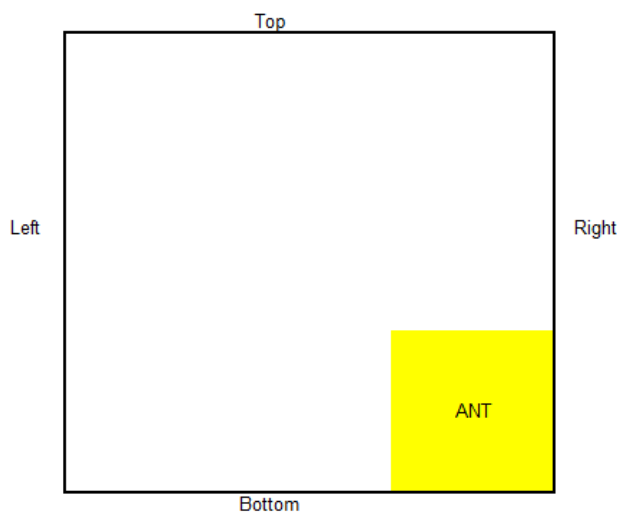
