





1. Getting Started

- Unpack Care Pal appliance from the packaging.
- Remove the protective film from your Care Pal appliance screen.

1.1 Setting Up Your Care Pal Appliance


A. Connecting a Power Source

Plug the power supply into an electrical outlet and the other end on the back of Care Pal appliance.



B. Set Up Directly Into A Telephone Jack

Plug one end of the telephone line into a telephone jack, and the other end into the Care Pal connector.




1.2 Connecting To Medical Devices (Optional)

- Plug one end of the cable into your medical device and the other end either into the serial (RJ45) connector or Universal Serial Port (USB) connector.
- Activate your Care Pal measurement function at Setting Connection (please refer to 2.1-E)









1.3 Using your Care Pal Appliance


Turn on your care Pal. Activate by pressing the **POWER** button to the **Welcome Screen**, then enter the **Login Screen**.

Select your ID and enter the **Main Menu Screen**.

1. Please make sure your medical device is connected to your Care Pal appliance before entering the measurement function.
2. For Bluetooth enabled medical devices, please make sure the Bluetooth is turned on before entering the measurement function.

B. Weight Scale



D. Glucose Meter


Press **<** or **>** to select Blood Glucose measurement record and press **O** to enter.





2.1 Get to Setting


Press  to upload the measurement.

Press  to review Before Meal or After Meal records.




Press  or  to select setting function and press  to enter.




A. Setting Date & Time

Press **<** or **>** to select e-mail and press **O** to enter.




Press **<** or **>** to select e-mail and press **O** to enter.


Press **O** to turn on the keyboard.

Repeat the above steps for the next e-mail account.




Next time when you login, you can check the new message.




C. Setting Warning Level

Press **<** or **>** to select Warning and press **O** to enter.




Press **<** or **>** to select the following:

I. Blood Oxygen




Press **<** or **>** to set the warning level and press **O** to confirm.




II. Body Weight


Press **<** or **>** to set your warning level and press **O** to confirm.



III. Blood Pressure




Press **<** or **>** to set the warning level and press **O** to confirm.




IV. Blood Glucose


Press **<** or **>** to set the warning level and press **O** to confirm.




D. Setting Alarm


Press  or  to select Alarm and press  to enter.

Press  to confirm hour and move to minute field.




Press  to increase or Press  to decrease.

Note: Alarm will not activate during measuring operation.


E. Setting Connection

Press **<** or **>** to select Connection and press **○** to enter.




I. Cable

Press **○** to select Cable.




Press **○** to select the type of the measuring device.

Repeat the above steps for other devices.








F. Setting Network

Enter the IP address by pressing **<** or **>** to select alphabet and press **O** to confirm each alphabet.




G. Setting Password

Press **<** or **>** to turn on the password function.


Press **<** and **>** to select number 0~9 to set your password.

2.2 Live Update

Care Pal appliance includes an automatic updating feature, which keeping your Care Pal appliance up-to-date easy and convenient for you. It is strongly recommended that you install the new version of software.



3. Regulatory Requirement

Intended use and indications for use

The Care Pal ("CP") appliance is for use in non-clinical settings as an accessory device to collect and transmit historical patient information to healthcare providers. It is intended to be used in combination with a variety of external devices. The CP appliance serves as the remote communication link between compatible external devices and the compatible healthcare facility at another location. The product is not intended to provide automated treatment decisions nor for use as a substitute for a health care professional's judgment. The main feature of the CP appliance is to collect and transmit selected personal health information (Such as blood pressure, weight, blood glucose) using standard digital communication technologies and protocols.

Important Safety Note

Safety Labels Used in this Manual

 "Warning" indicates a potentially hazardous situation which if not avoided, could result in serious injury.

Warning

- If you experienced a medical emergency, call the appropriate local medical emergency telephone number or go to your emergency care facility. Medical problems, questions or concerns that are not emergencies should be promptly referred to your health care professional.
- Do not place the Care Pal appliance near flammable anesthetic mixtures, which could create an explosion hazard.
- Do not place the Care Pal appliance near oxidizing agents such as nitrous oxide or pure oxygen. These materials strongly support combustion and may react violently with the Care Pal appliance.

- Use only the power supply provided with your Care Pal appliance.
- Do not use Care Pal appliance or any device connected to the Care Pal appliance during a thunderstorm. If lightning strikes the telephone line, you could receive a severe electric shock.
- Do not use the Care Pal appliance if the power, telephone, or cables become worn or frayed. Call your health care professional for a replacement of the power supply or any of the cables.
- Do not submerge the Care Pal appliance in water. You could receive a severe electric shock. If the Care Pal does get submerged in water, unplug the power supply from the electrical outlet and disconnect it from the telephone line. Call your health care professional for a replacement device.

Cautions

The Care Pal system is not intended for use as a substitute for a health care professional's judgment. All patient medical diagnosis and treatment are to be performed under the supervision and oversight of health care professional.

Clean the Care Pal appliance only with a soft cloth dampened with water. Do not use chemicals or abrasives and do not submerge the Care Pal system in water.

Keep the Care Pal appliance away from any heated surfaces or under direct sunlight. If the Care Pal appliance gets too hot, it could lead to system malfunction.

Please handle the Care Pal system with care, avoid vibration while transporting.

The Care Pal system should also be used with adaptors certified by IEC60601-1 and output of 5V, 1.5A or higher only.

Instructions for use

Read this document provided with your Care Pal appliance for proper instructions for use. If you have any questions about these instructions, please call your health care professional.

NOTICE: Part 68, FCC Rules and Regulations permit this device to be directly connected to the telephone network and U.S. standardized jacks are used for these connections. This equipment should not be used on party lines or coin lines.

If you experience trouble using the Care Pal appliance, you should disconnect it from the telephone line to determine if it is malfunctioning. If the Care Pal appliance is malfunctioning, you should discontinue use of the equipment until the problem has been corrected.

FCC Statement

This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference in a residential installation. This equipment generates, uses and can radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications. Troubleshooting

Q Why is the user icon appeared in gray color?

A No response when I press the buttons?

A Preset value has no user function to choose from. Please contact customer service for assistance.

Q What should I do if my device is having problem connecting to Care Pal?

A 1. Please check if Care Pal supports the device.

2. Please check if the connection setting is correct.

3. Please check if the network connection of the device (If you are using Bluetooth device, please make sure Bluetooth is turned on)

Q What should I do if I have problems uploading the data?

A 1. Please check network setting

- Check network cable (Ethernet) if is connected properly
- Check the wireless network platform if is working properly
- Check the phone line connection

2. If you still have problems uploading the data, please contact customer service.

Q Why are the device icon appeared in gray after I login?

A The preset value does not include device setting. Please set your connection method under the setting menu.

Q What should I do if I can not receive messages?

A Please check the network setting. If it connects to the internet but still having problems, kindly contact customer service for assistance.

Q My Bluetooth device is connected but the screen still appears in the "Receiving Data" step. What should I do?

A 1. Please restart the device.

2. Please check connection setting and make sure the model is correct.

Q My blood pressure exceeded the warning level, but my family did not receive the e-mail notification?

A 1. Please check the e-mail address under setting menu.

2. Please check the internet connection.

Q What should I do if I forget my password?

Can I change my user name?

How do I add another user?

A Please contact customer service for assistance.
