124 channels are provided to this EUT. Therefore, the low, middle and high channels are chosen for testing.

- The EUT is a GPRS class 10 device (Multislot class: 12, Mobile Terminal B), which provide 4 up-link. After pre-tested both functions, found up-link with 1 time slot is worse, therefore, test results of output power, frequency stability, occupied bandwidth and band edge tests came out from this.
- The EUT is an E-GPRS class 10 device (Multislot class: 12, Mobile Terminal B), which provide 4 up-link. After pre-tested both functions, found up-link with 1 time slot is worse, therefore, test results of output power, frequency stability, occupied bandwidth and band edge tests came out from this.
- The EUT has GSM, GPRS & E-GPRS functions. After pre-testing, GSM function is the worst case for all the emission tests.

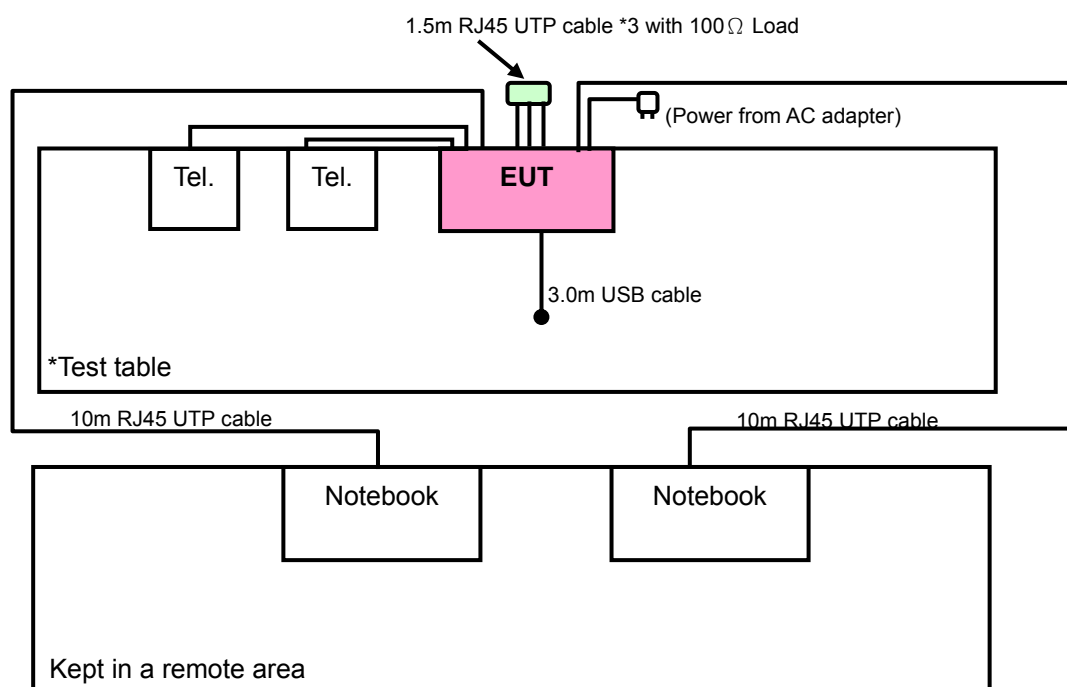

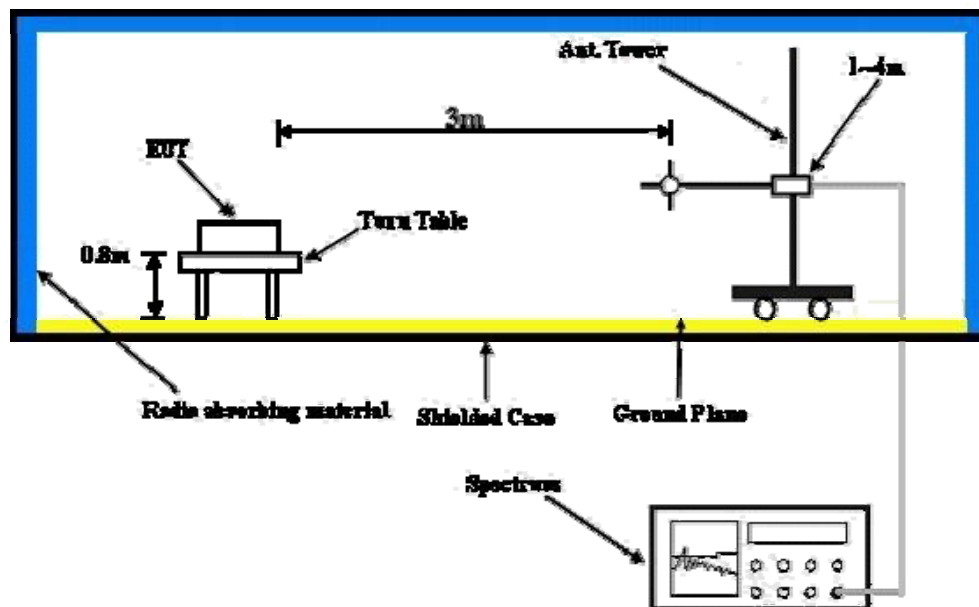

4.1.3 TEST PROCEDURES

4.5.3 TEST PROCEDURE

- The EUT makes a phone call to the communication simulator. The power was measured with R&S Spectrum Analyzer. All measurements were done at 3 channels, 128, 190 and 251 (GSM) / 4132, 4182 and 4233 (WCDMA) (low, middle and high operational frequency range.)
- The conducted spurious emission used the power splitter via EUT RF power connector between simulation base station and spectrum analyzer. This splitter loss and cable loss are the worst loss 23.1dB in the transmitted path track.
- When the spectrum scanned from 9kHz to 9GHz, it shall be connected to 20dB Pad. The spectrum set RB=1MHz, VB=3MHz.

4.6.3 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meters semi-anechoic chamber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

NOTE: The resolution bandwidth of spectrum analyzer is 1 MHz and the video bandwidth is 3 MHz.

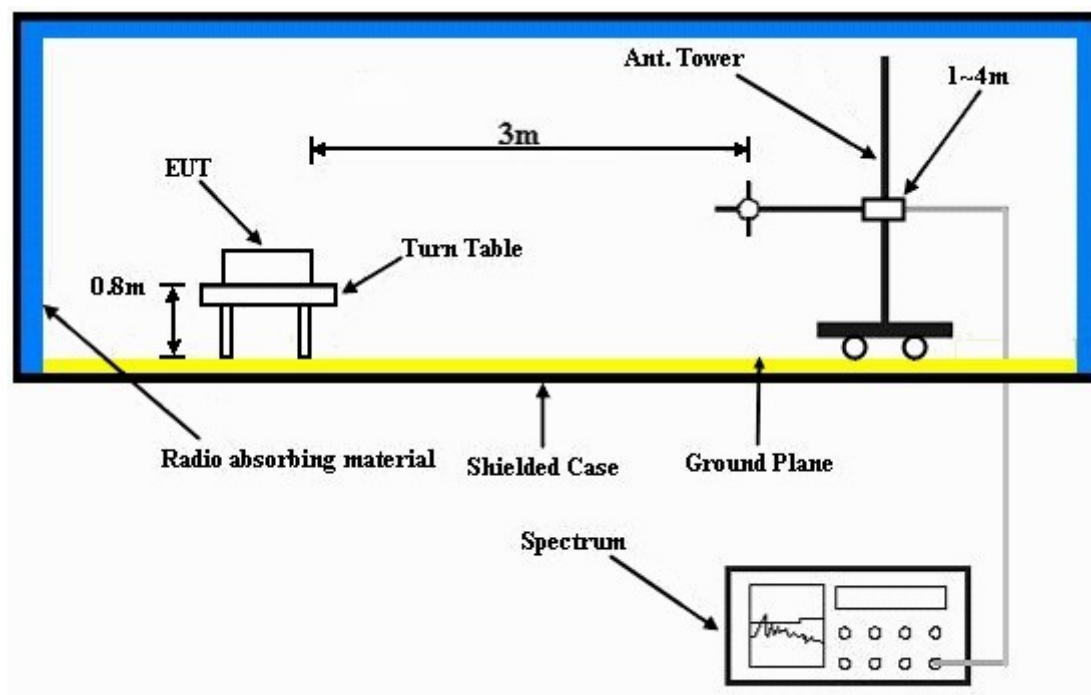

In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The “Read Value” is the spectrum reading the maximum power value.
- b. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a TX cable. Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to “Read Value “ of step a. Record the power level of S.G
- c. $EIRP = \text{Output power level of S.G} - \text{TX cable loss} + \text{Antenna gain of substitution horn}.$
- d. E.R.P power can be calculated form E.I.R.P power by subtracting the gain of dipole, $E.R.P \text{ power} = E.I.P.R \text{ power} - 2.15\text{dBi}.$
