



<h3>Operation Instruction</h3> <ul style="list-style-type: none"> <li>• TTU-WHS-D works with all Wireless Ready TTU units.</li> <li>• Press and hold the MUTE, the LISTEN volume down key and the Power on/off key simultaneously then release the MUTE and LISTEN volume down key to enter the USER'S MANUAL Keep press the LISTEN volume key to obtain the HS ID that matches the RF ID on the TTU-WR unit. Continue to press the Mic MUTE key until the display turns off.</li> <li>• Press and hold the power ON/OFF button to turn the unit on and off.</li> <li>• Press the UP or DOWN triangle key to increase or decrease the TALK or LISTEN volume.</li> <li>• Press the square Mic MUTE key once to turn off the operator's microphone.
