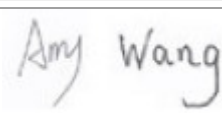

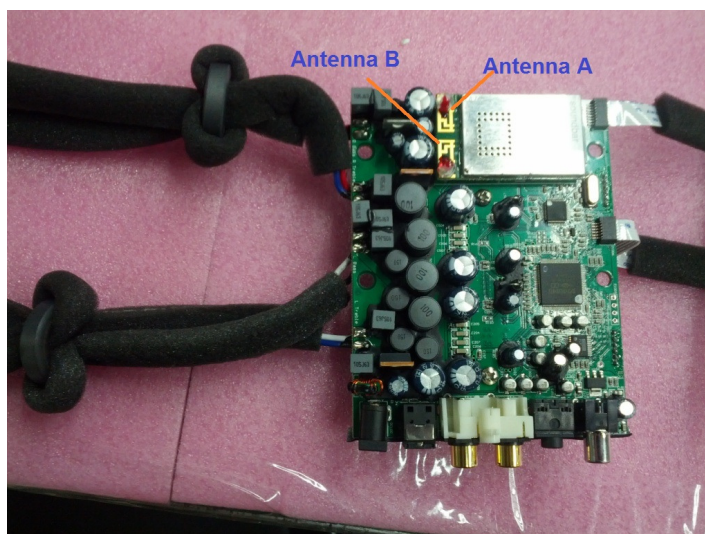

7.1 E.U.T. test conditions

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

15.247(b) (4) requirement:

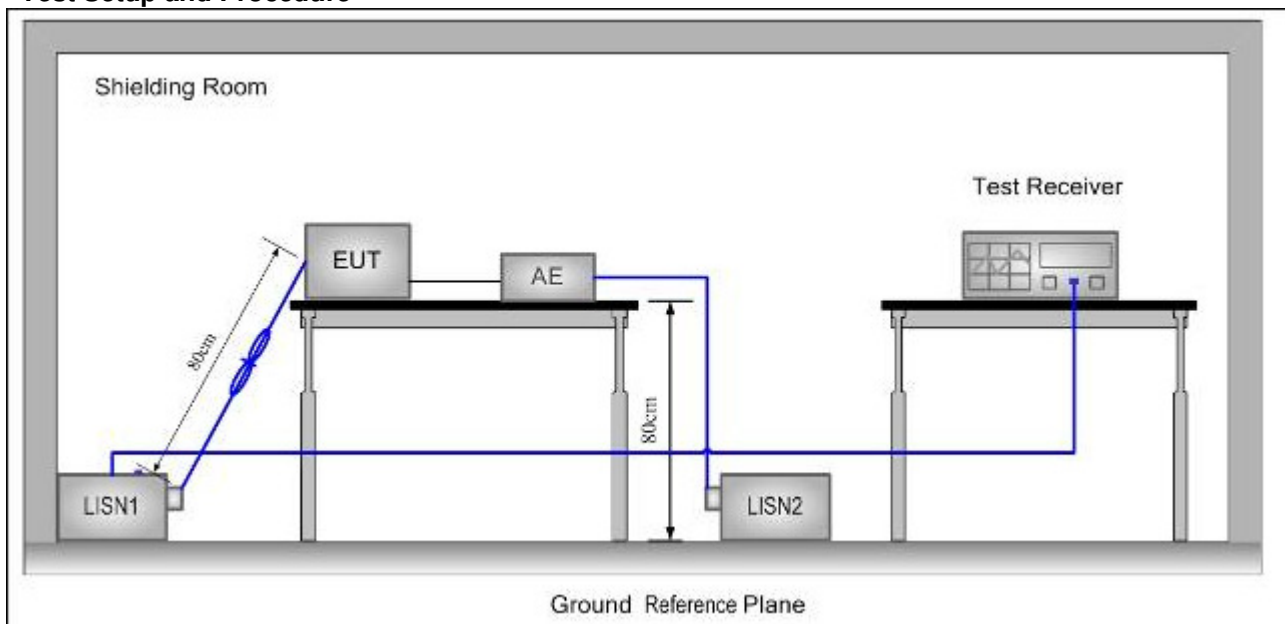

Test Setup and Procedure



1. The mains terminal disturbance voltage was measured with the EUT in a shielded room.
2. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a 50Ω/50μH + 5Ω linear impedance. The power cables of all other units of the EUT was connected to a second LISN, which was bonded to the ground reference plane in the same way as the

LISN for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded

3. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane, but separated from metallic contact with the ground reference plane by 0.1m of insulation.
4. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance was between the closest points of the LISN and the EUT. The mains lead of EUT excess 0.8m was folded back and forth parallel to the lead so as to form a horizontal bundle with a length between 0.3m and 0.4m. All other units of the EUT and associated equipment was at least 0,8 m from the LISN.

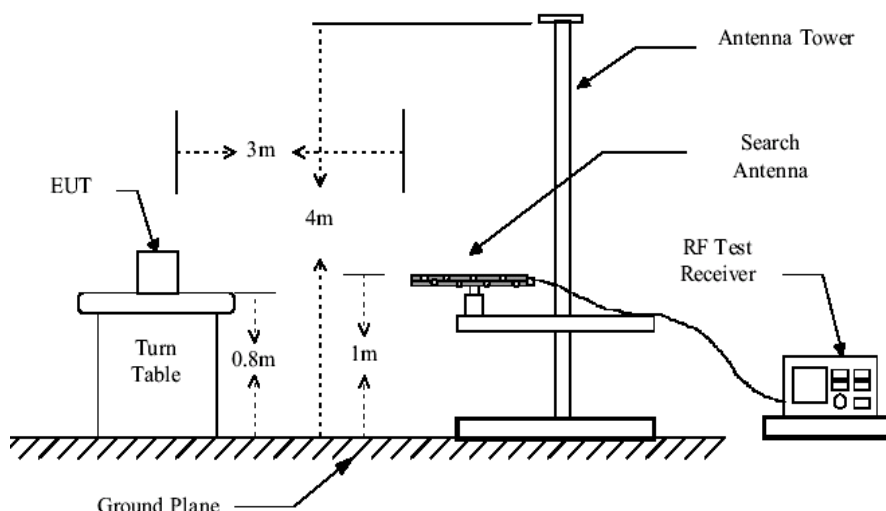


Figure 1. 30MHz to 1GHz radiated emissions test configuration

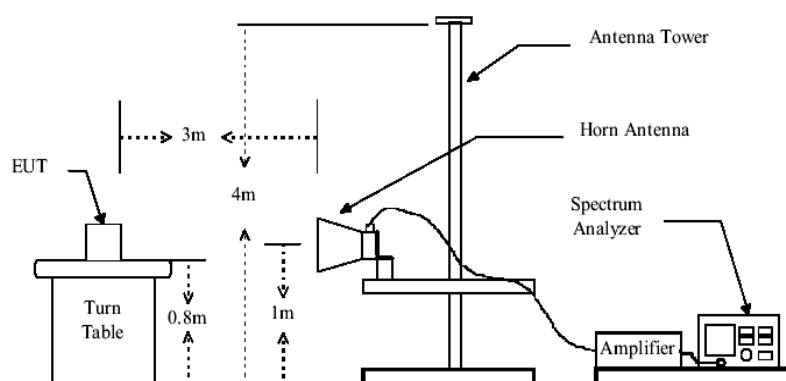


Figure 2. Above 1GHz radiated emissions test configuration

An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. Low noise amplifier was used below 1GHz, High pass Filter was used above 3GHz.

Between 1G and 3GHz, we did not use any amplifier or filter.

Pre-test was performed on Antenna A and Antenna B mode, Compliance test was performed on worst case (Antenna A mode).

Test were performed for there spatial orthogonal(X, Y, Z), the worst test data (X orthogonal) was sumitted.

1) For this intentional radiator operates below 25 GHz. the spectrum shall be investigated to the tenth harmonic of the High fundamental frequency. And above the third harmonic of this intentional radiator, the disturbance is very low. So the test result only displays to 5rd harmonic.

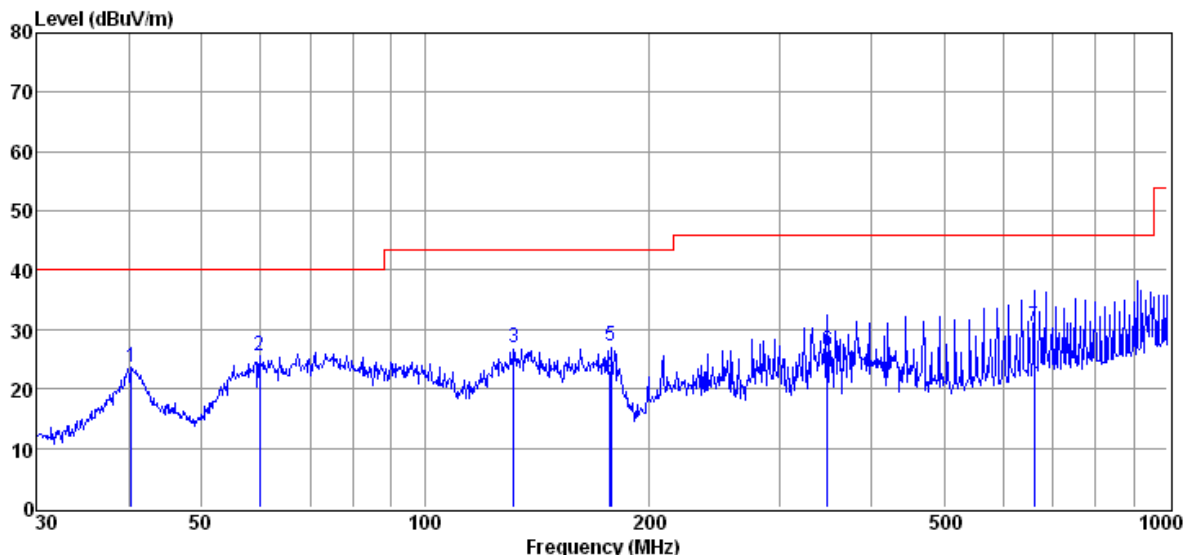

Test Procedure:

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. Set the spectrum analyzer: Span = approximately 2 to 3 times the 20dB bandwidth, centered on the hopping channel;
3. Set the spectrum analyzer: RBW \geq 1% of the 20dB bandwidth (set 100kHz). VBW \geq RBW. Sweep = auto; Detector Function = Peak. Trace = Max Hold.
4. Mark the peak frequency and -20dB points.

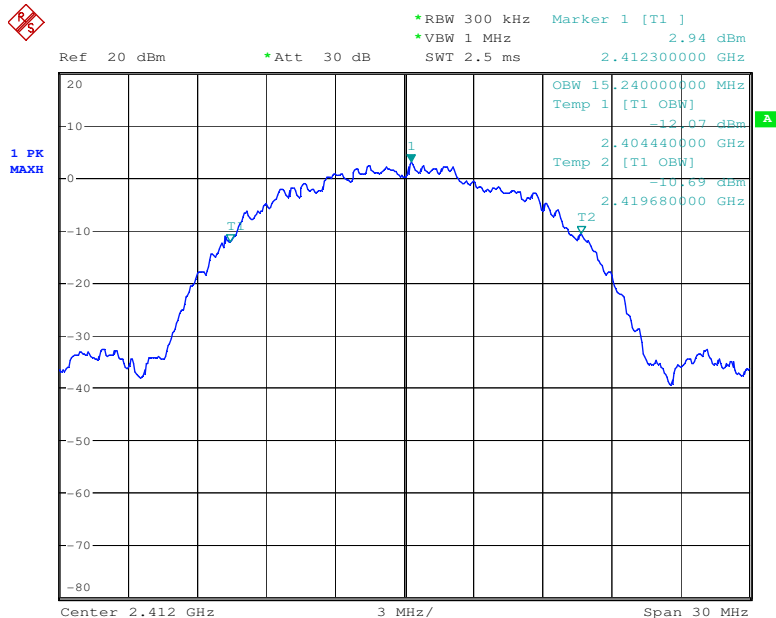

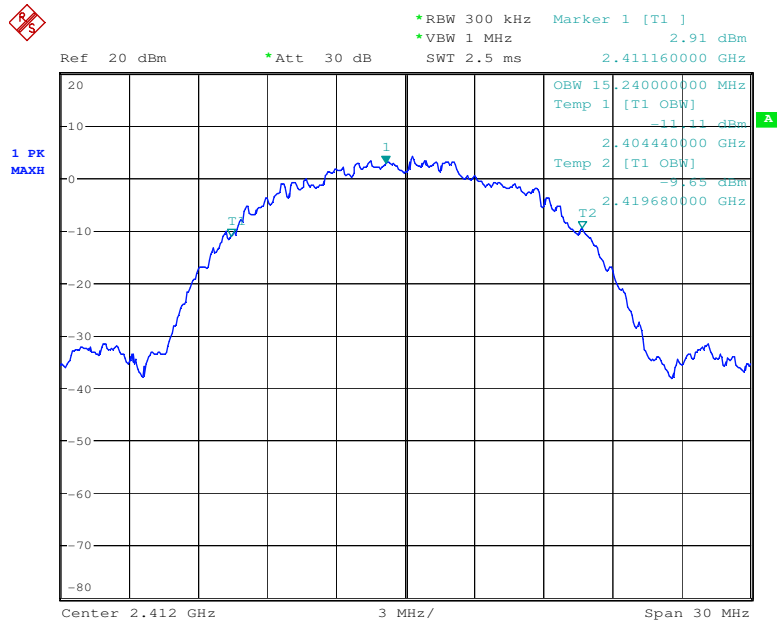

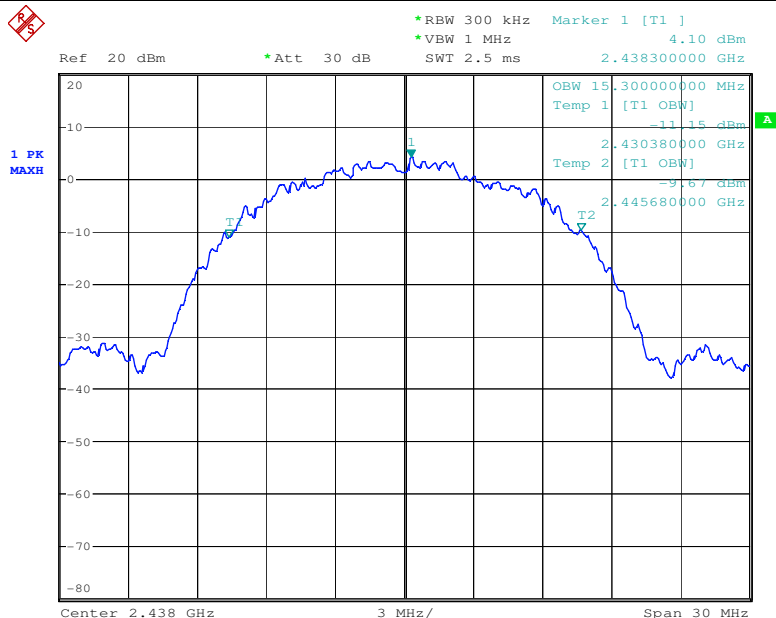

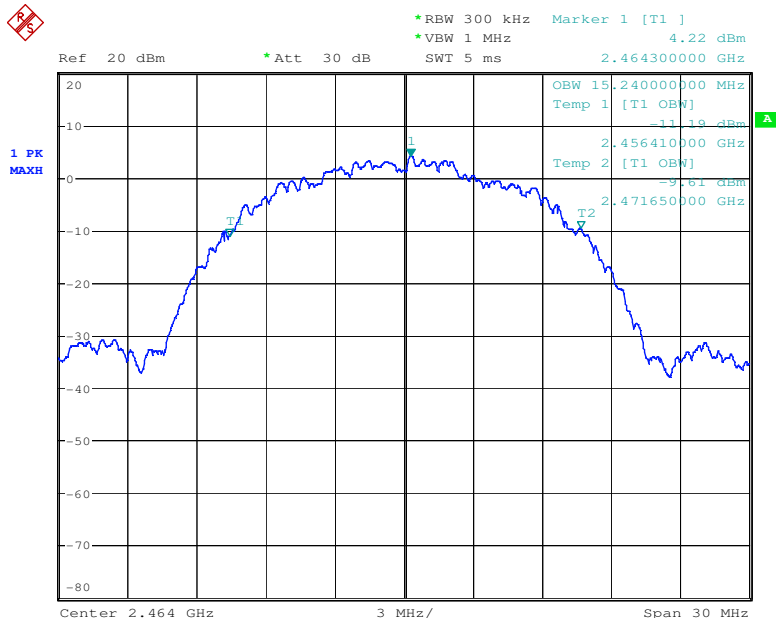
