Chapter 1 Introduction of MSCAN-CVG


1.1 Overview of MSCAN-CVG:



MSCAN-CVG is an UHF EPC C1G2 portable RFID reader. It is designed for close proximity reading. It is a compact RFID reader and OS independent with Bluetooth connectivity to any mobile devices. It serves as a handy checkpoint at different stages throughout the value chain, such as logistics operations, inventory management and POS system etc.

- The MSCAN-CVG Intelligent RFID Reader supports protocols, UHF CLASS 1 GEN2 EPC C1G2/ISO 18000-6C, (917-927 MHz RFID frequency band) in United States.






2.1 Connect to Windows PC

2.1.1 BT connection



This section explains how to set-up MSCAN-CVG and connect the MSCAN-CVG to your computer:


- I. Power On the MSCAN-CVG by pressing the Power On button.
- II. White LEDs on both sides light up, which indicates the Bluetooth is ready.
- III. Search and Pair the Bluetooth with your computer:
 - In startup manual, choose “Control Panel”.
 - In “Control Panel”, choose “Devices and Printers”
 - In “Devices and Printers”, press the button “add a device”, then select mDongle D1 BT address to pair. In general, the mDongle D1 BT name is called “mDongle- XXXX”



IV. When the Bluetooth is connected, LEDs turn blue.

V. After BT is connected, then run the test program in the computer to control the MSCAN-CVG operation.

VI. Set the “COM” number in the program which is generated after paired. The “COM” number can be found in the device manager in the computer.



VII. Run the web application program. Then set the parameter.





2.2 Hardware installation

The main unit and antenna will be mount on a moving rail as show below. It is behind the mounting bracket for tablet. The distance between the user and the antenna is greater than 6cm.
