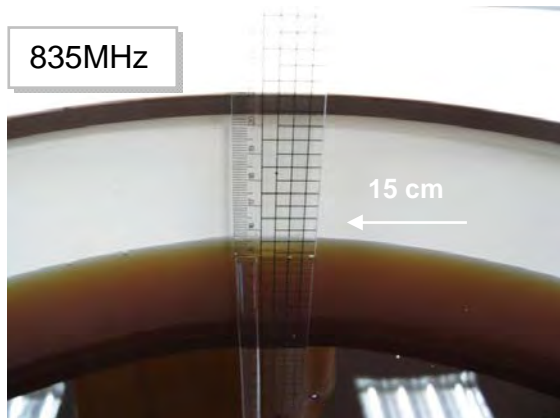

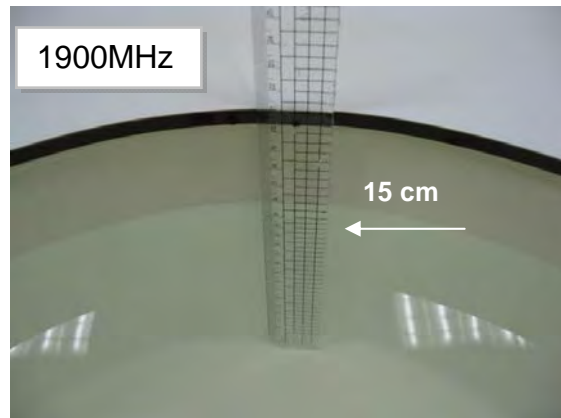

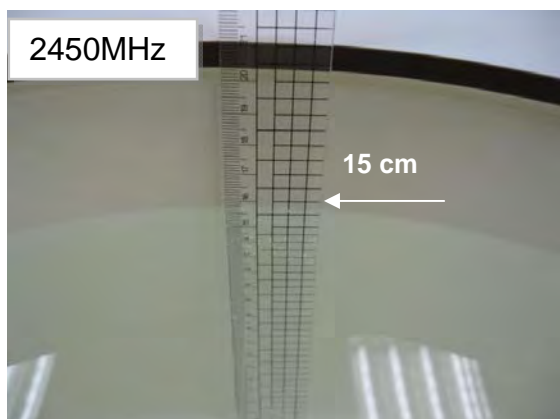

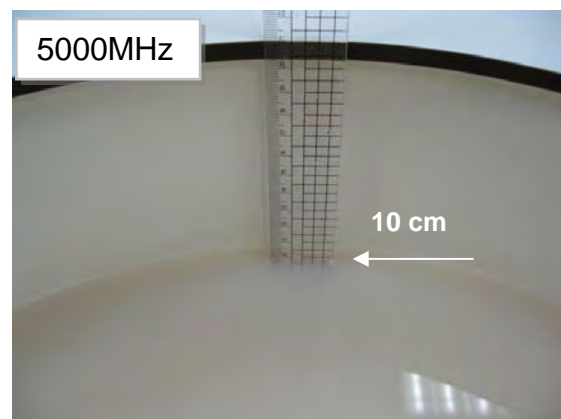

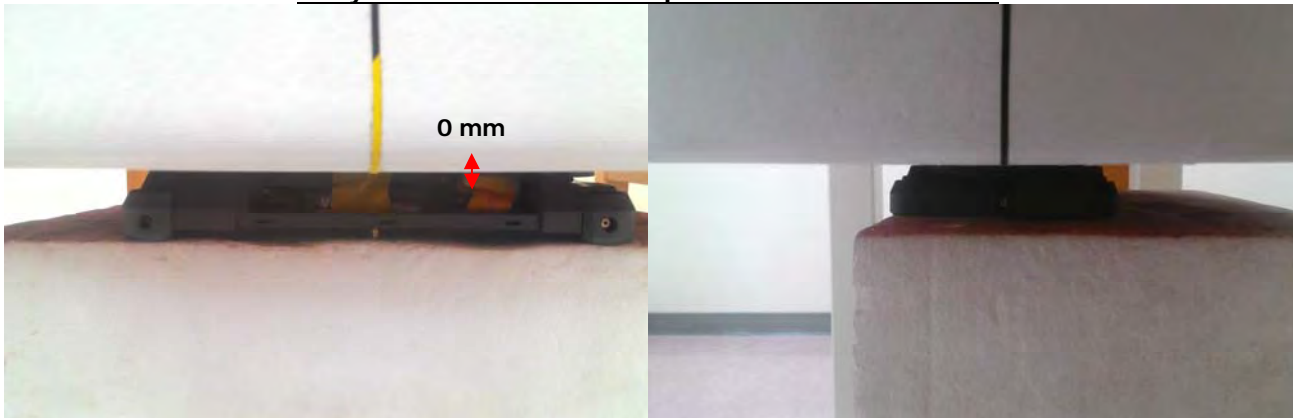


Fig.3 EUT Back side to flat phantom

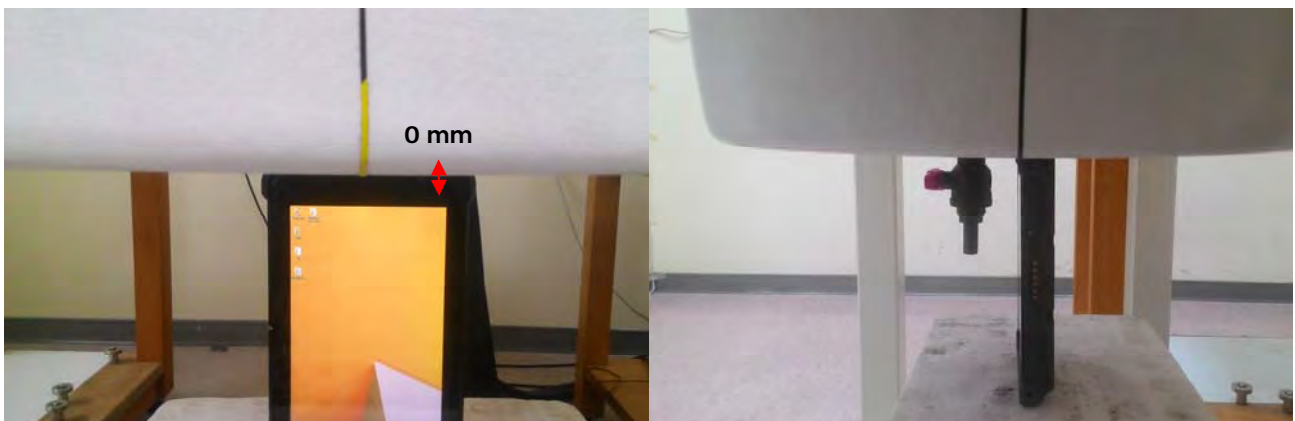


Fig.5 EUT Right side to flat phantom

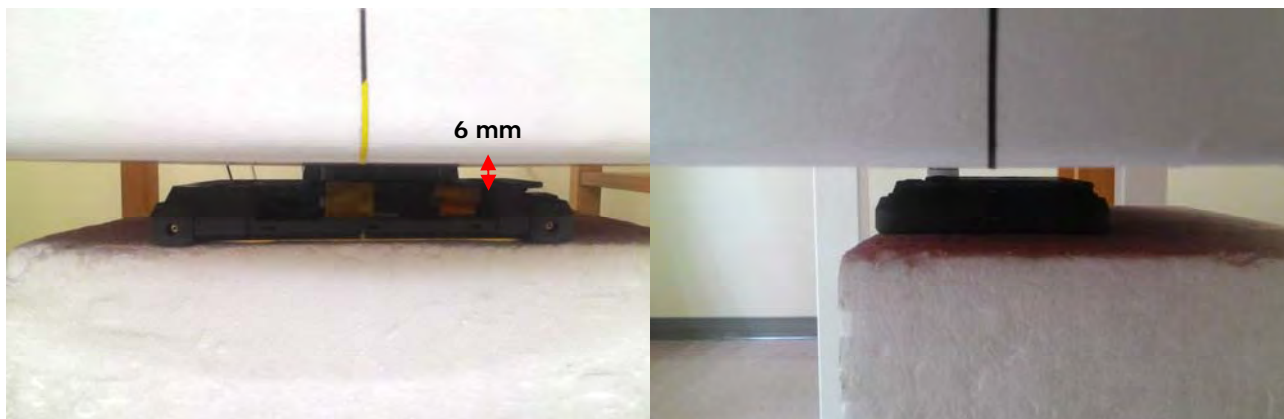


Fig.7 EUT back side to flat phantom

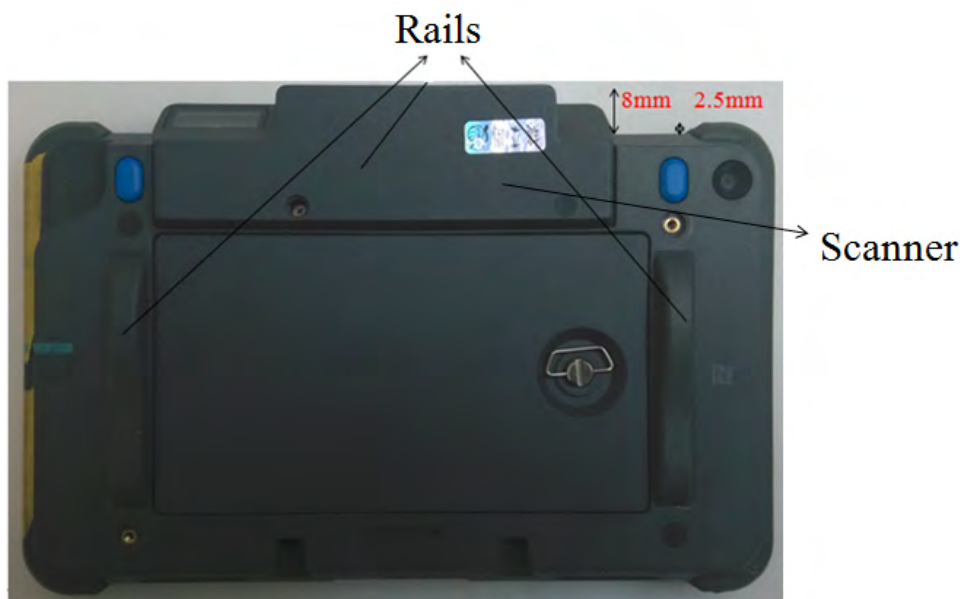


Fig.11 Back view of EUT(with scanner and rails)

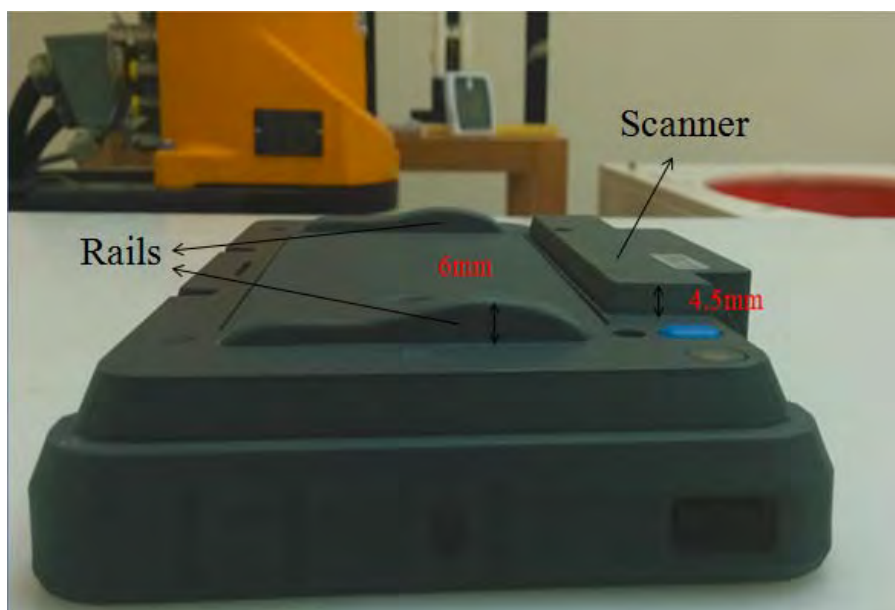


Fig.12 Side view of EUT(with scanner and rails)

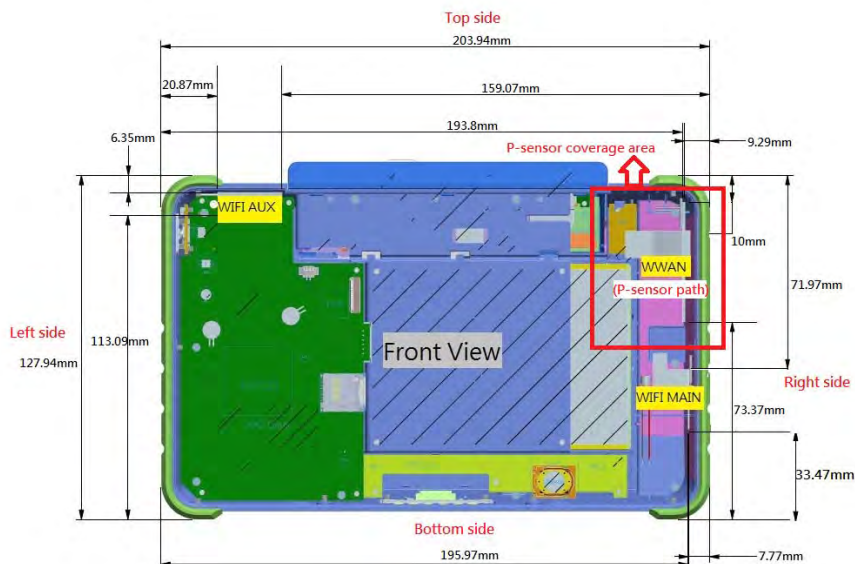


Fig.13 Antenna position of EUT (Front view)
