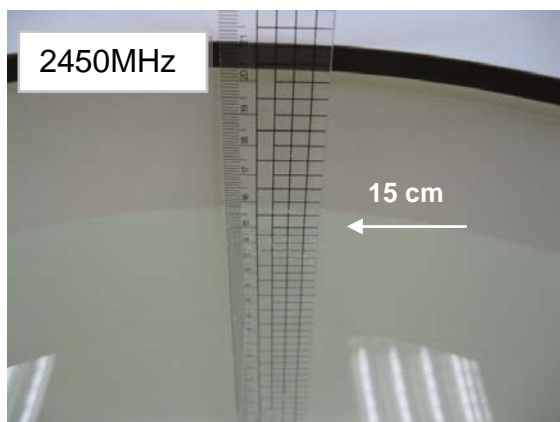

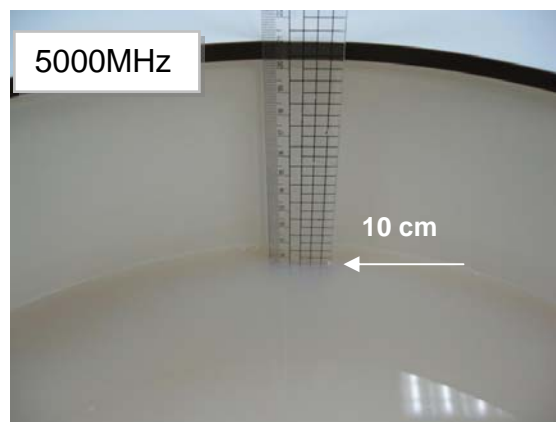

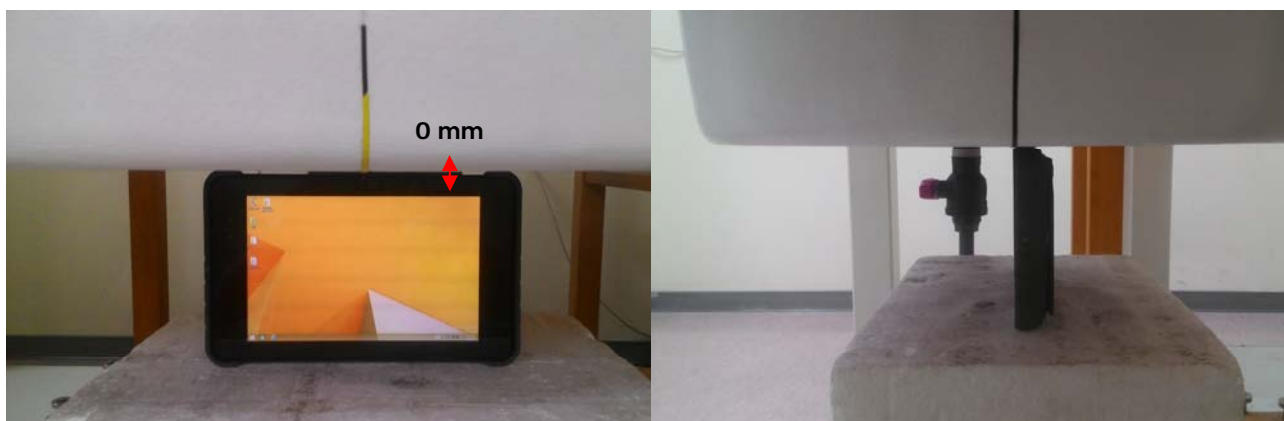


Fig.4 EUT Top side to flat phantom

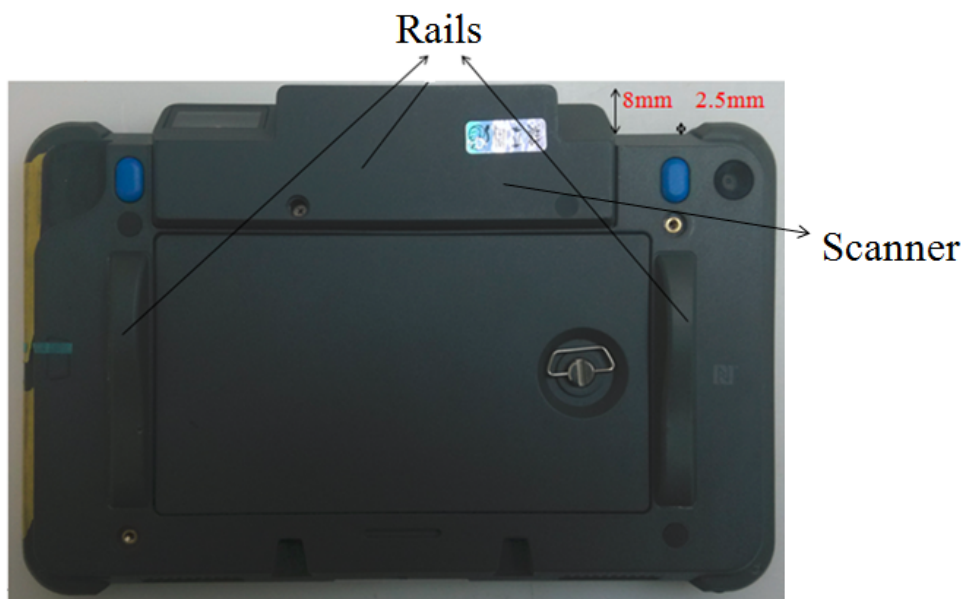


Fig.9 Back view of EUT(with scanner and rails)

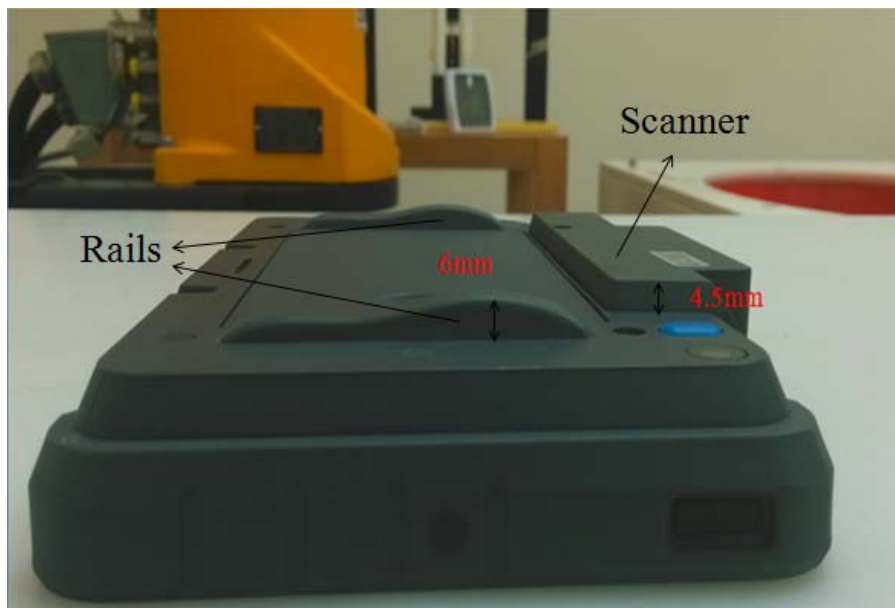


Fig.10 Side view of EUT(with scanner and rails)

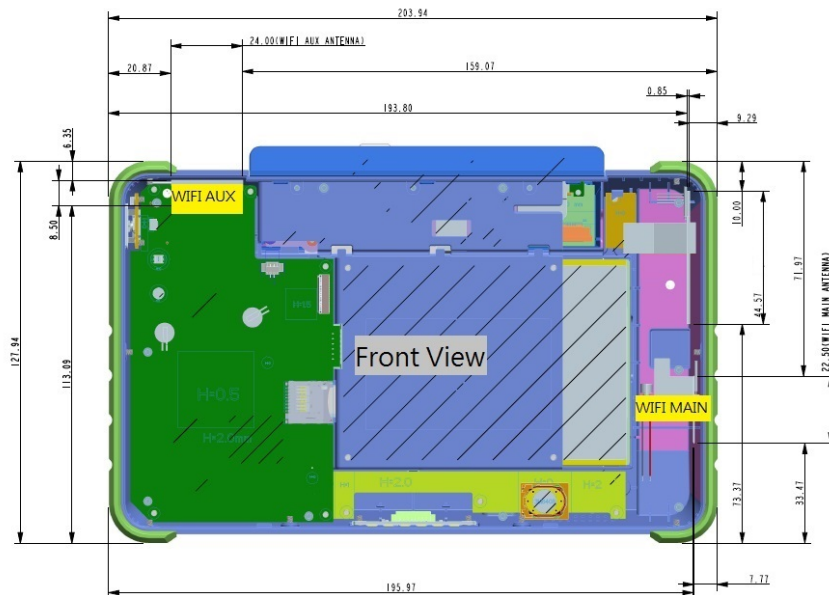


Fig.11 Antenna position of EUT (Front view)
