1.6 Maximum Permissible Exposure (MPE) Evaluation

In this application we seek approval to the iWP250. Based on the FCC OET Bulletin 65 Supplement C and 47 CFR §2.1091, we have concluded that the MO300QBM module will comply with the FCC rules on RF exposure for mobile devices in cellular band and PCS band. The following analysis will demonstrate such compliance. The analysis will be done in two US bands.

Operation in cellular band (824 – 849 MHz)

The ERP of iWP250 in cellular band is 31.31dBm max at GSM/GPRS mode. The resulted power density at a distance of 20 cm can be deducted as follows:

As we can see the resulted power density is below the MPE limit, therefore iWP250 in cellular band is compliant with the FCC rules on RF exposure.
