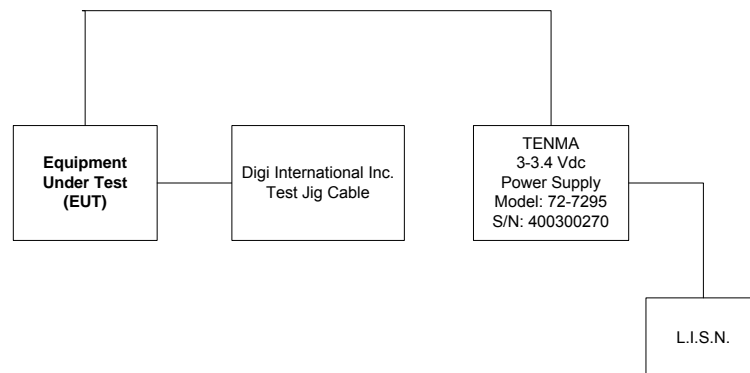

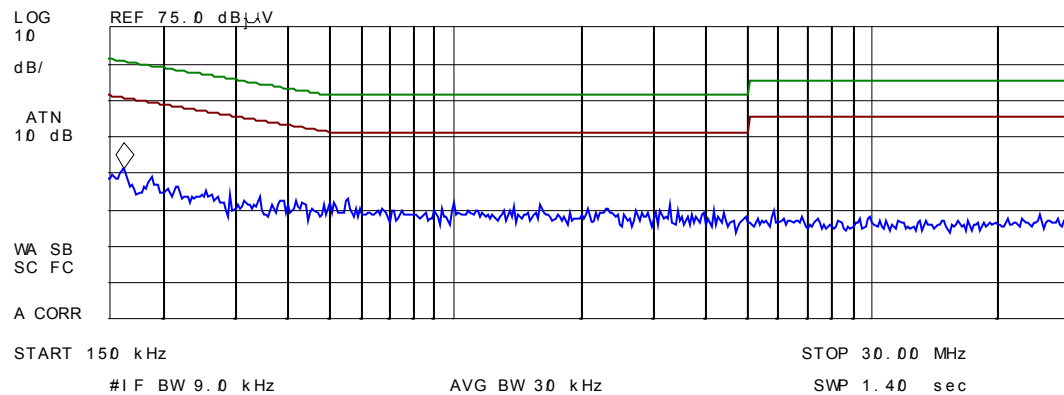

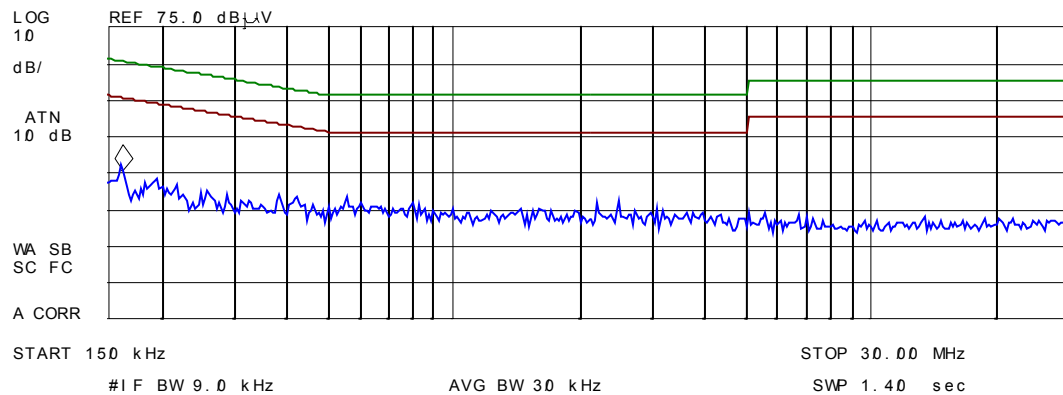

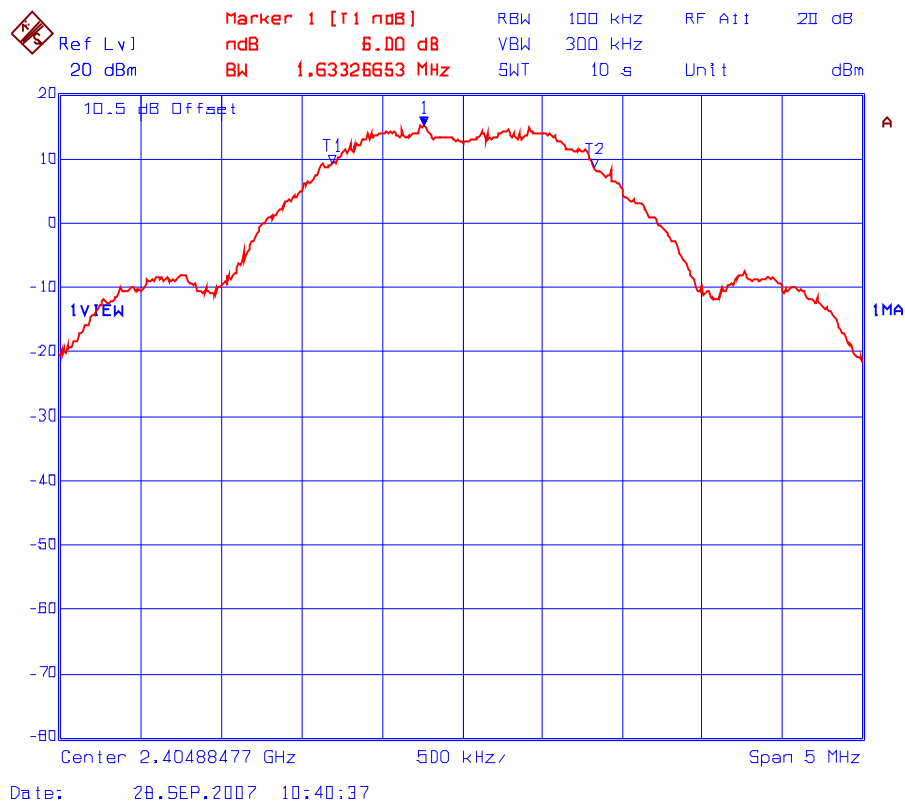

Frequency: 2405 MHz



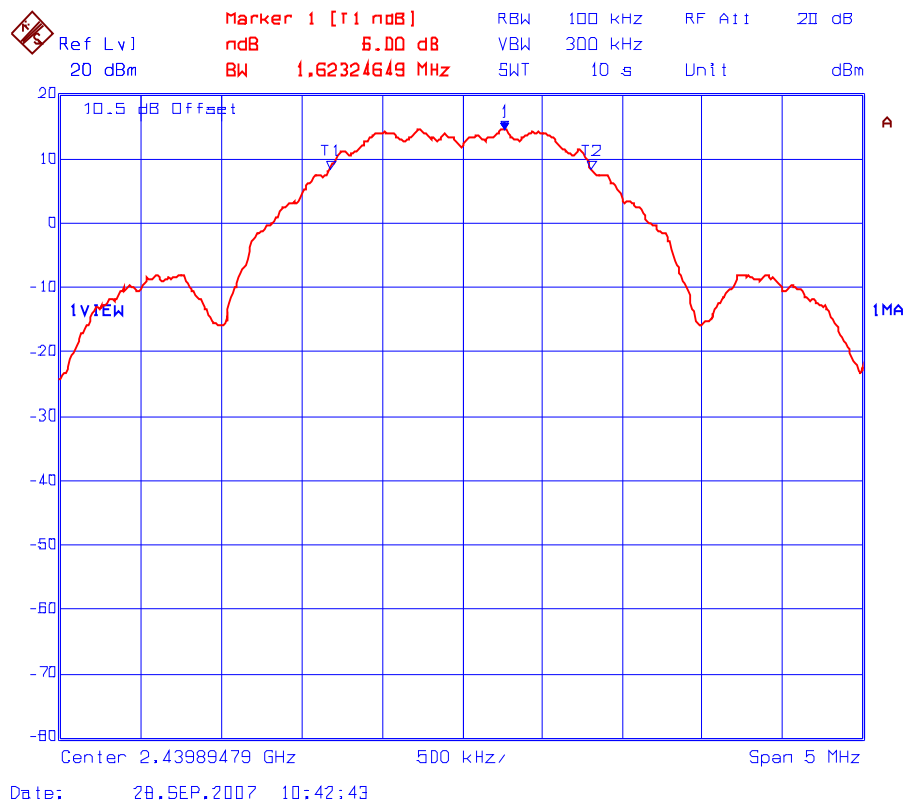

Frequency: 2440 MHz



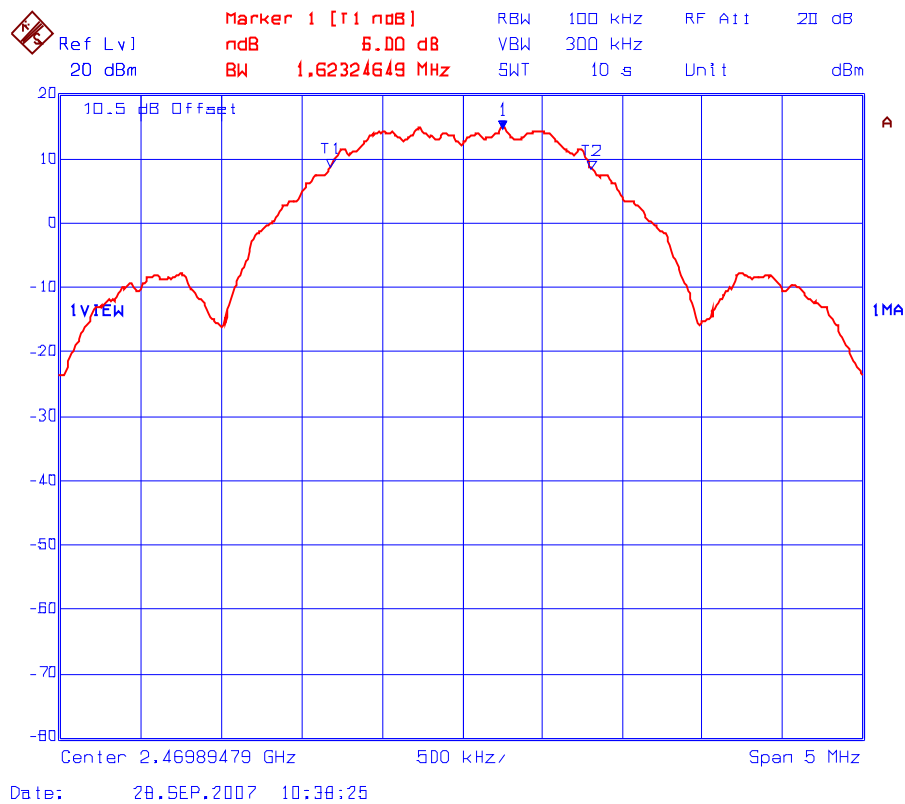

Frequency: 2470 MHz



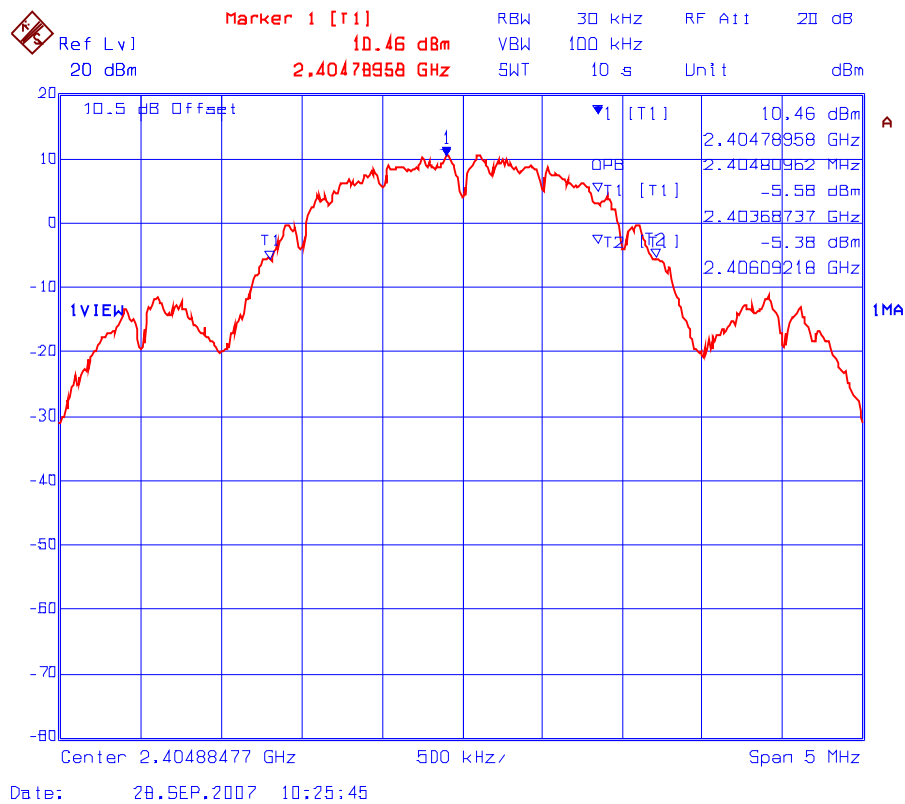

Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. 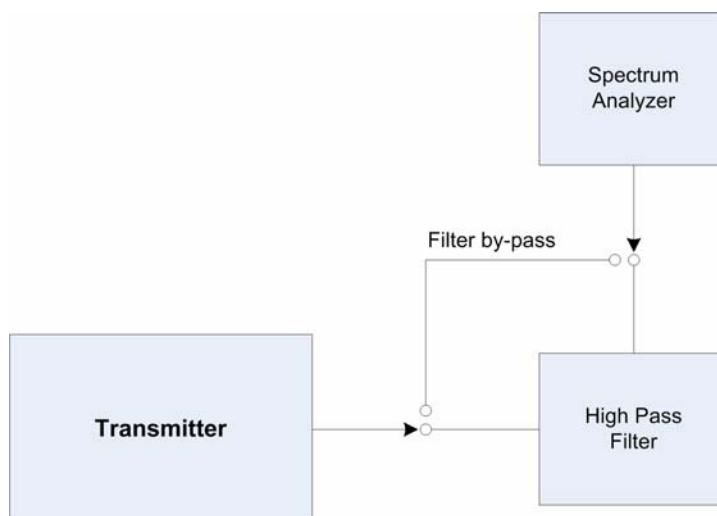

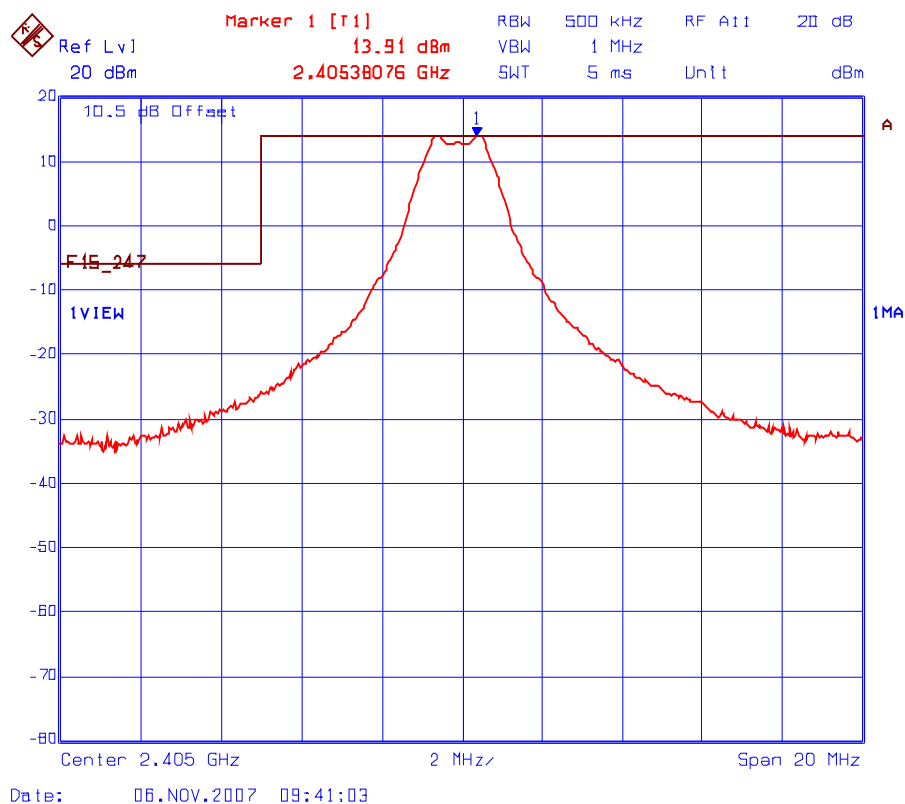

Low End of Frequency Band



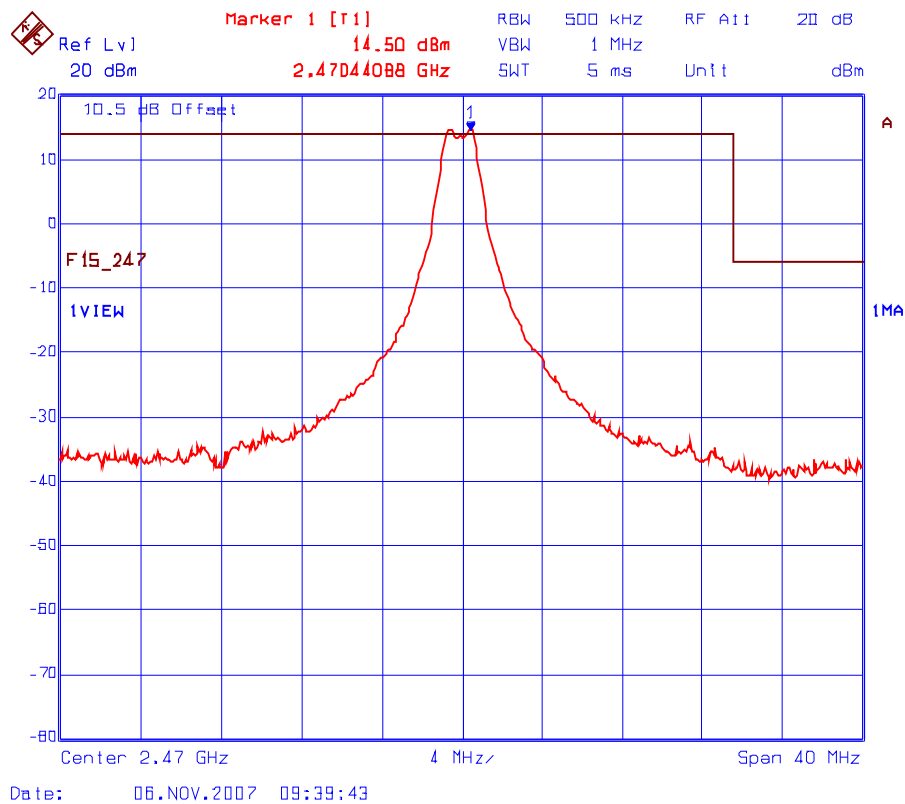

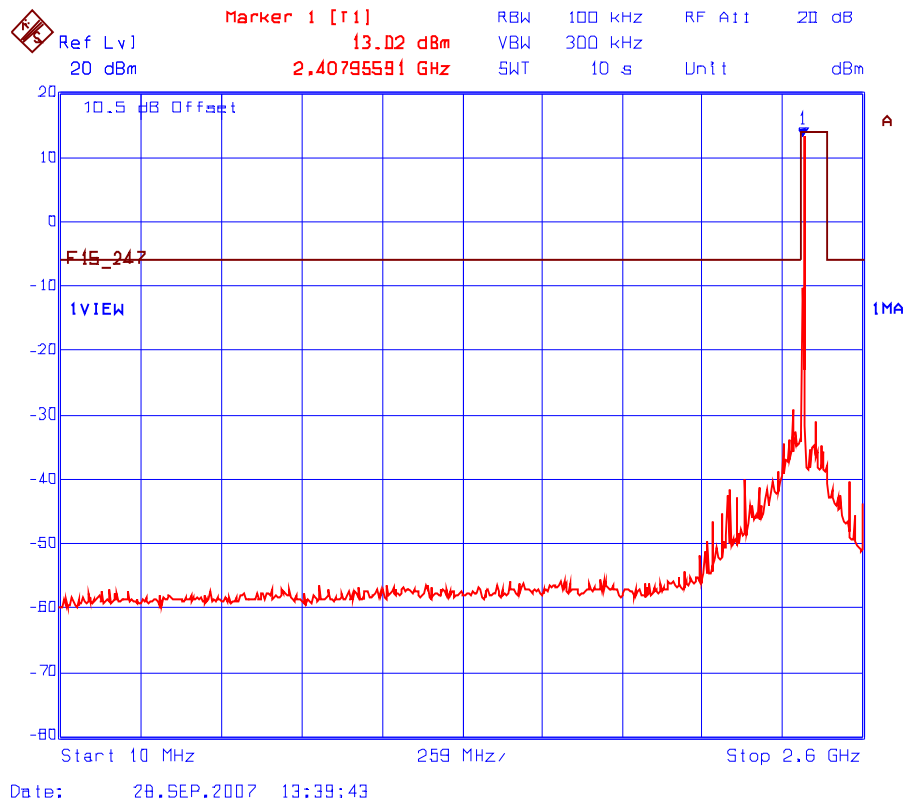

Transmitter Frequency: 2405 MHz



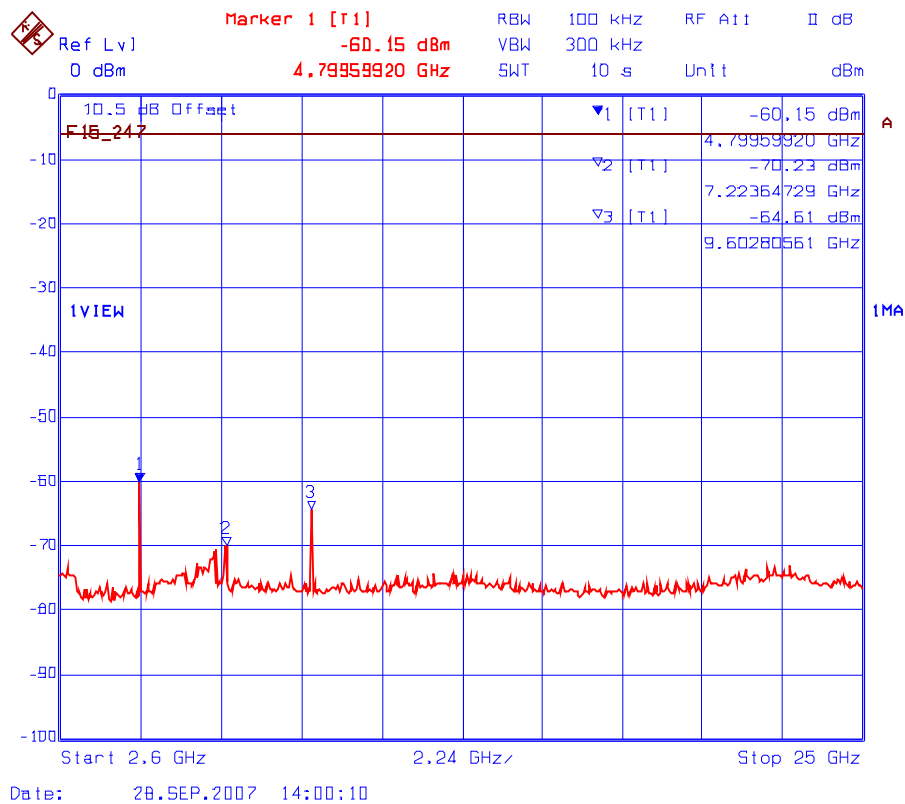

 Transmitter Frequency: 2405 MHz



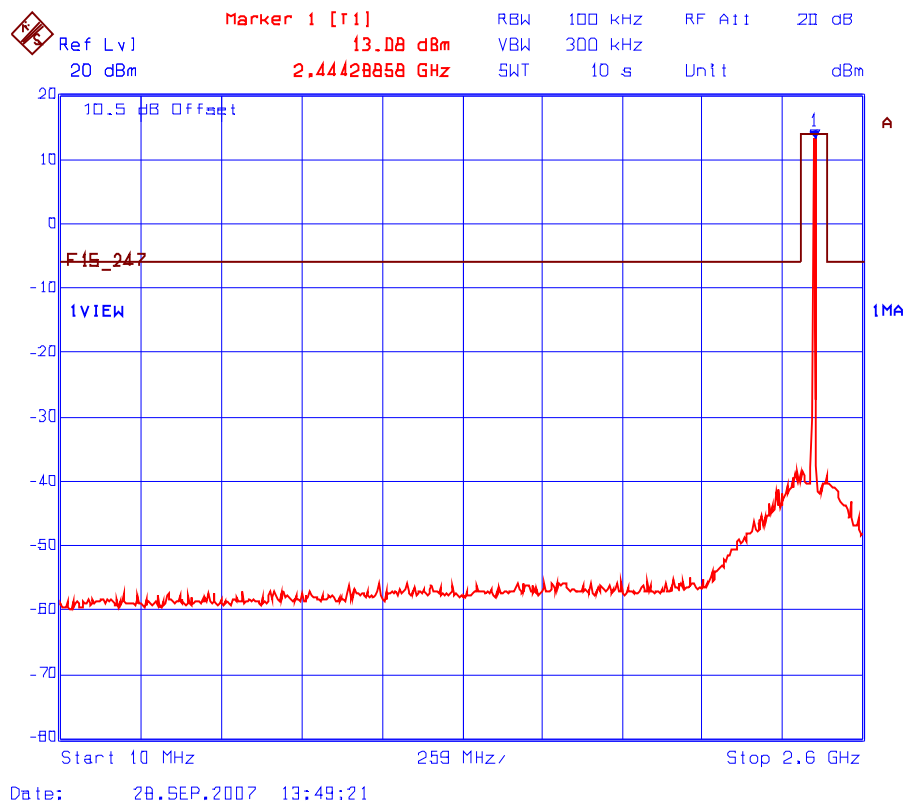

Transmitter Frequency: 2440 MHz



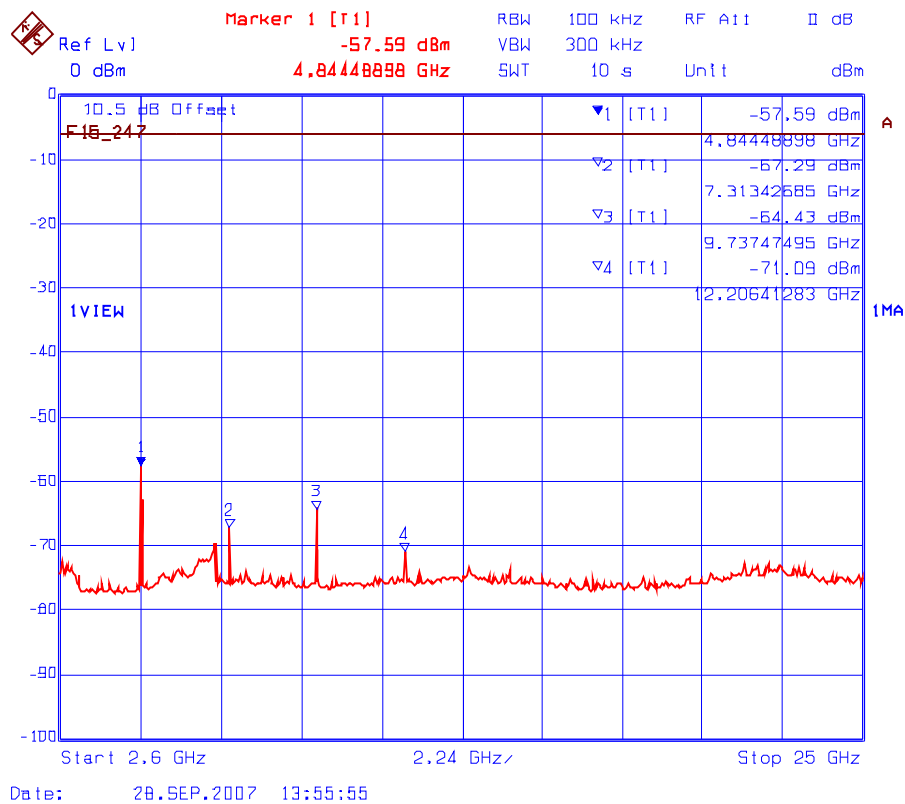

 Transmitter Frequency: 2440 MHz



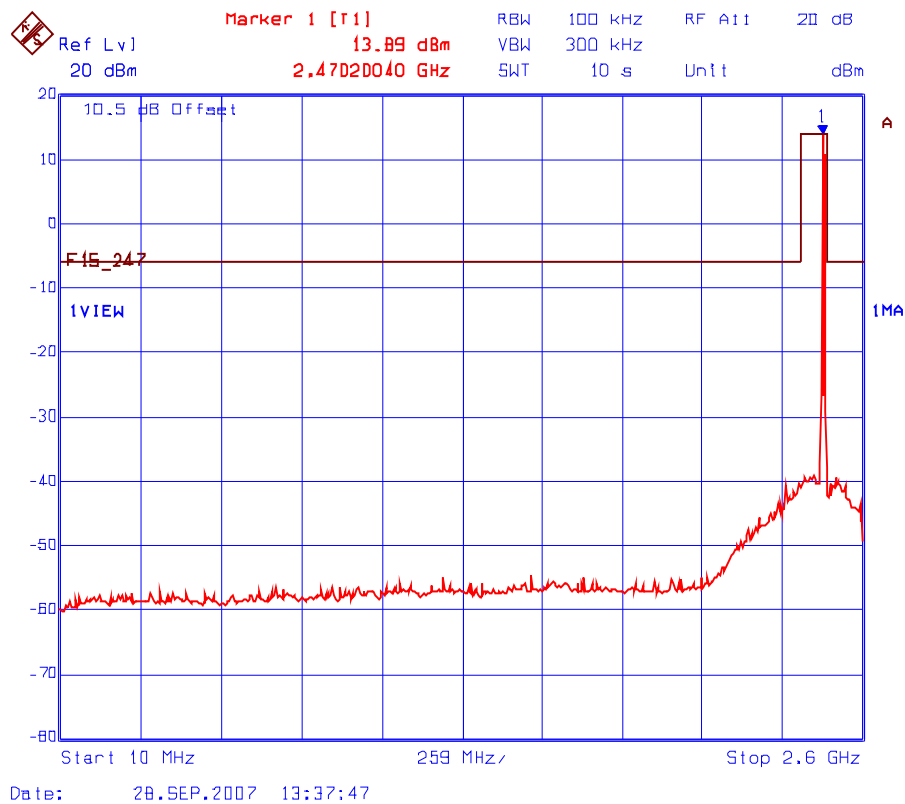

Transmitter Frequency: 2470 MHz



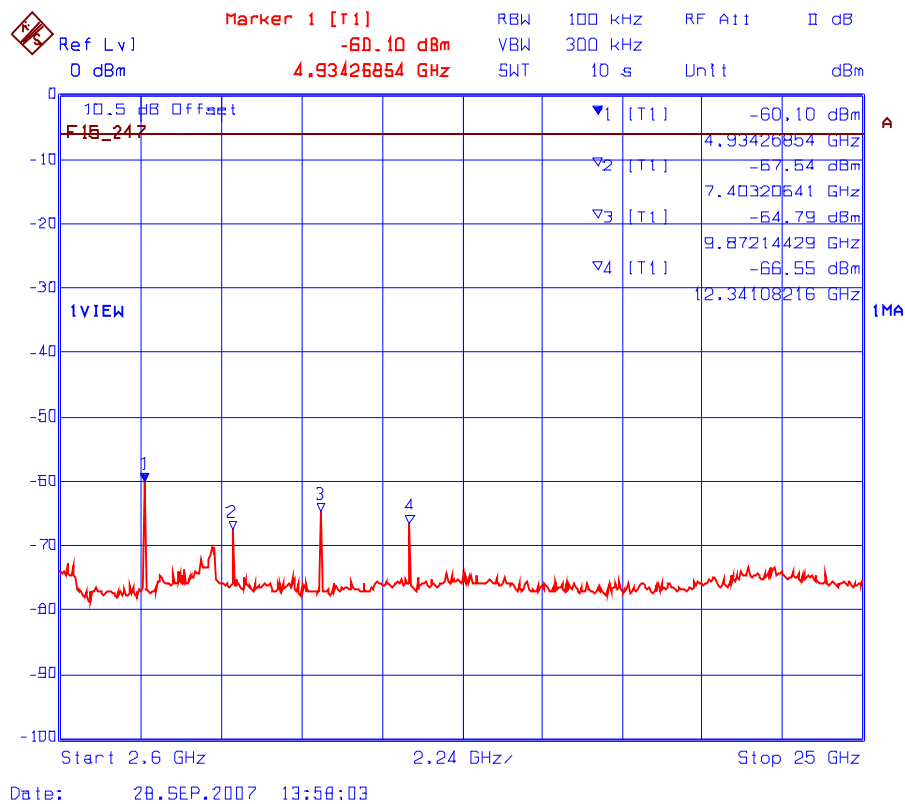

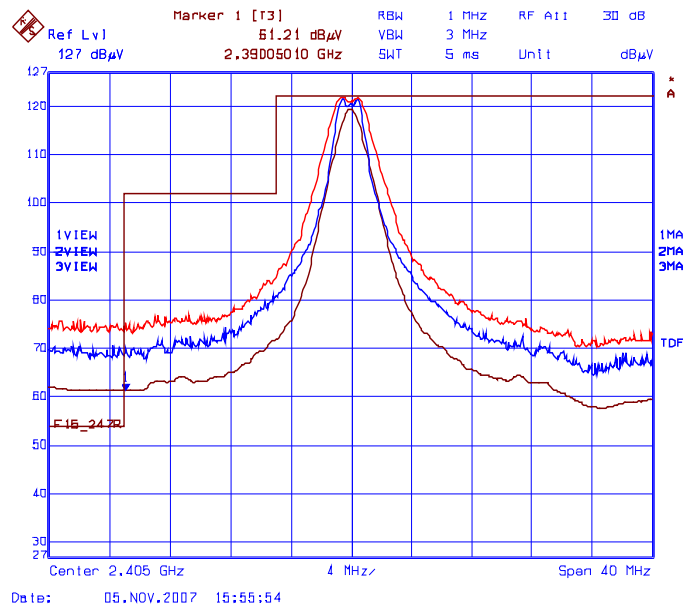

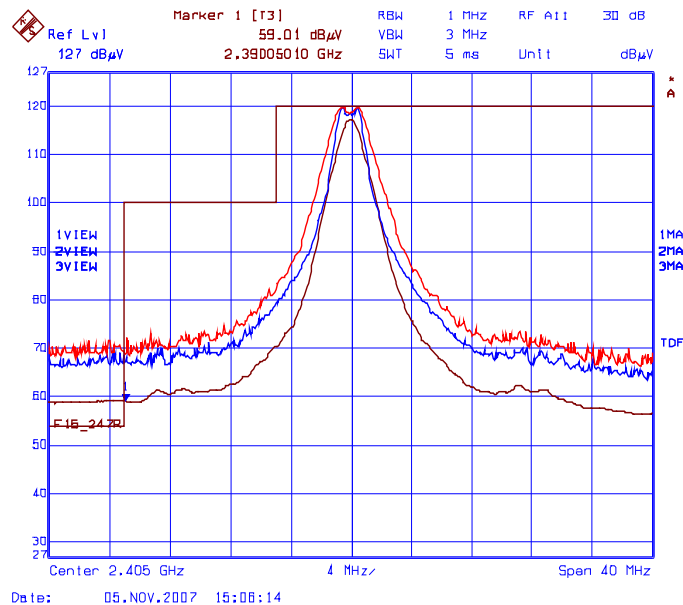

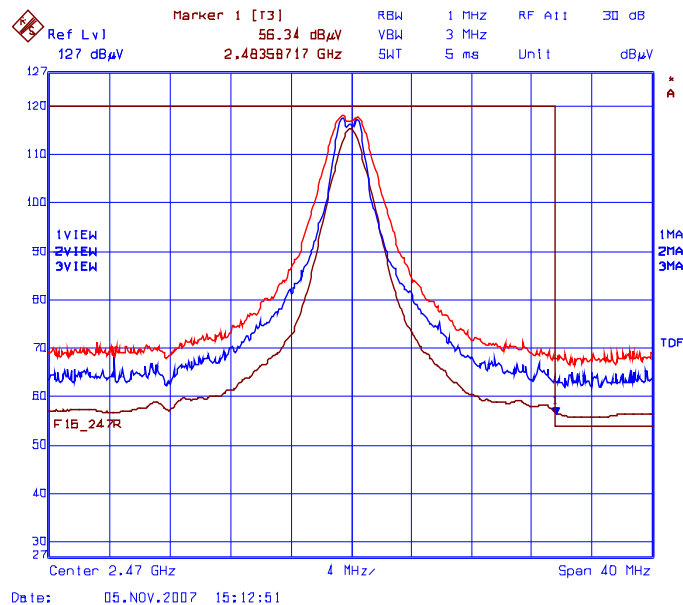

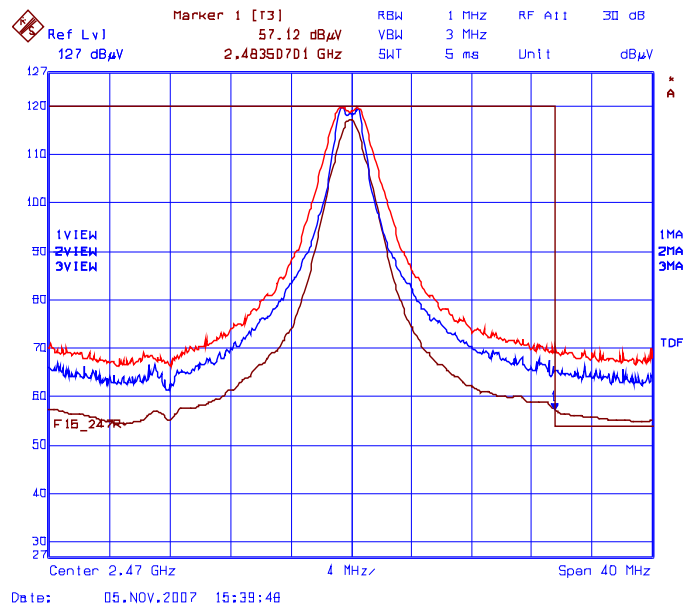

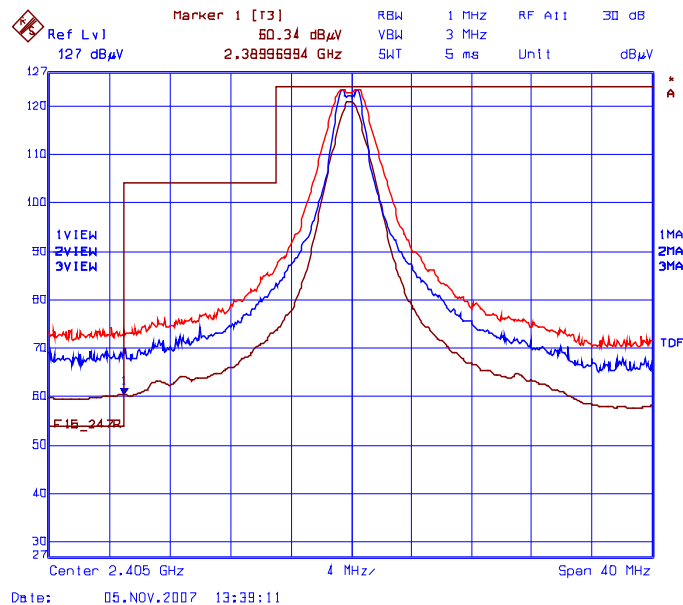

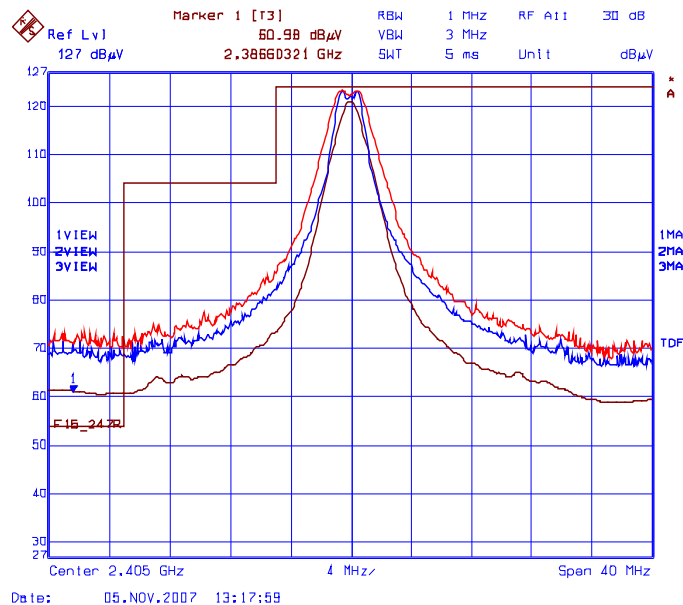

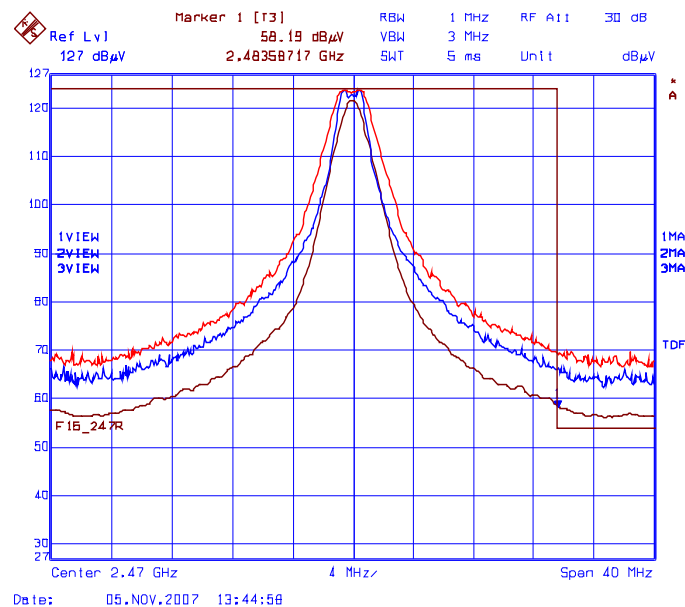

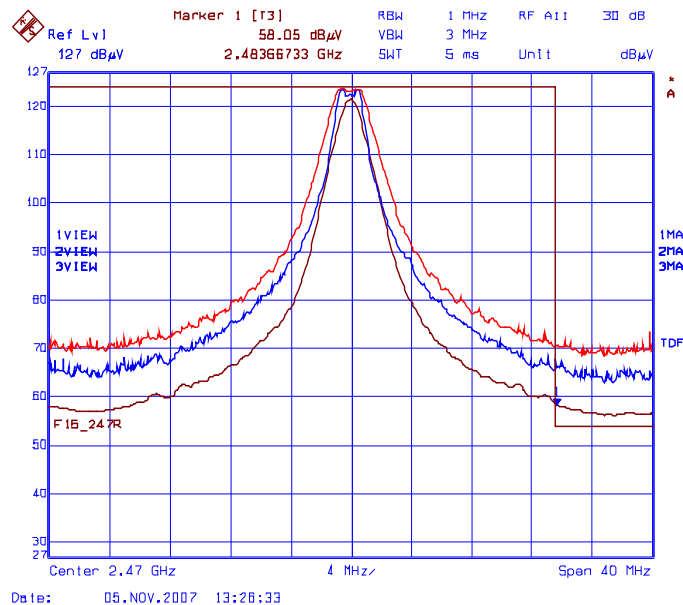

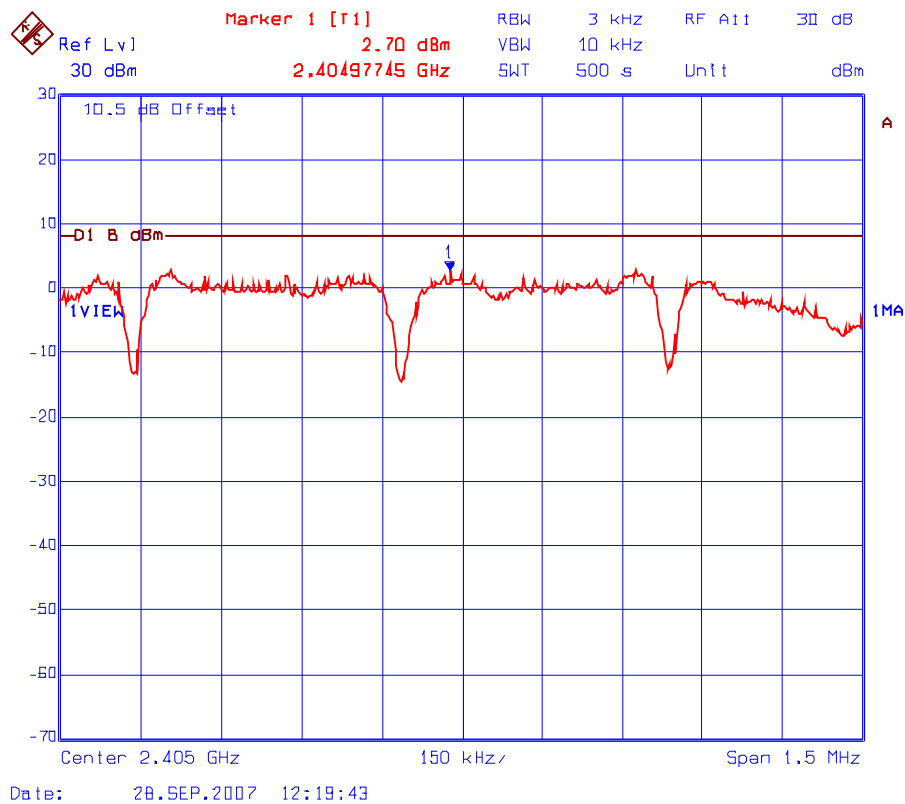

Frequency: 2405 MHz



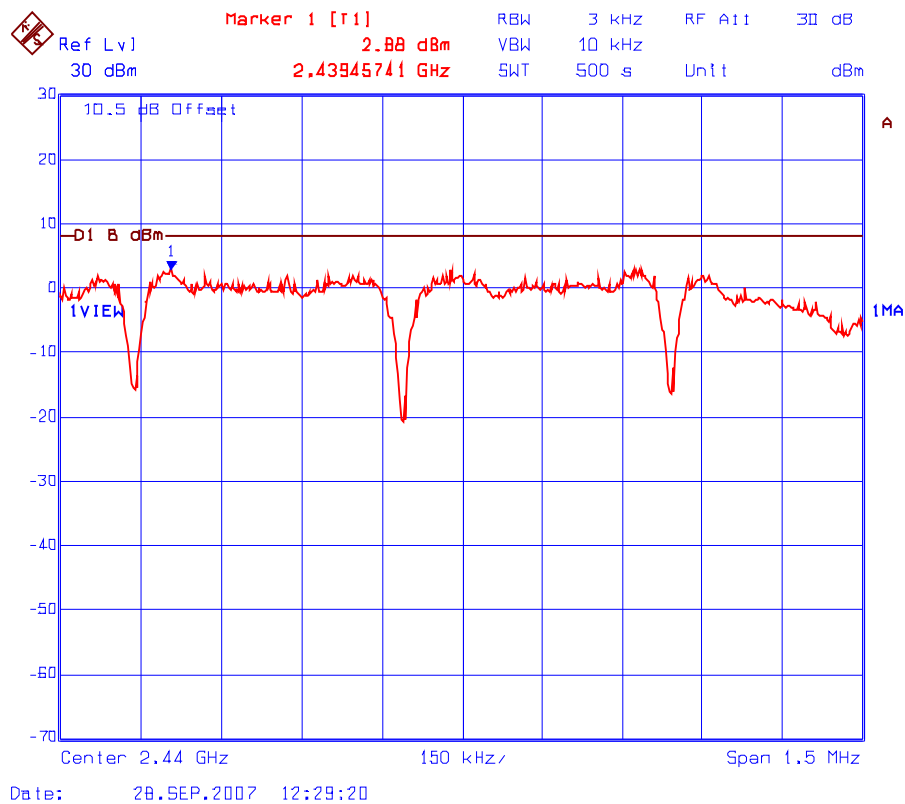

Frequency: 2440 MHz



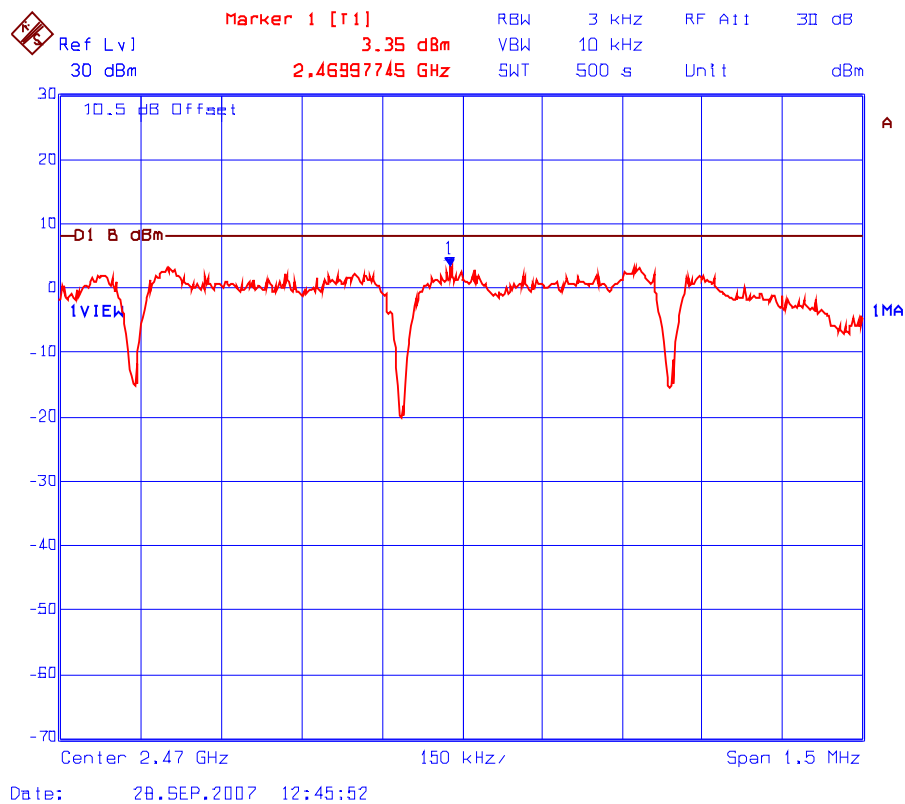
