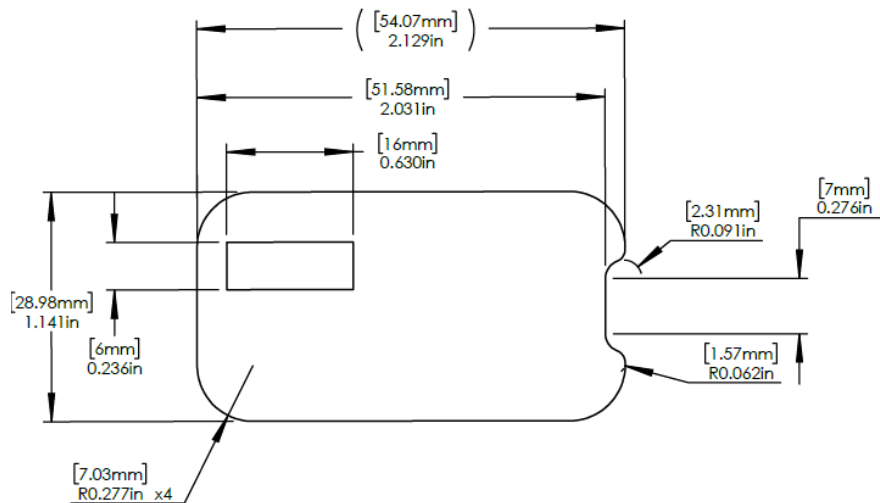


Figure 1: Dimensions of the Label and Transparent Window
