802.11a LCH 5260MHz Ant1 NTN



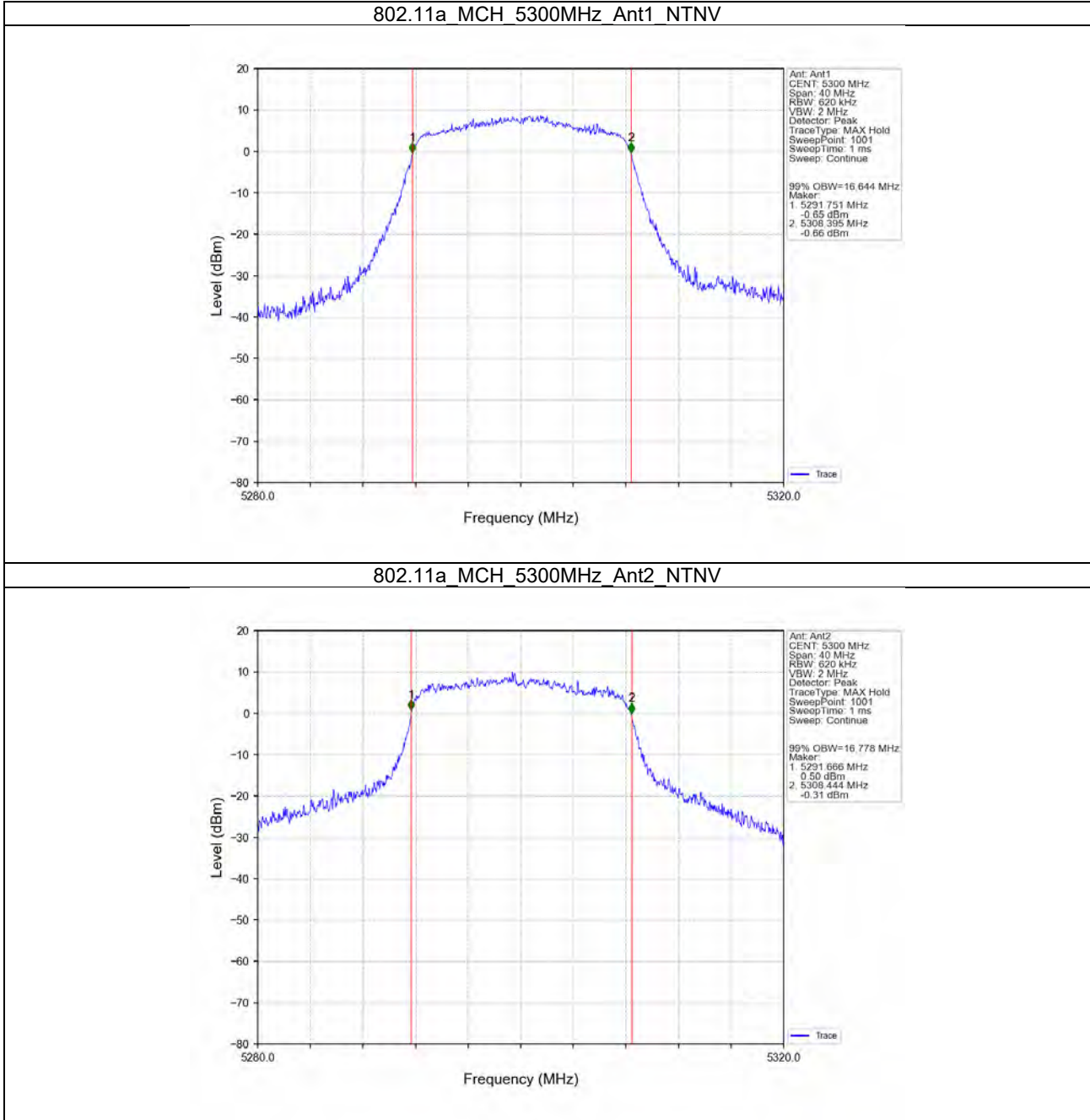
