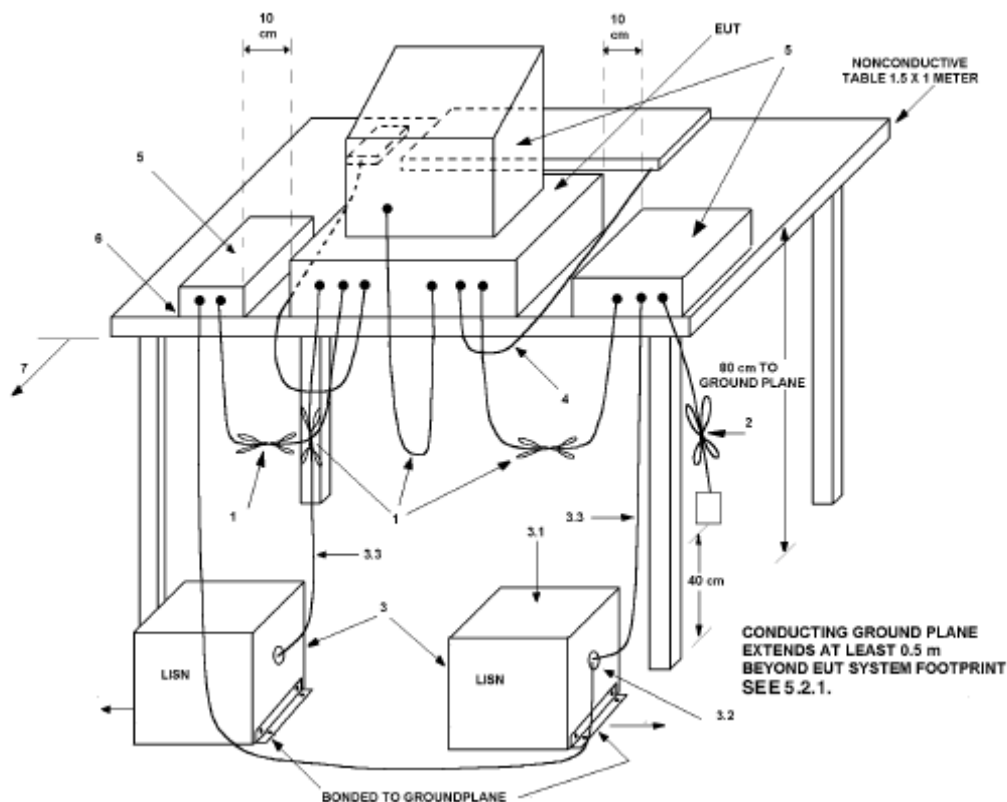

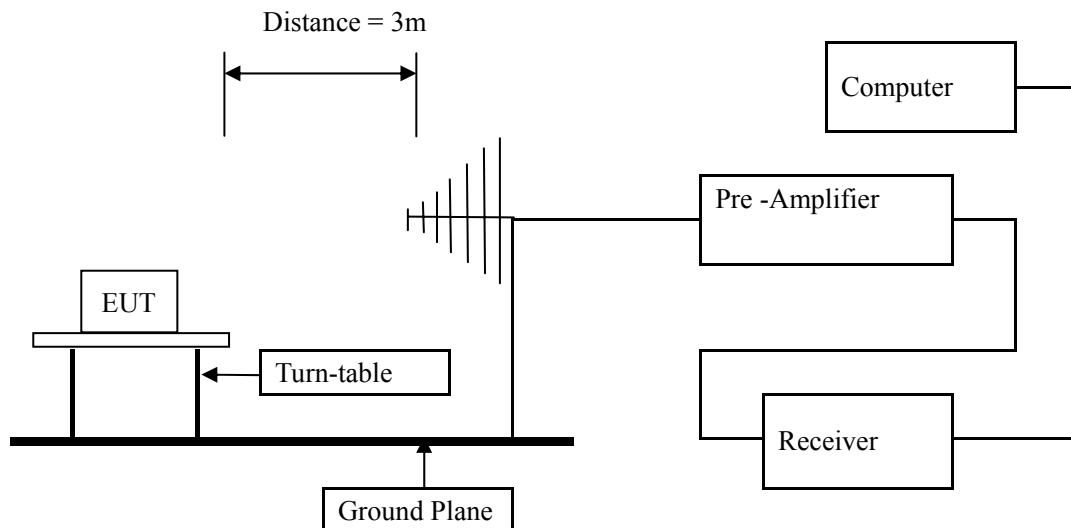

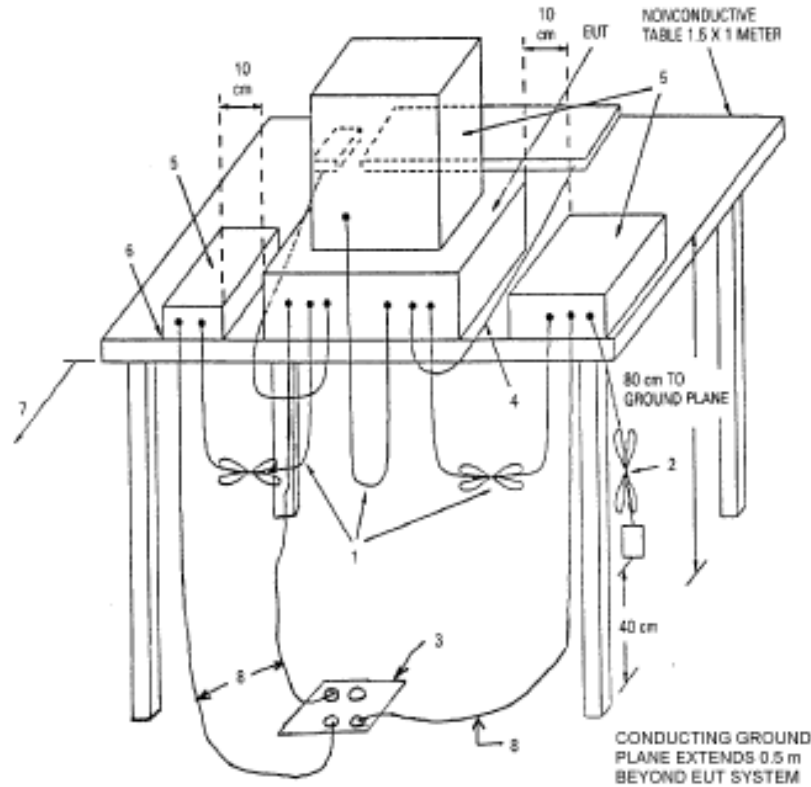
#### Block diagram of Test setup
