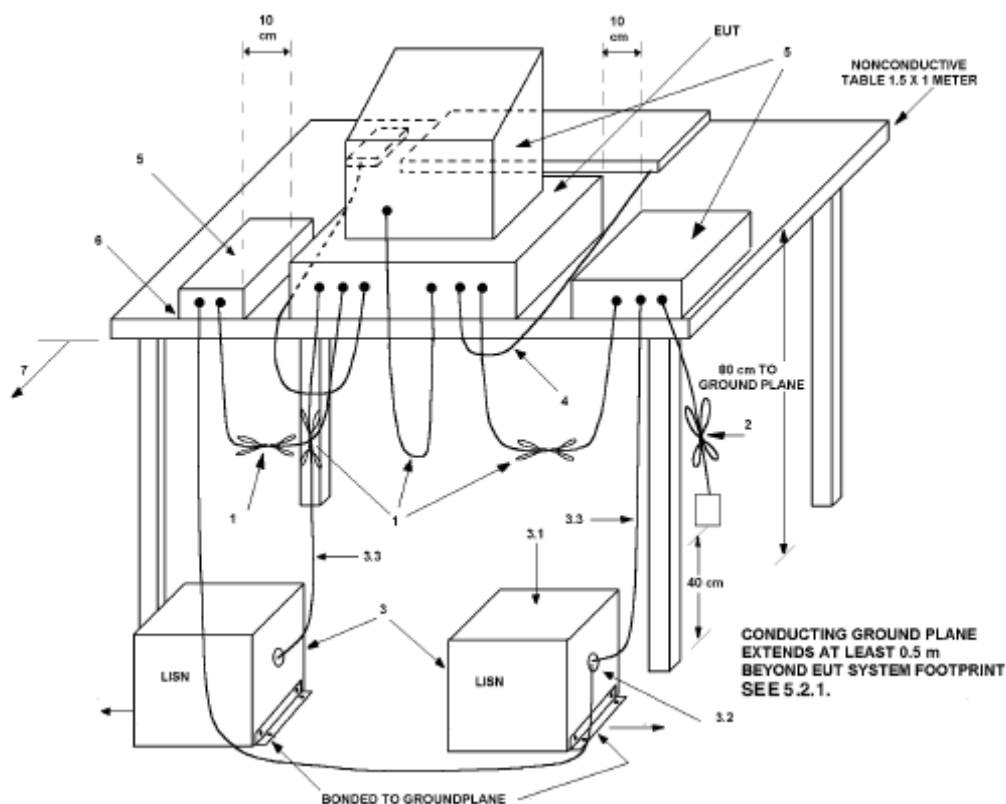

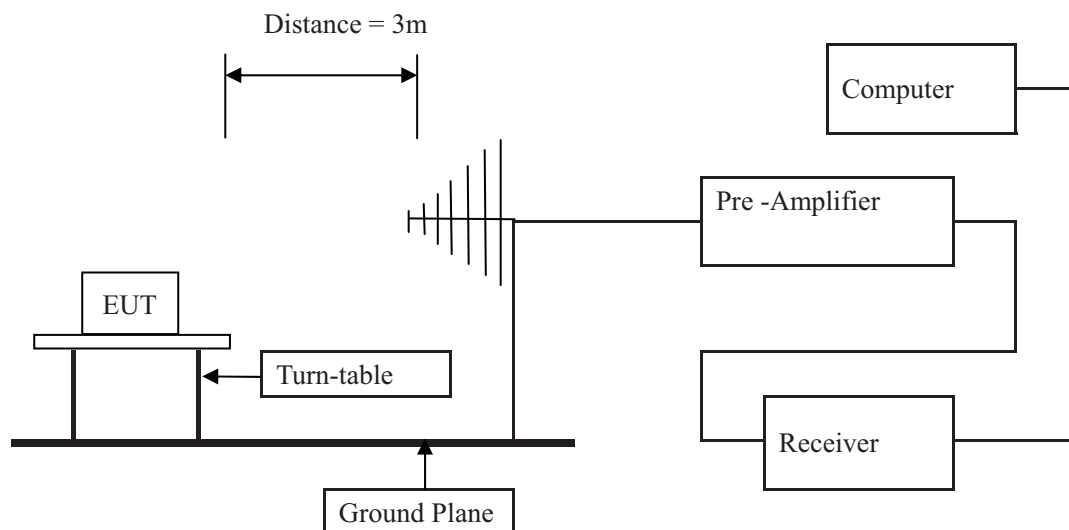

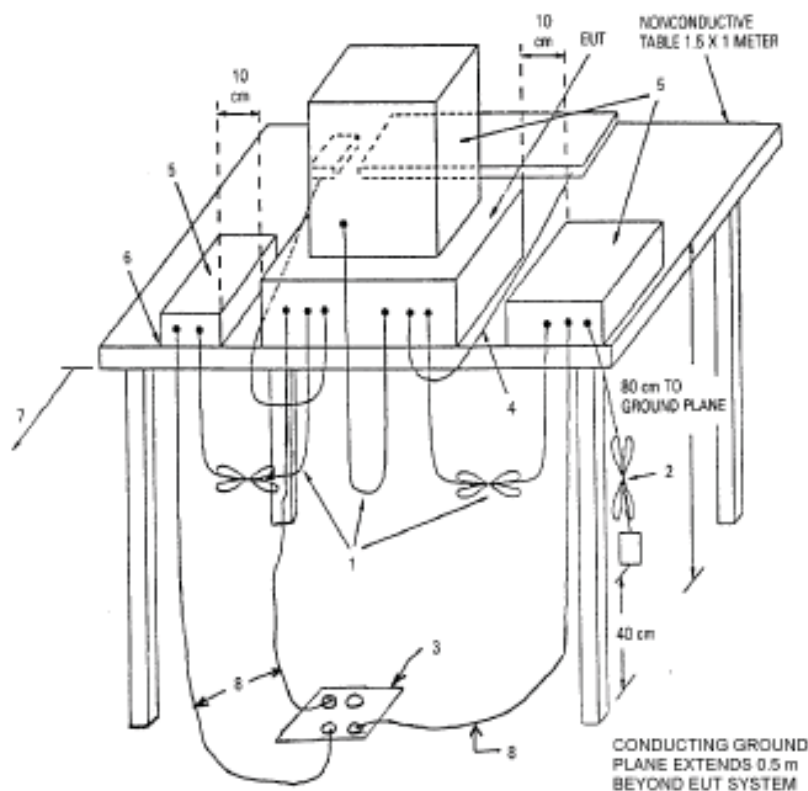
#### Block diagram of Test setup

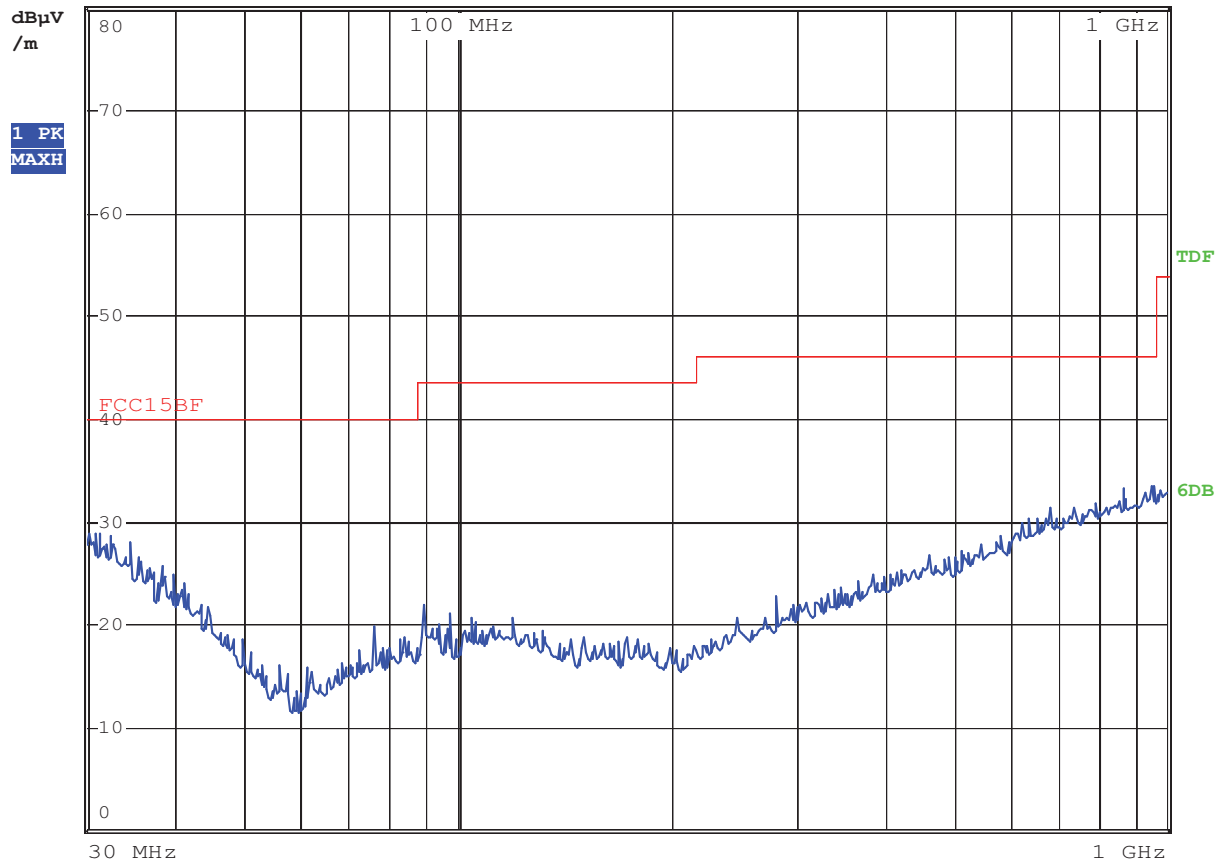

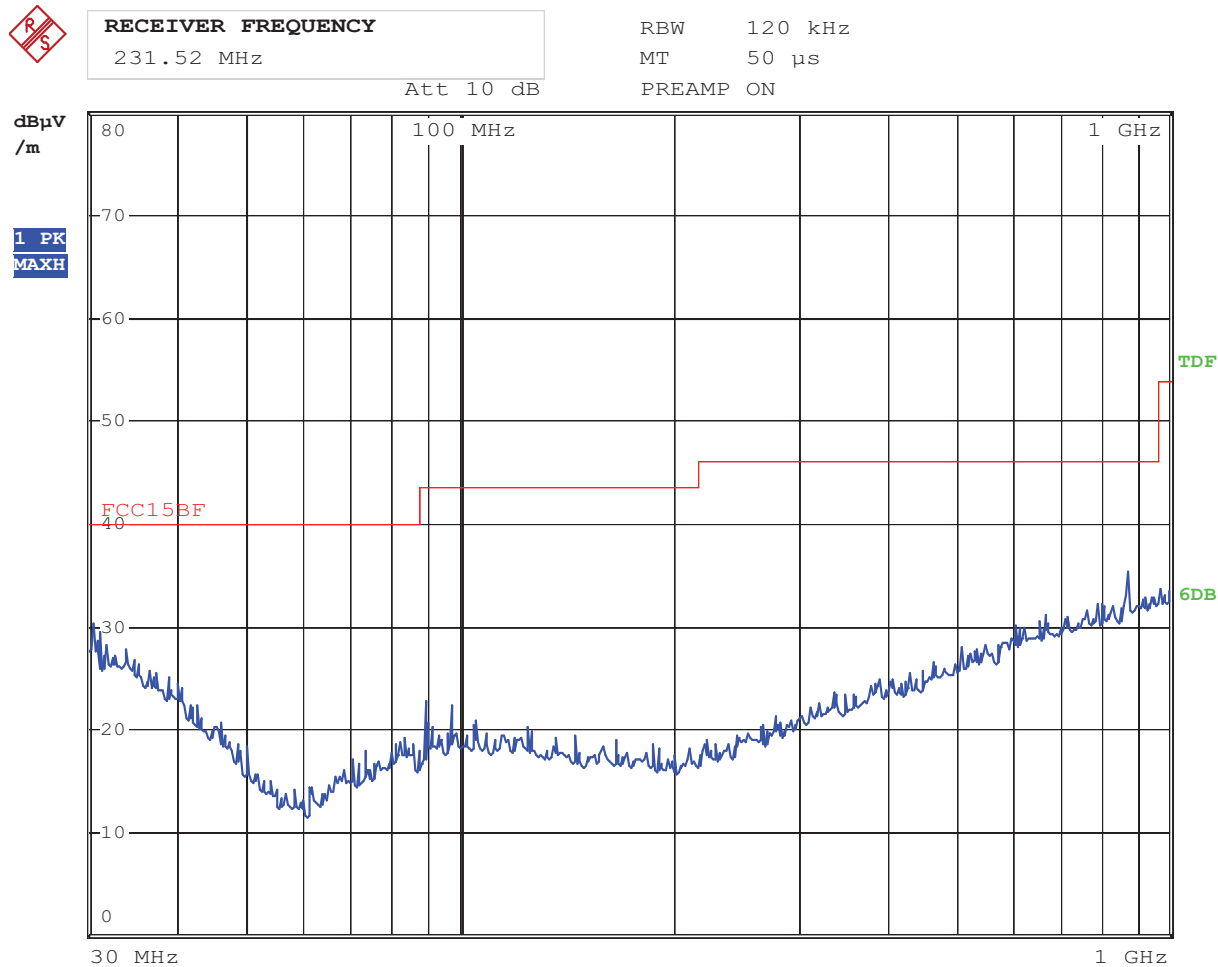


**B Radiated Emission In Vertical (30MHz----1000MHz)**
