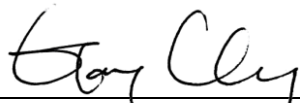

## 1 MPE EVALUATION OF MOBILE DEVICES

Human exposure to RF emissions from mobile devices (47 CFR §2.1091) may be evaluated based on the MPE limits adopted by the FCC for electric and magnetic field strength and/or power density, as appropriate, since exposures are assumed to occur at distances of 20 cm or more from persons.

### 1.1 LIMITS FOR GENERAL POPULATION/UNCONTROLLED EXPOSURE

Frequency Range (MHz)	Power Density (mW /cm <sup>2</sup> )	Averaging Time (minutes)
300~1500	F/1500	30
1500~100000	1.0	30

### 1.2 MPE EVALUATION FORMULA

$$Pd = \frac{Pt}{4 * \pi * R^2}$$

Where

Pd= Power density in mW/cm<sup>2</sup>

Pt= EIRP in mW

π= 3.1416

R= Measurement distance

### 1.3 MPE EVALUATION RESULTS

Frequency Range (MHz)	Maximum Conducted Power (dBm)	Antenna Gain (dBi)	Distance (cm)	Power Density (mW/cm <sup>2</sup> )	Limit (mW/cm <sup>2</sup> )
2412~2462	26.64	4	20	0.231	1
5180~5240	27.48	4	20	0.280	1
5745~5825	26.81	4	20	0.240	1

#### CONCLUSION:

Both of the WLAN 2.4G & 5.0G can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 + .....etc. < 1

CPD = Calculation power density

LPD = Limit of power density

1. WLAN 2.4G + WLAN 5.0G = 0.231+0.280=0.511

Therefore, the maximum calculation of this situation is 0.511, which is less than the “1” limit.
