



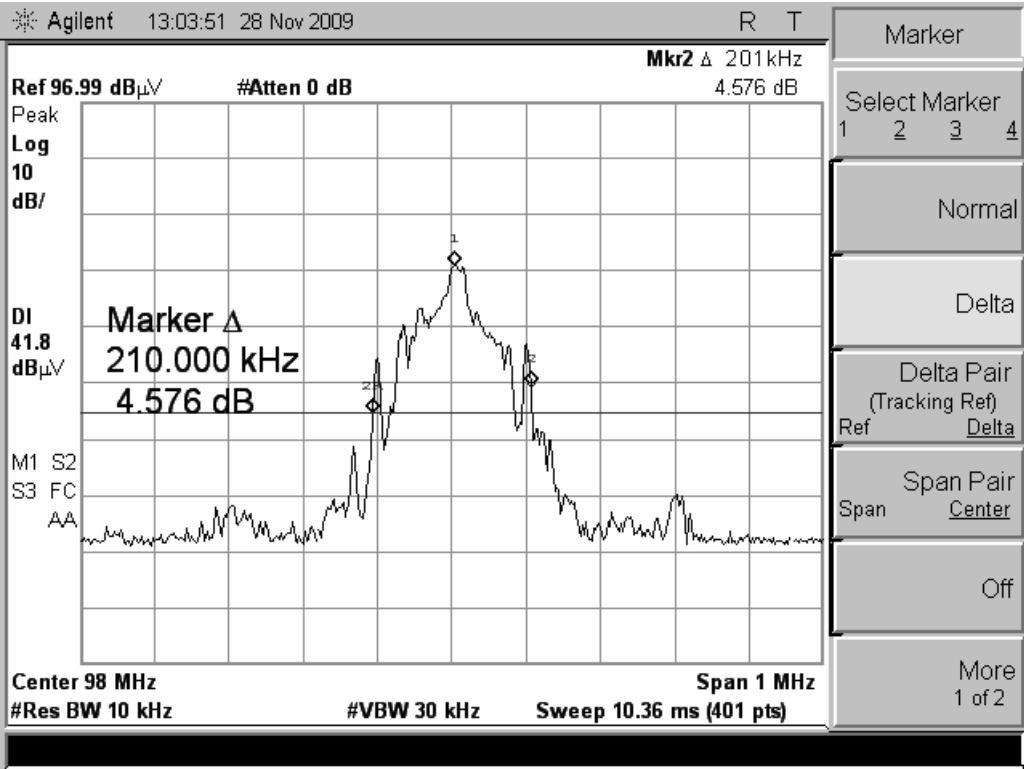

## **5.2 Frequency Range**

### **5.2.1 Definition**

Emissions from the intentional radiator shall be confined within a band 200 kHz wide centered on the operating frequency. The 200 kHz band shall lie wholly within the frequency range of 88-108 MHz.

### **5.2.2 Test Description**

The EUT was placed on a non-conductive table 0.8 meters above the floor. The table was rotated to an angle which presented the highest signal level. The occupied bandwidth was based on a 26 dB criteria (26 dB down either side of the emission from the peak emission). A drawing showing the test setup is given as Figure 1.

### **5.2.3 Test Result**

The operation frequency band is form 88.1 MHz to 107.9 MHz. This frequency range complies with the FCC requirement.

## 5.3 Radiated Emission

### 5.3.1 Definition

The field strength of any emission within this band (section 15.239, frequency between 88 MHz –108 MHz) shall not exceed 250 micro volts /meter at 3 meters. The emission limit in this paragraph is based on measurement instrumentation employing an average detector. The provisions in section 15.35 for limiting peak emissions apply.

1. The field strength of any emissions which appear outside of this band shall not exceed the general radiated emission limits in section 15.209(Intentional Radiators general limit), as below.

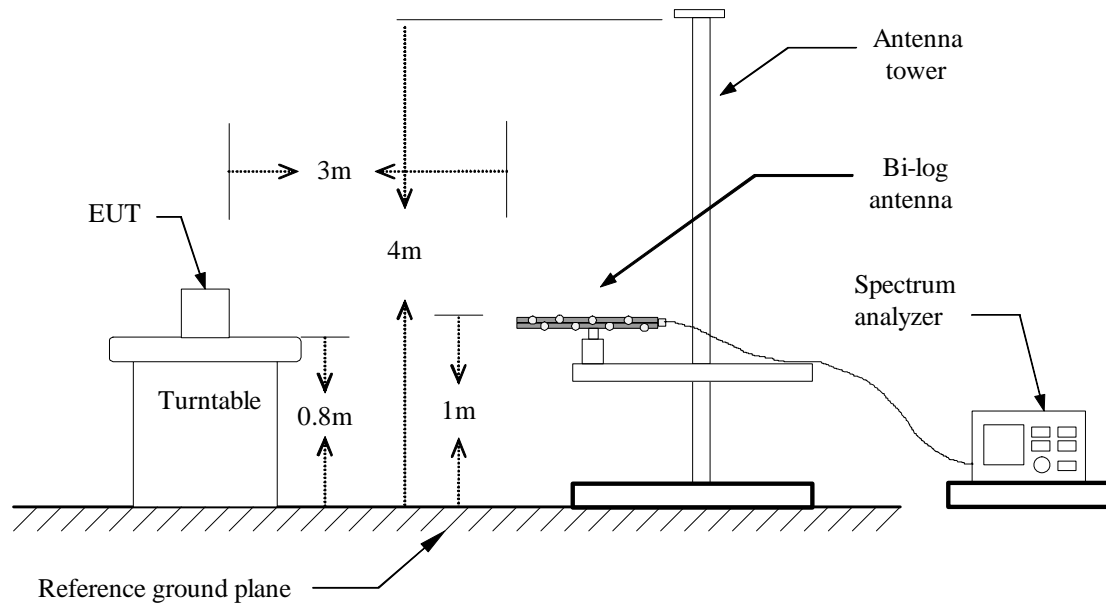

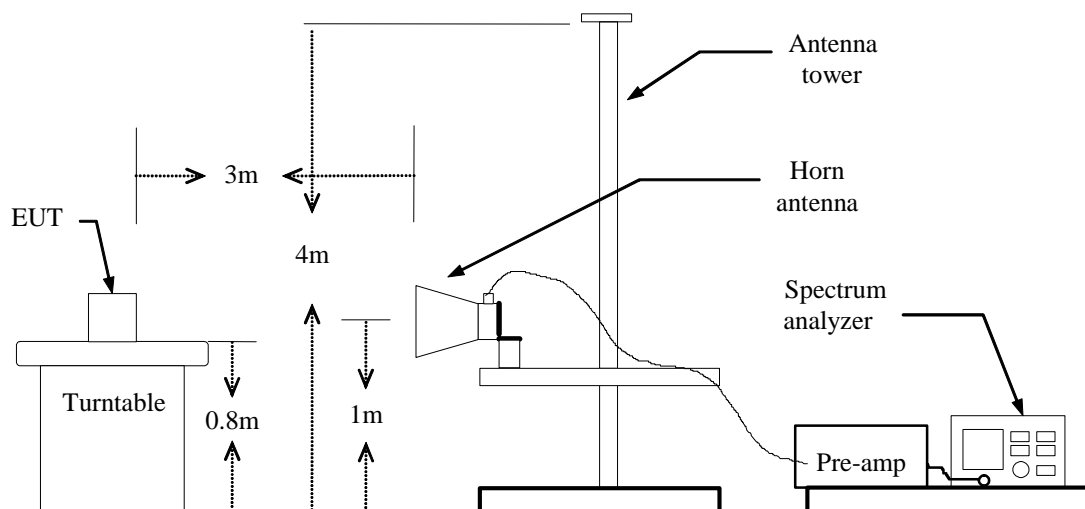

### 5.3.3 Test Description

1. The EUT is placed on a turntable, which is 0.8m above ground plane.
2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emissions.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Set the spectrum analyzer in the following setting as:  
 Below 1GHz: RBW=100 kHz / VBW=300 kHz / Sweep=AUTO  
 Above 1GHz : (a) PEAK: RBW=VBW=1MHz / Sweep=AUTO  
                  (b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO
7. Repeat above procedures until the measurements for all frequencies are complete.

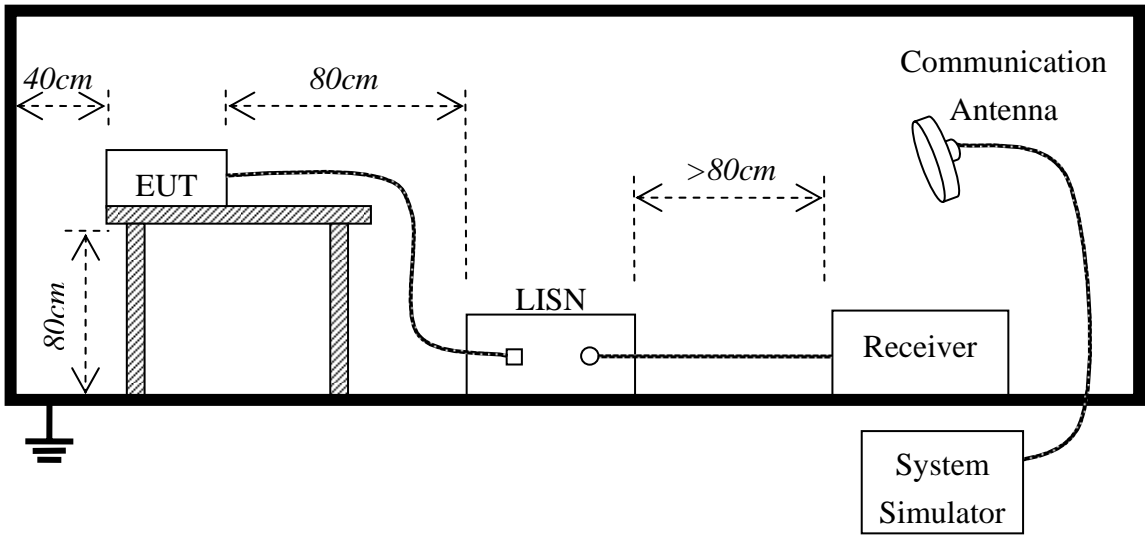

#### 5.4.2 Preliminary Procedure of Line Conducted Emission Test

- 1) The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. When the EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per FCC Part 15 (see Test Facility for the dimensions of the ground plane used). When the EUT is floor-standing equipment, it is placed on the ground plane which has a 3-12 mm non-conductive covering to insulate the EUT from the ground plane.
- 2) Support equipment, if needed, was placed as per FCC Part 15.
- 3) All I/O cables were positioned to simulate typical actual usage as per FCC Part 15.
- 4) The EUT received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5) All support equipments received power from a second LISN supplying power of AC 120V/60Hz, if any.
- 6) The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7) Analyzer / Receiver scanned from 150 kHz to 30 MHz for emissions in each of the test modes.
- 8) During the above scans, the emissions were maximized by cable manipulation.

Then, the EUT configuration and cable configuration of the above highest emission level were recorded for reference of final testing.

#### 5.4.3 Final Procedure of Line Conducted Emission Test

EUT and support equipment was set up on the test bench as per step 9 of the preliminary test.

A scan was taken on both power lines, Line 1 and Line 2, recording at least the six highest emissions. Emission frequency and amplitude were recorded into a computer in which correction factors were used to calculate the emission level and compare reading to the applicable limit. If EUT emission level was less -2dB to the A.V. limit in Peak mode, then the emission signal was re-checked using Q.P and Average detector.

The test data of the worst case condition(s) was reported on the Summary Data page.

## **5.5 Antenna Requirement**

### **5.5.1 Definition**

An analysis of the DM302 was performed to determine compliance with FCC Section 15.203. This section requires specific handling and control of antennas used for devices subject to regulations.

### **5.5.2 Evaluation Procedure**

The structure and application of the DM302 was analyzed with respect to the rules. The antenna is an internal antenna, and is not accessible to the user. An auxiliary antenna port is not present.

### **5.5.3 Evaluation Criteria**

Section 15.203 of the rules states that the subject device must meet at least one of the following criteria:

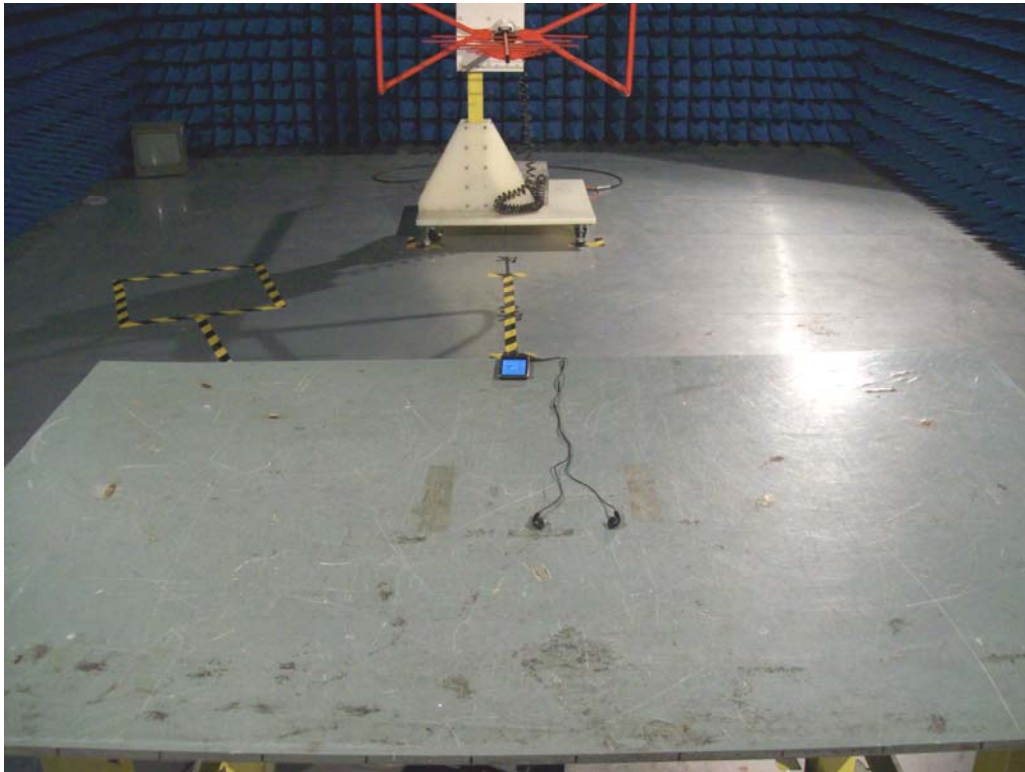
- (a) Antenna must be permanently attached to the unit.
- (b) Antenna must use a unique type of connector to attach to the EUT.
- (c) Unit must be professionally installed. Installer shall be responsible for verifying that the correct antenna is employed with the unit.

### **5.5.4 Evaluation Results**

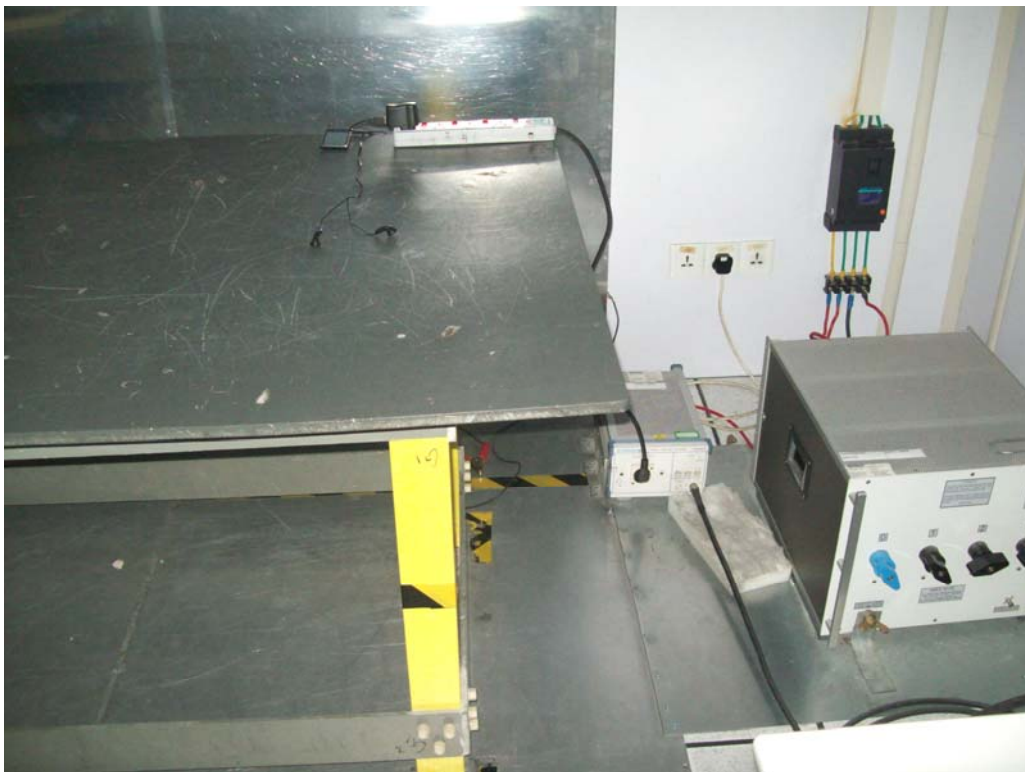
The DM302 meets the criteria of this rule by virtue of having an internal antenna inaccessible to the user. The EUT is therefore compliant.

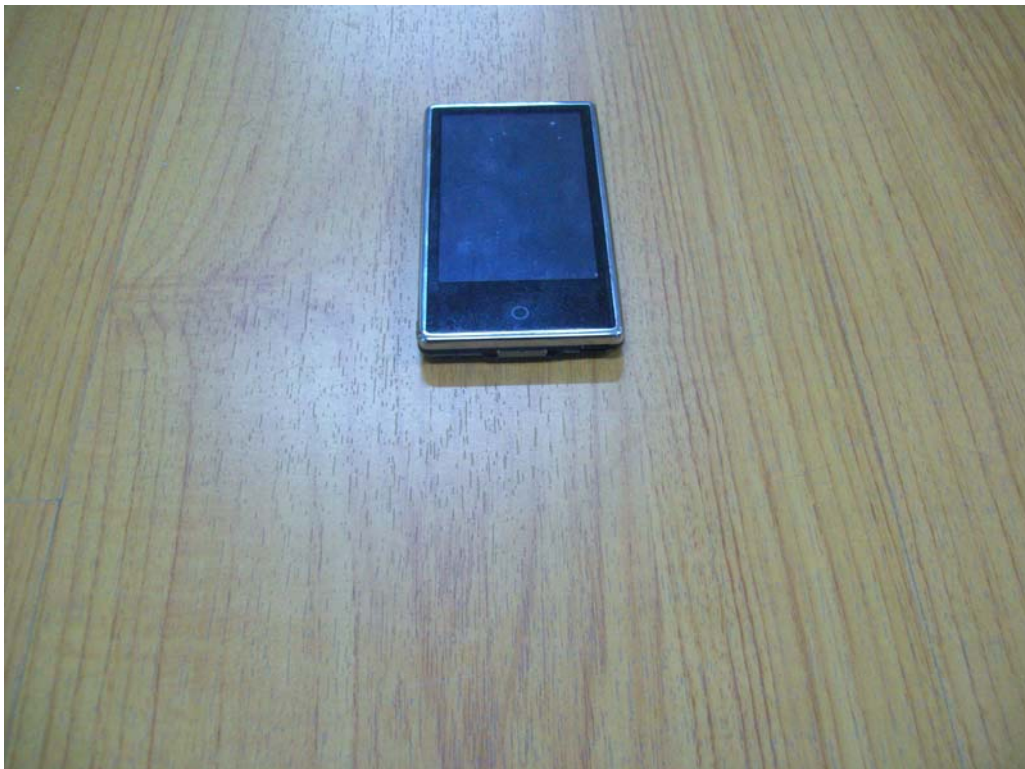

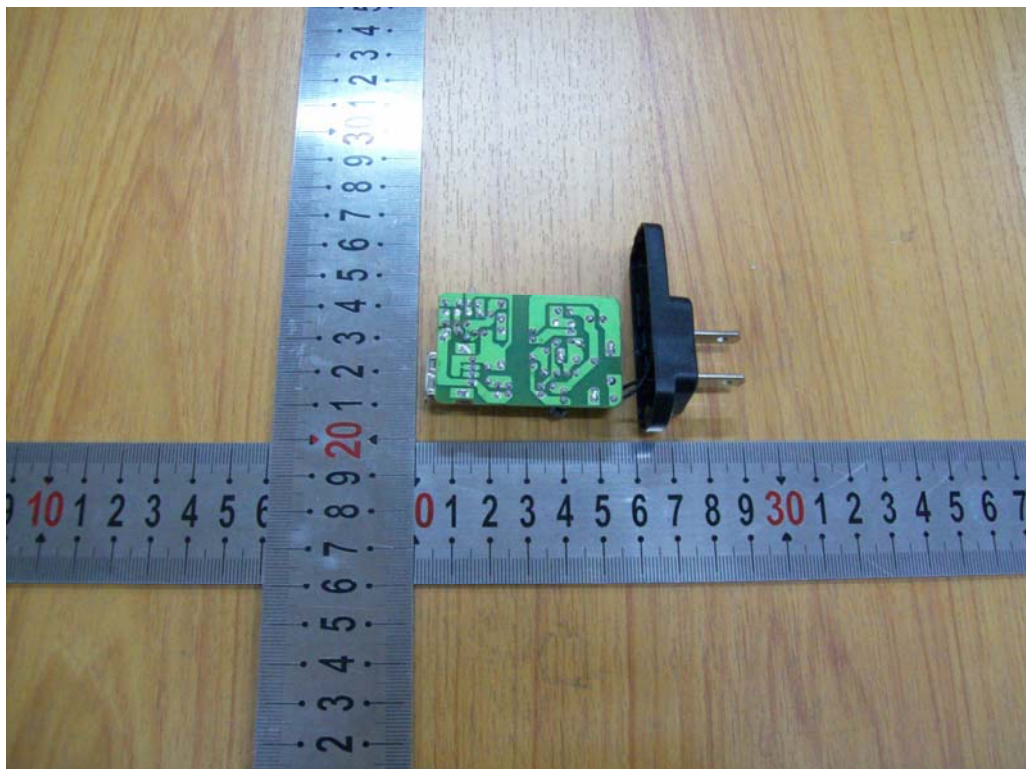

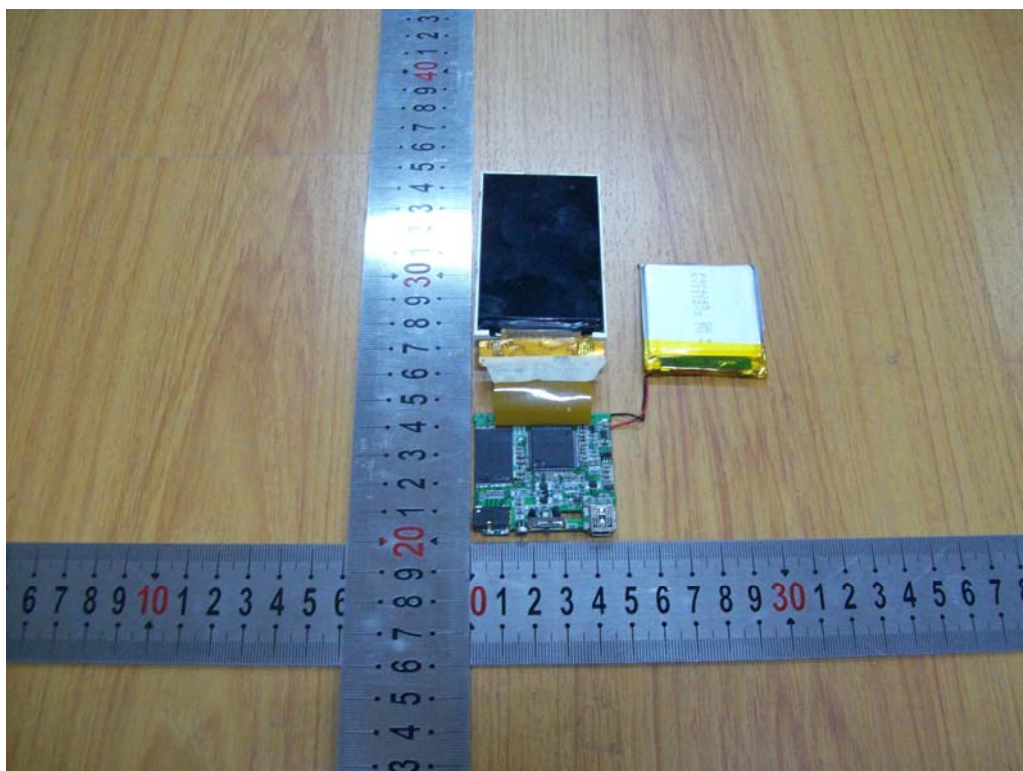
