The EUT is "Dazzle Mobile Phone" designed as a "Communication Device". It is designed by way of utilizing the FHSS technology to achieve the system operation.

### **2.3. RECEIVER INPUT BANDWIDTH**

The input bandwidth of the receiver is 1.0MHZ, In every connection one Bluetooth device is the master and the other one is slave. The master determines the hopping sequence. The slave follows this sequence. Both devices shift between RX and TX time slot according to the clock of the master. Additionally the type of connection(e.g. single or multislot packet) is set up at the beginning of the connection. The master adapts its hopping frequency and its TX/RX timing according to the packet type of the connection. Also the slave of the connection will use these settings.

Repeating of a packet has no influence on the hopping sequence. The hopping sequence generated by the master of the connection will be followed in any case. That means, a repeated packet will not be send on the same frequency, it is send on the next frequency of the hopping sequence.

### **2.5. EQUALLY AVERAGE USE OF FREQUENCIES AND BEHAVIOUR**

The generation of the hopping sequence in connection mode depends essentially on two input values:

1. LAP/UAP of the master of the connection.
2. Internal master clock

The LAP(lower address part) are the 24 LSB's of the 48 BD\_ADDRESS. The BD\_ADDRESS is an unambiguous number of every Bluetooth unit. The UAP(upper address part) are the 24MSB's of the 48BD\_ADDRESS

The internal clock of a Bluetooth unit is derived from a free running clock which is never adjusted and is never turned off. For behavior zation with other units only offset are used. It has no relation to the time of the day. Its resolution is at least half the RX/TX slot length of 312.5us. The clock has a cycle of about one day(23h30). In most case it is implemented as 28 bit counter. For the deriving of the hopping sequence the entire. LAP(24 bits),4LSB's(4bits)(Input 1) and the 27MSB's of the clock(Input 2) are used. With this input values different mathematical procedures(permuations, additions, XOR-operations)are performed to generate te Sequence. This will be done at the beginning of every new transmission.

Regarding short transmissions the Bluetooth system has the following behavior:

The first connection between the two devices is established, a hopping sequence was generated. For Transmitting the wanted data the complete hopping sequence was not used. The connection ended.

The second connection will be established. A new hopping sequence is generated. Due to the fact the Bluetooth clock has a different value, because the period between the two transmission is longer(and it Cannot be shorter) than the minimum resolution of the clock(312.5us). The hopping sequence will always Differ from the first one.



## 7. PEAK OUTPUT POWER

### 7.1. MEASUREMENT PROCEDURE

For peak power test:

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
3. Set the EUT Work on the top, middle and the bottom operation frequency individually.
4. Set the RBW greater than 6DB bandwidth of emission.
5. Record the maximum power from the Spectrum Analyzer.


For average power test:

1. The EUT was placed on a table which is 0.8m above ground plane.
2. Connect EUT RF output port to power probe through an RF attenuator.
3. Connect the power probe to the PC.
4. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
5. Record the maximum power from the software.
6. The maximum peak power shall be less 1 Watt (30dBm).





2. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
3. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
4. Set Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel  
RBW  $\geq$  1% of the 20 dB bandwidth, VBW  $\geq$  RBW; Sweep = auto; Detector function = peak
5. Set SPA Trace 1 Max hold, then View.




TEST PLOT OF BANDWIDTH FOR LOW CHANNEL

## 9. CONDUCTED SPURIOUS EMISSION

### 9.1. MEASUREMENT PROCEDURE

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
3. Set the EUT Work on the top, the Middle and the bottom operation frequency individually.
4. Set the Span = wide enough to capture the peak level of the in-band emission and all spurious emissions from the lowest frequency generated in the EUT up through the 10th harmonic.  
RBW = 100 kHz; VBW  $\geq$  RBW; Sweep = auto; Detector function = peak.
5. Set SPA Trace 1 Max hold, then View.



TEST PLOT OF OUT OF BAND EMISSIONS WITH THE WORST CASE

## 10. RADIATED EMISSION

### 10.1. MEASUREMENT PROCEDURE

1. Configure the EUT according to ANSI C63.4. The EUT was placed on the top of the turntable 0.8 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emissions, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz VBW and RBW for peak reading. Then 1MHz RBW and 10Hz VBW for average reading in spectrum analyzer.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum values.
8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High - Low scan is not required in this case.






### RADIATED EMISSION TEST SETUP BELOW 30MHz

### RADIATED EMISSION TEST SETUP ABOVE 1000MHz





## RADIATED EMISSION BELOW 1GHZ-Vertical



RADIATED EMISSION ABOVE 1GHZ (1-10<sup>th</sup> Harmonics) –Horizontal










TEST PLOT OF LOW CHANNEL



### **15.3. PRELIMINARY PROCEDURE OF LINE CONDUCTED EMISSION TEST**

1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. When the EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.4 (see Test Facility for the dimensions of the ground plane used). When the EUT is a floor-standing equipment, it is placed on the ground plane which has a 3-12 mm non-conductive covering to insulate the EUT from the ground plane.
2. Support equipment, if needed, was placed as per ANSI C63.4.
3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.4.
4. All support equipments received AC120V/60Hz power from a LISN, if any.
5. The EUT received power by adapter which received 120V/60Hzpower by a LISN..
6. The test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
7. Analyzer / Receiver scanned from 150 kHz to 30MHz for emissions in each of the test modes.
8. During the above scans, the emissions were maximized by cable manipulation.
9. The test mode(s) were scanned during the preliminary test.


Then, the EUT configuration and cable configuration of the above highest emission level were recorded for reference of final testing.

### **15.4. FINAL PROCEDURE OF LINE CONDUCTED EMISSION TEST**

1. EUT and support equipment was set up on the test bench as per step 2 of the preliminary test.
2. A scan was taken on both power lines, Line 1 and Line 2, recording at least the six highest emissions. Emission frequency and amplitude were recorded into a computer in which correction factors were used to calculate the emission level and compare reading to the applicable limit. If EUT emission level was less -2dB to the A.V. limit in Peak mode, then the emission signal was re-checked using Q.P and Average detector.
3. The test data of the worst case condition(s) was reported on the Summary Data page.


