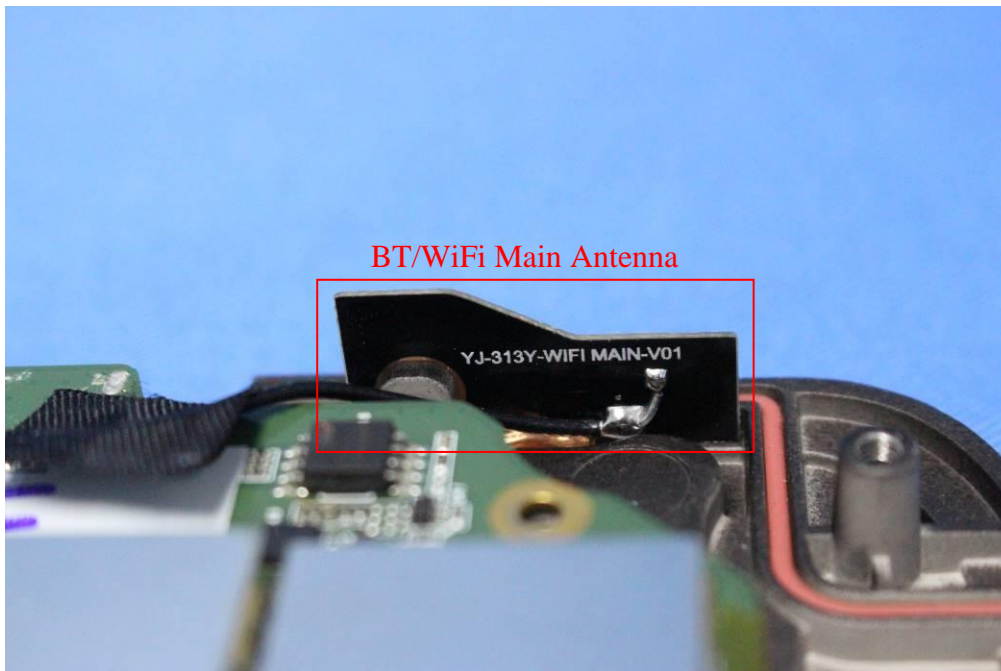

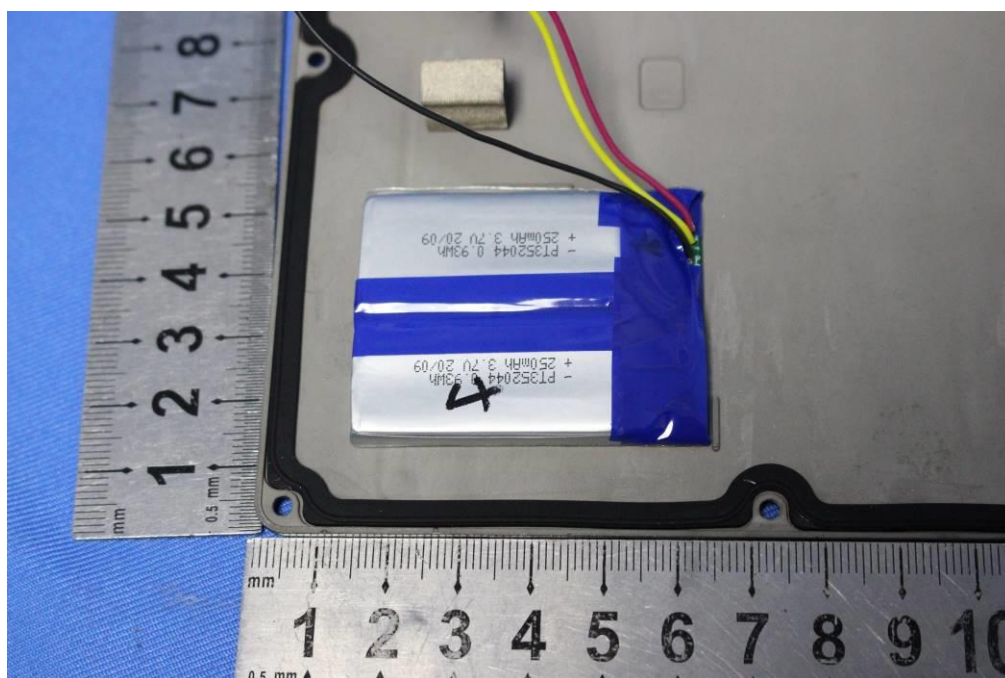

LTE Main/Sensor Antenna





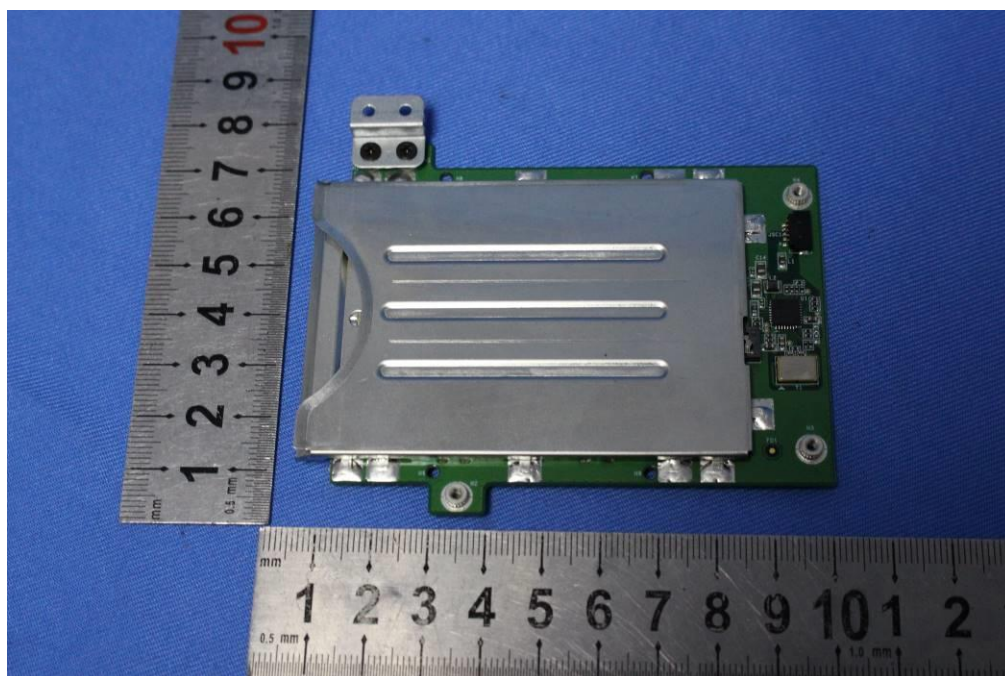
