## Limited Warranty

### Hardware Warranty Coverage

Looxcie, Inc. (1196 Borregas Ave, Suite 200, Sunnyvale, CA 94089), warrants the Looxcie video device ("Product") to be free of material defects (subject to the terms set forth below) for a period of one (1) year from the date of purchase ("Warranty Period"). This Warranty specifically excludes any Looxcie software applications which are subject to separate End User License Agreements and any software embodied in the hardware. During the Warranty Period, Looxcie will repair or replace (at Looxcie's discretion) this Product or any defective parts ("Warranty Service") at no charge (other than applicable incidental charges). Replacement Product may be new or refurbished/recertified at Looxcie's discretion. If repair or replacement is not commercially practical or cannot be timely made, Looxcie may choose to refund the purchase price paid for the affected Product. Call Looxcie support at 1-855-LOOXCIE (566-9243) for instructions regarding obtaining Warranty Service.

If Looxcie provides service under Warranty, the terms of the Warranty and applicable provisions of law will cover defects in materials and workmanship that arise during the remaining Warranty or 90 days after service, whichever provides longer coverage. If service is provided outside of Warranty, Looxcie warrants that the replacement will be free from defects in materials and workmanship for 90 days from the replacement ship date.

This Warranty is only valid for the original purchaser with the original purchase receipt and will automatically terminate prior to expiration if this Product is sold or otherwise transferred to another party.





The Warranty provided by Looxcie in this statement applies only to Products purchased for use, and not for resale. It does not apply to open box purchases, which are sold “as is” and without any Warranty. Specifically exempt from Warranty are limited-life consumable components subject to normal wear and tear, such as earbuds, batteries, and other accessories.

### General Use and Care

Use Looxcie indoors or in dry conditions outdoors. Do not place heavy objects on Looxcie or attempt to modify or service Looxcie. Use only accessories approved by Looxcie. Using any accessories not approved by Looxcie may invalidate your Warranty, might result in damage to Looxcie, and may be dangerous. Use of unauthorized accessories also limits any liability on the part of Looxcie. Do not use liquid cleaners or aerosol cleaners, as they may cause damage. Use a dry cloth to clean the external parts of Looxcie.

Do not use Looxcie on aircraft or where it might interfere with medical devices.







## Children

## Electrical Safety
