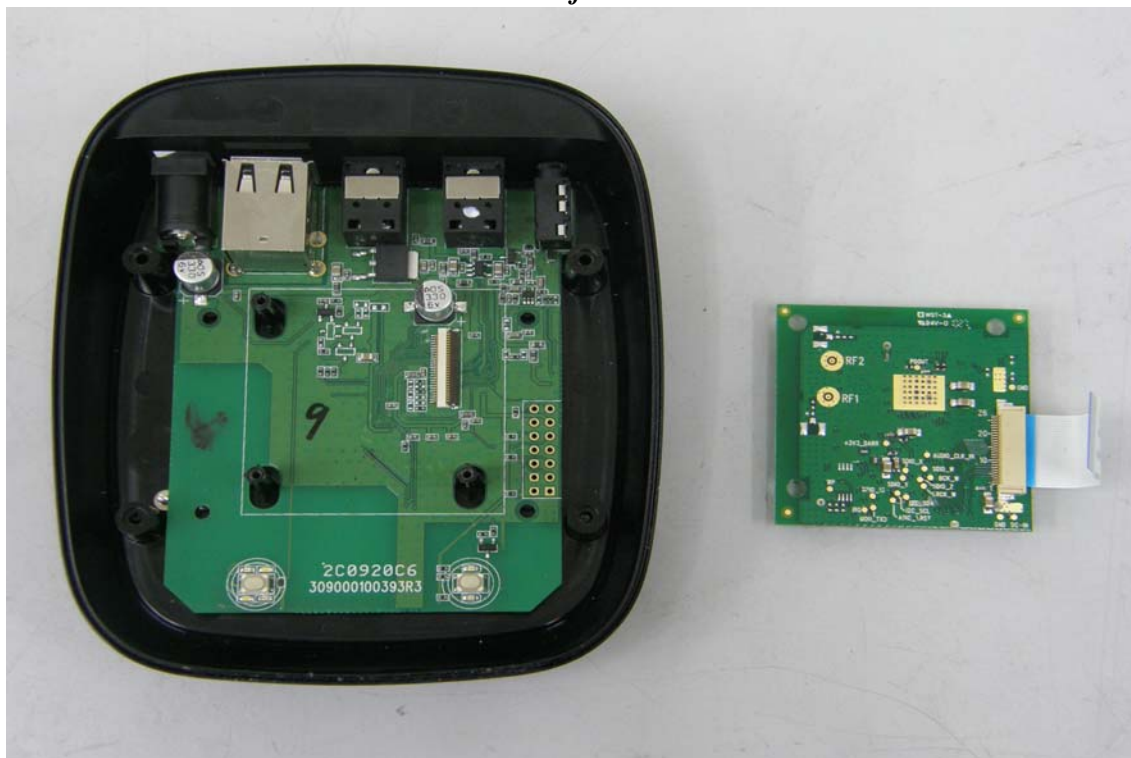

Open view of EUT – 1

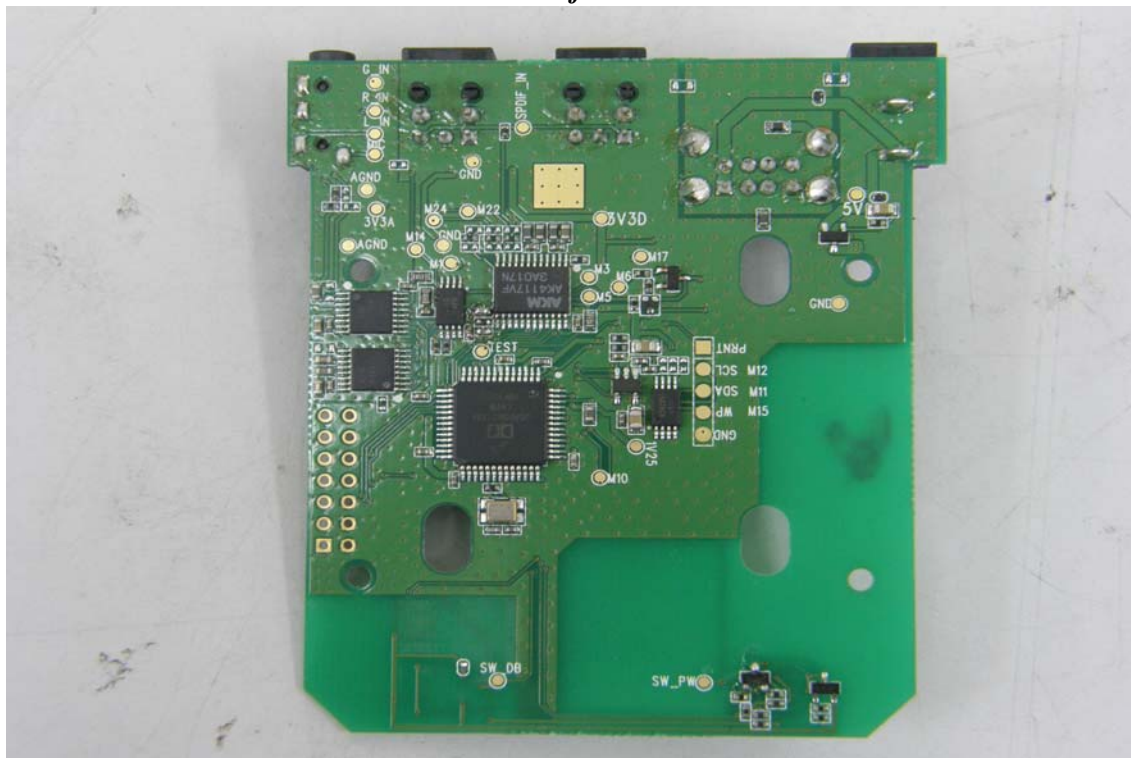

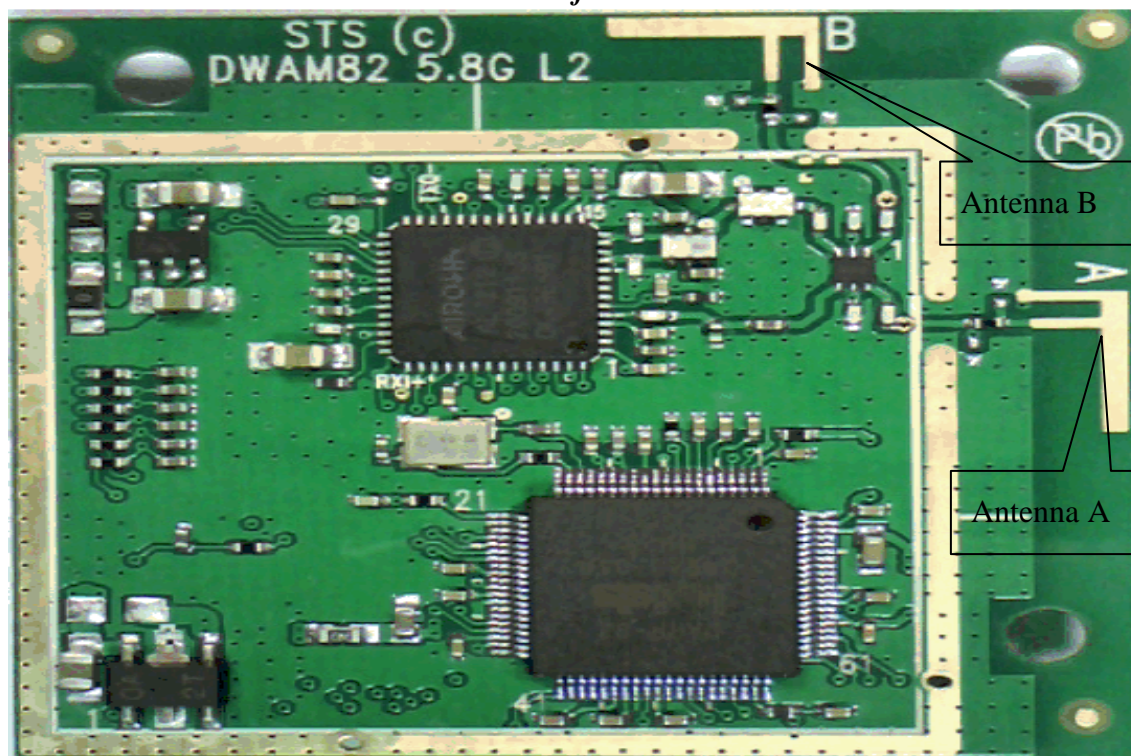

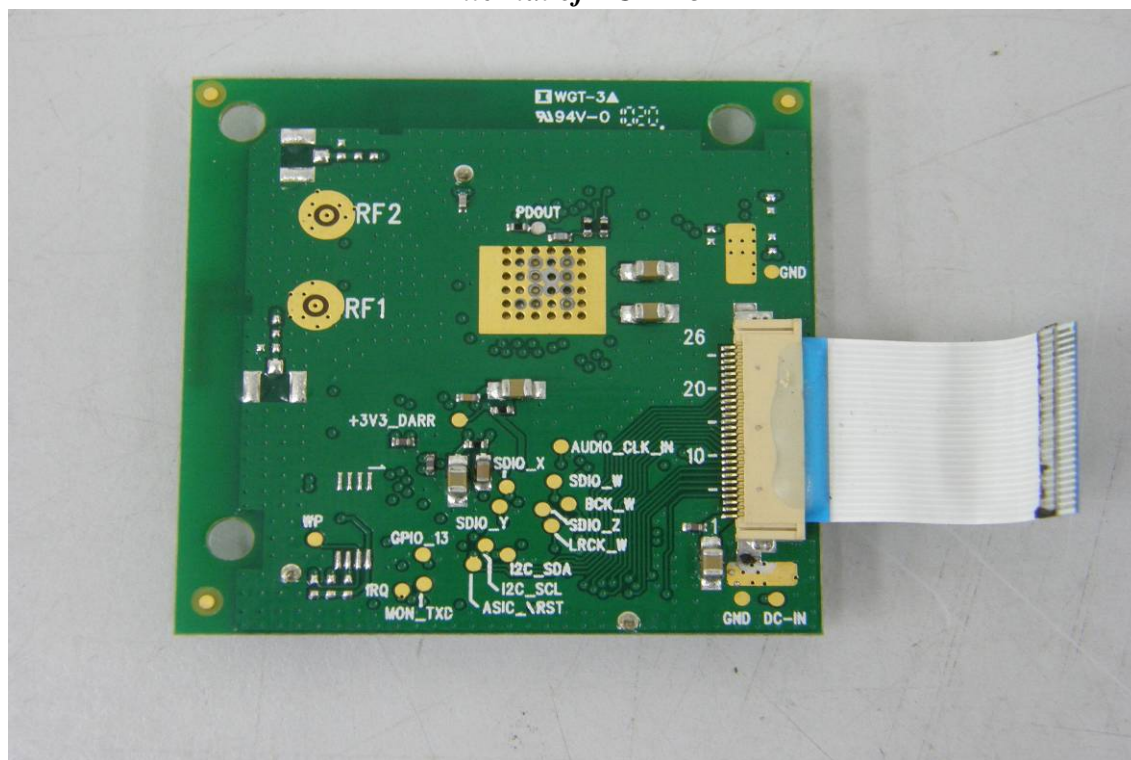
