## Installation

- Open the battery compartment and insert 1xAAA batteries, ensuring polarity is correct.
- Close battery compartment;
- Take out the USB receiver
- Plug in USB receiver;
- Wireless mouse is ready to work

If the above steps do not work properly, please remove USB receiver and repeat these steps.

## Wireless performance

- Reduced wireless performance can be caused by:
  - Metal objects close to or between the adapter and the other device.
  - Low batteries
  - Other wireless devices close by.

The reception is reduced when the signal has to pass through concrete walls and floors.

- Solution
  - Use an extension cable so that the adapter can be moved to a better position.
  - Replace the batteries.
  - Select a different channel or remove other wireless devices.

## Energy

- For the best performance, use rechargeable AAA NiMH batteries.
- Observe local regulations when disposing of batteries.

- The USB receiver is supplied from an identified USB2.0 port of computer.

## Wireless

- There are an increasing number of wireless products (video, audio, computer, etc.) which work in the same frequency range as this device. It may, therefore, be possible that the function of this product is limited by or is limiting for other wireless products. This can only be avoided by paying attention to the distance between products and, where possible, by changing channels.
- Be careful when using wireless devices if you have a pacemaker or are depended on other life-saving, sensitive electronic equipment, because this device transmits radio signals.
