1.5. Information about the FHSS characteristics:

1.5.1. Pseudorandom Frequency Hopping Sequence

The channel is represented by a pseudo-random hopping sequence hopping through the 79 RF channels. The hopping sequence is unique for the piconet and is determined by the Bluetooth device address of the master; the phase in the hopping sequence is determined by the Bluetooth clock of the master. The channel is divided into time slots where each slot corresponds to an RF hop frequency. Consecutive hops correspond to different RF hop frequencies. The nominal hop rate is 1 600 hops/s.

The channels of this system will be used equally over the long-term distribution of the hopsets.

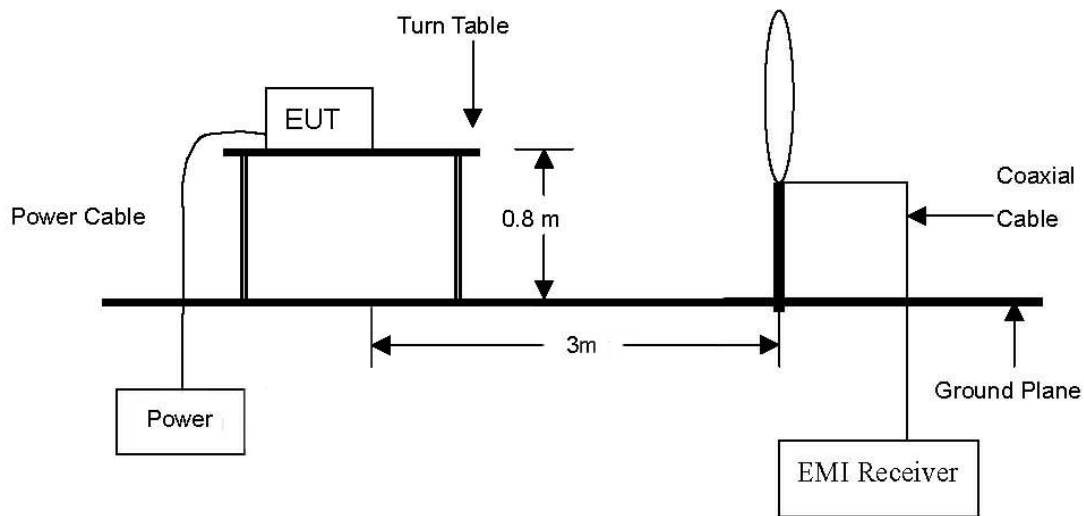

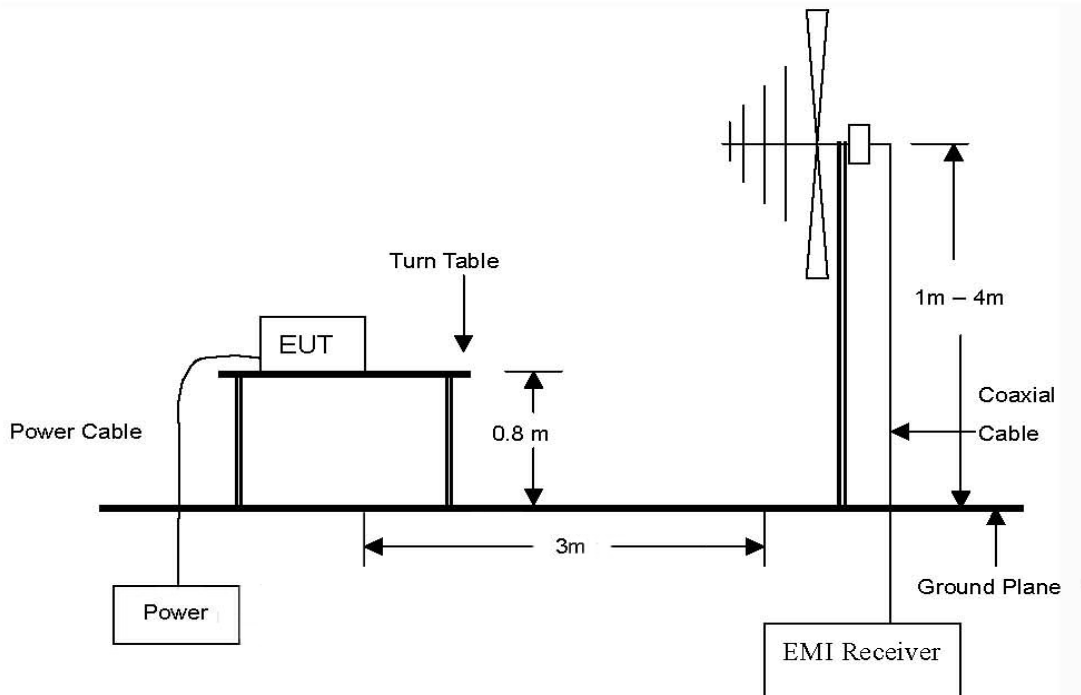

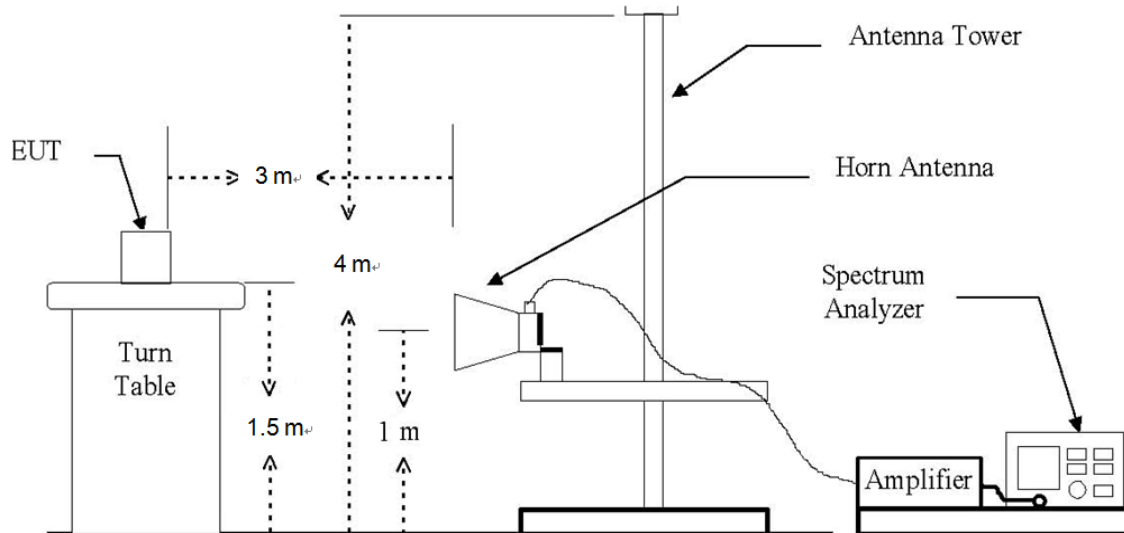

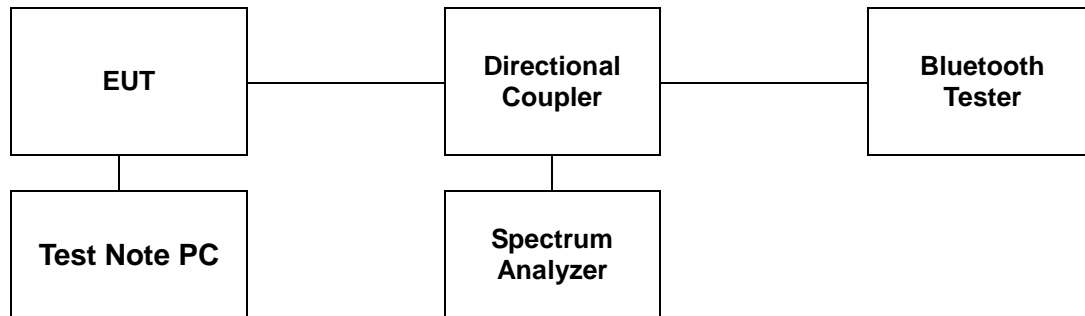

2.2. Limit

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in section §15.209(a) is not required. In addition, radiated emission which fall in the restricted band, as define in section §15.205(a), must also comply the radiated emission limits specified in section §15.209(a) (see section §15.205(c))

According to § 15.209(a), Except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table :

2.3. Test Procedures

Radiated emissions from the EUT were measured according to the dictates of DA 00-705 and ANSI C63.10-2009

Remark:

Testing for radiated emissions above 1GHz was performed with the EUT elevated at 1.5m instead of 0.8m. 1.5m is the required height in ANSI C63.10:2013 as referenced by RSS GEN issue 4. This test height has been permitted by FCC as discussed in FCC-TCB conference call in December 2014.

2.3.1. Test Procedures for Radiated Spurious Emissions

1. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site below 1 GHz and 1.5 meters above the ground at a 3 meter anechoic chamber test site above 1 GHz. The table was rotated 360 degrees to determine the position of the highest radiation.
2. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 3 meter away from the interference-receiving antenna.
3. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
5. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
6. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

NOTE;

All data rates and modes were investigated for radiated spurious emissions. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1 GHz.
2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection and frequency above 1 GHz.
3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is $1/T_{on}$ Hz (T_{on} = On-time of the Pulsed emission) for Average detection (AV) at frequency above 1 GHz.
 $VBW = 350 \text{ Hz} \geq 1/T_{on} \text{ Hz}$, pulse width in seconds ($T_{on} = 2.90 \text{ ms}$). Refer to the DH5, 3DH5 of Time of Occupancy (Dwell Time) test item.
4. When Average result is different from peak result over 20 dB (over-averaging), According to 15.35 (c), as a "duty cycle correction factor", pulse averaging with $20 \log(\text{duty cycle})$ has to be used.
5. To get a maximum emission level from the EUT, the EUT is manipulated through three orthogonal planes. Worst orthogonal plan of EUT is **Y – axis** during radiation test.

2.3.2. Test Procedures for Conducted Spurious Emissions

2.3.2.1. Band-edge Compliance of RF Conducted Emissions

§15.247(a)(1)(iii), Frequency hopping systems in the 2 400–2 483.5 MHz band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.

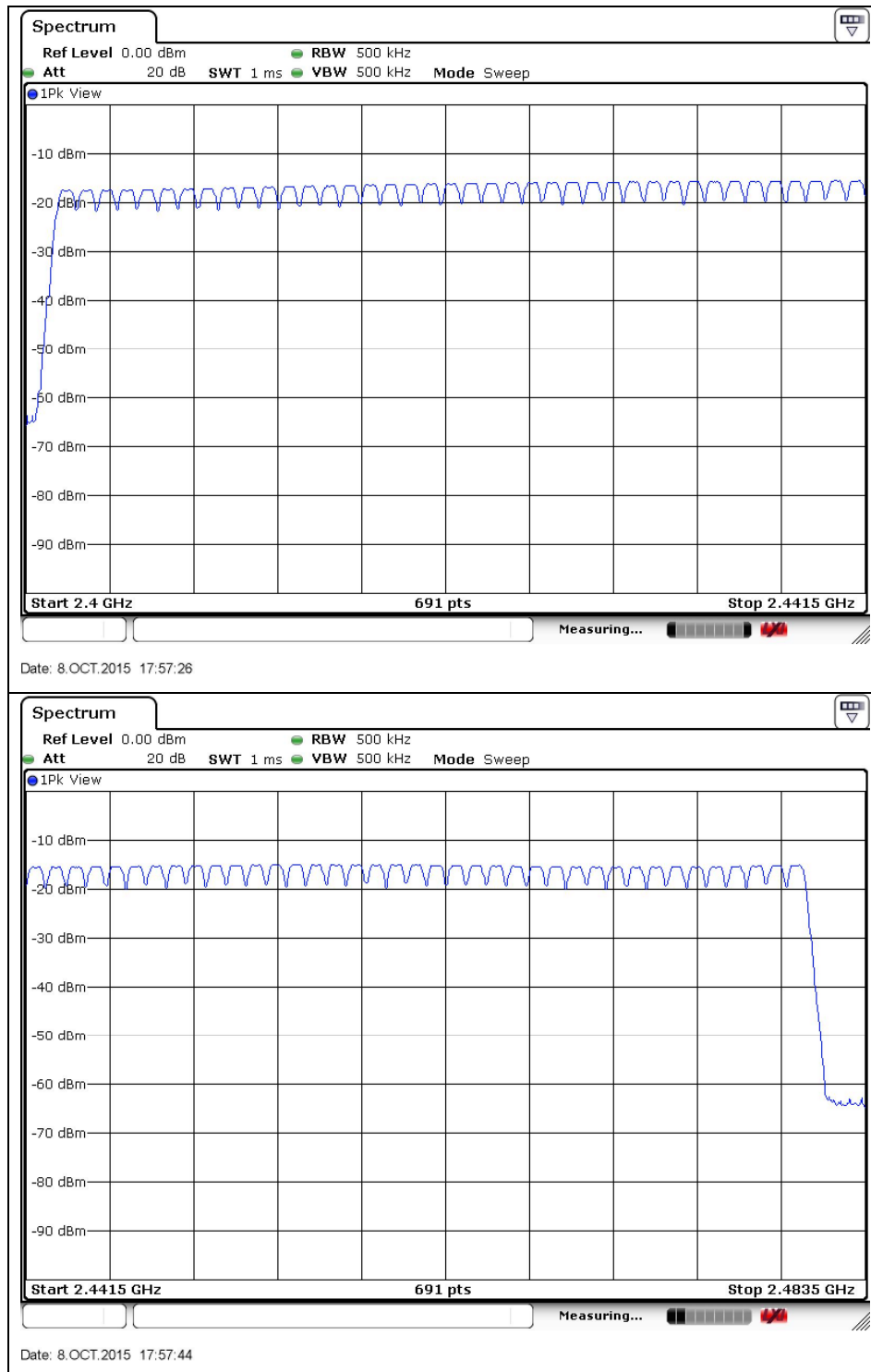

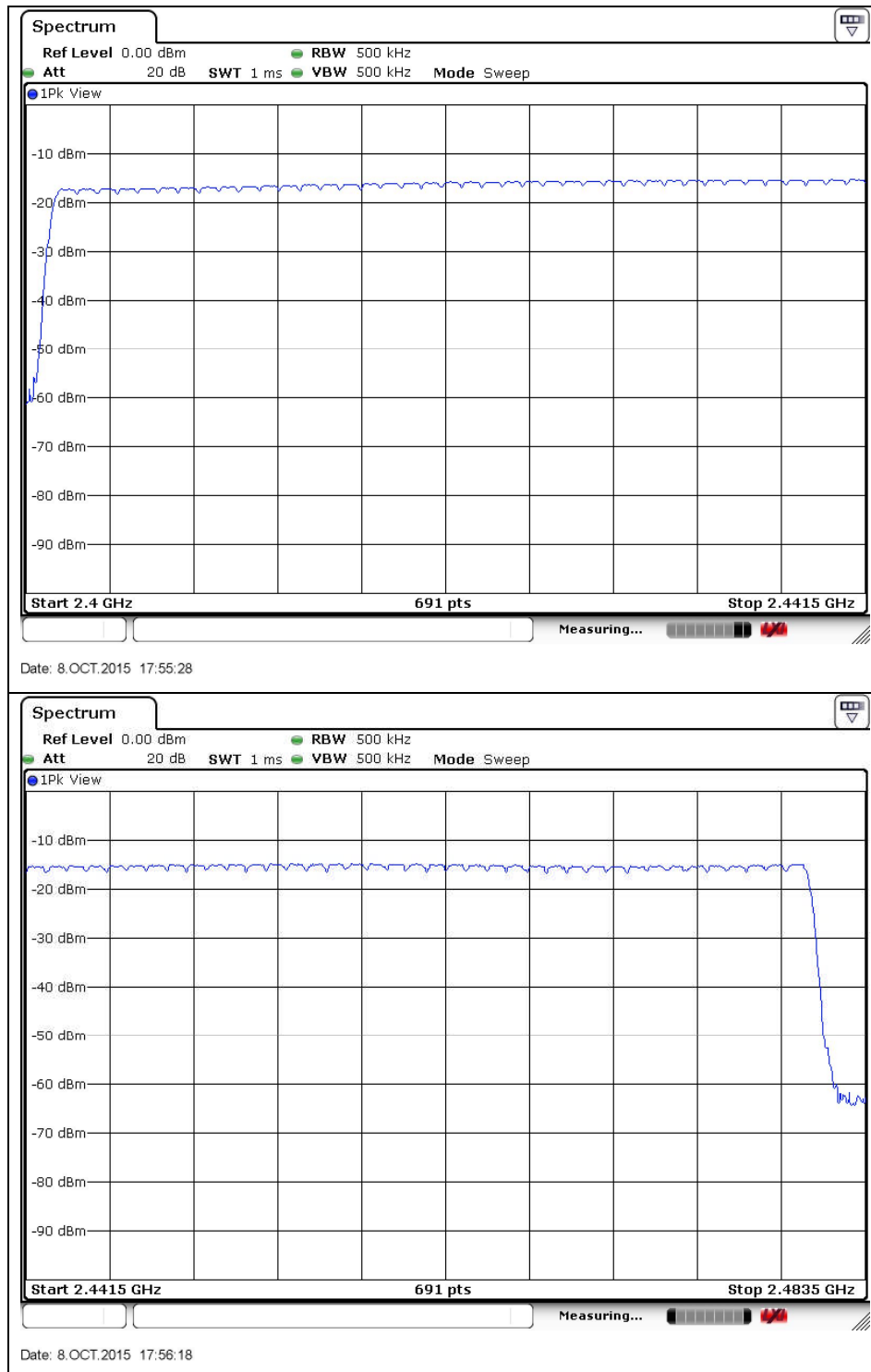

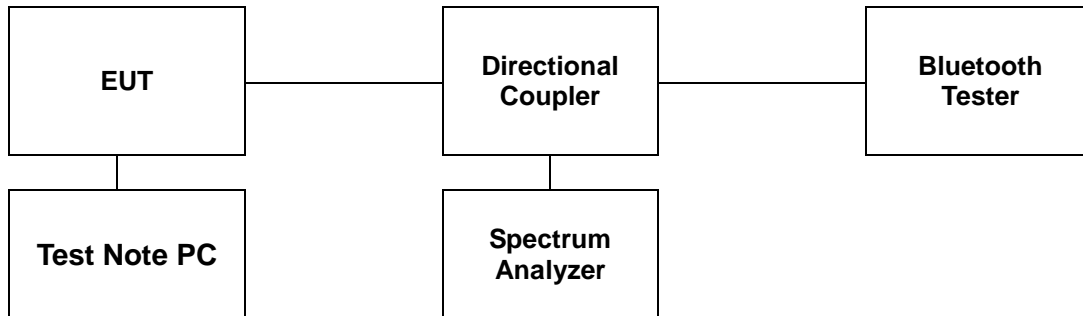

7.3. Test Procedure

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
