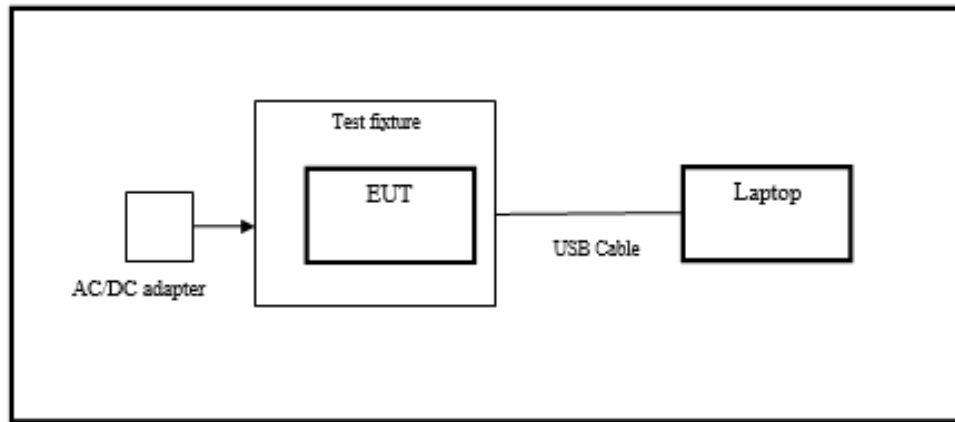

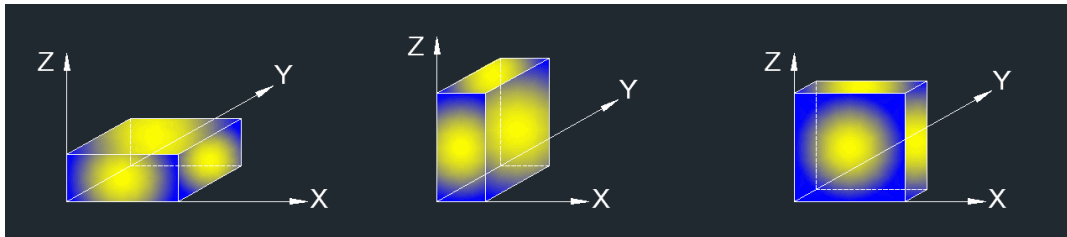

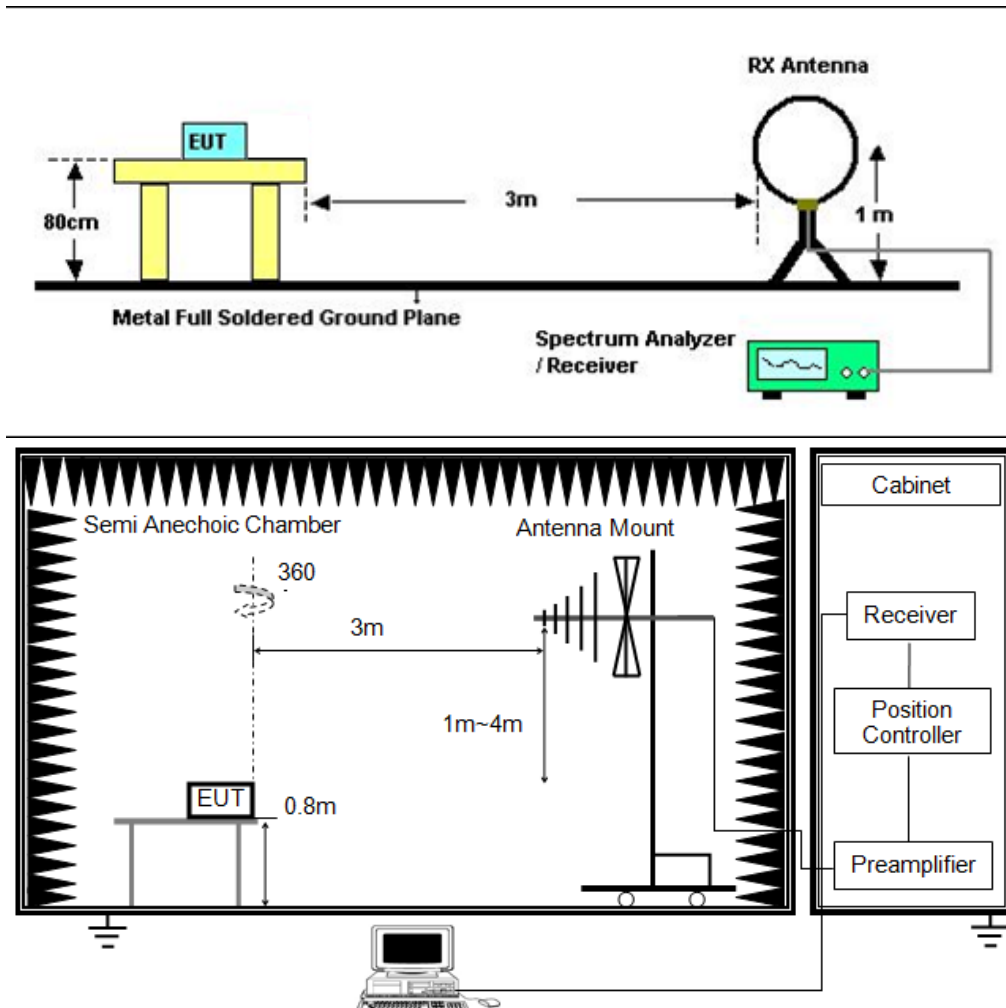

AC Power Line Conducted Emission



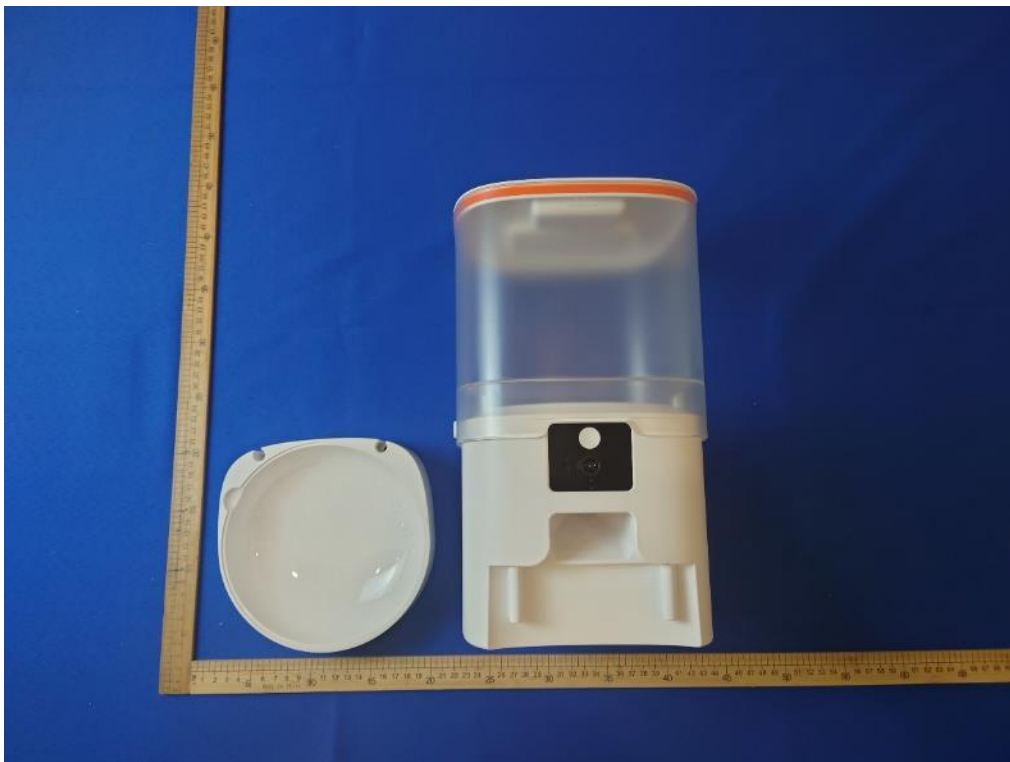
Radiated Band edge and Spurious Emission

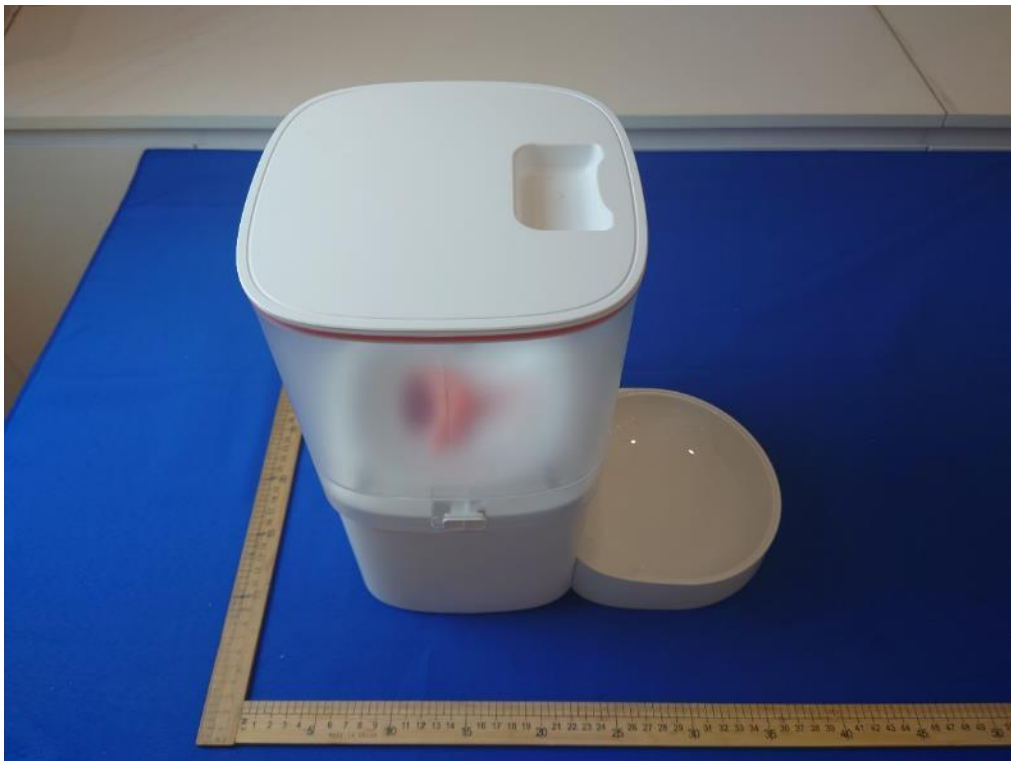


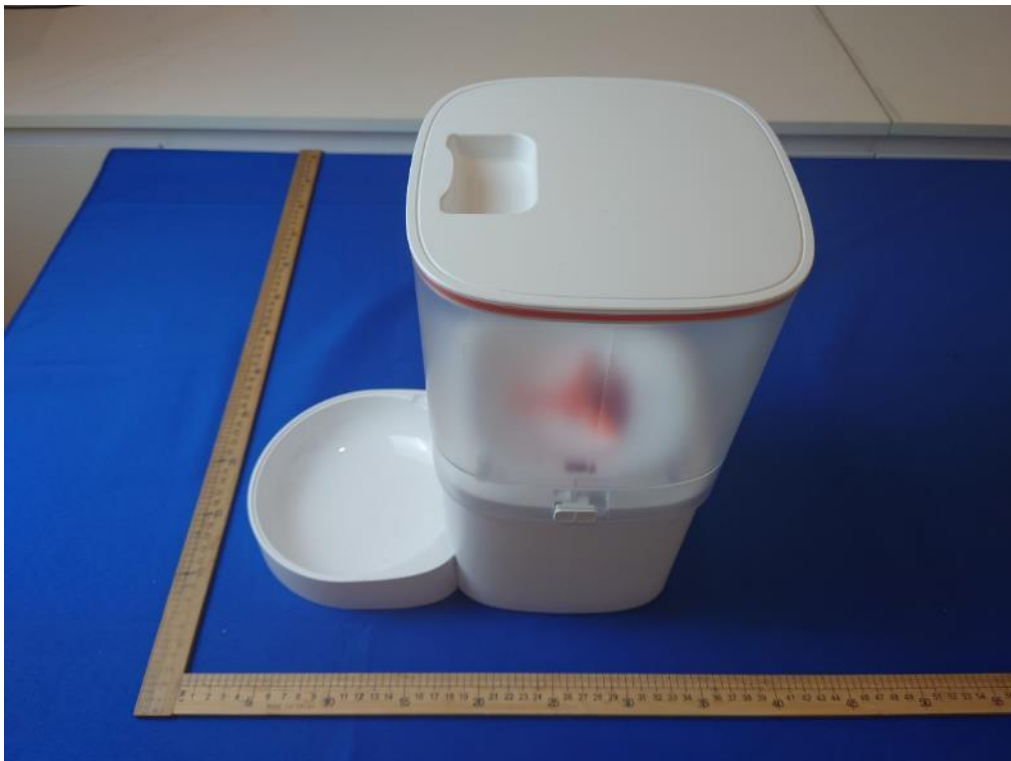
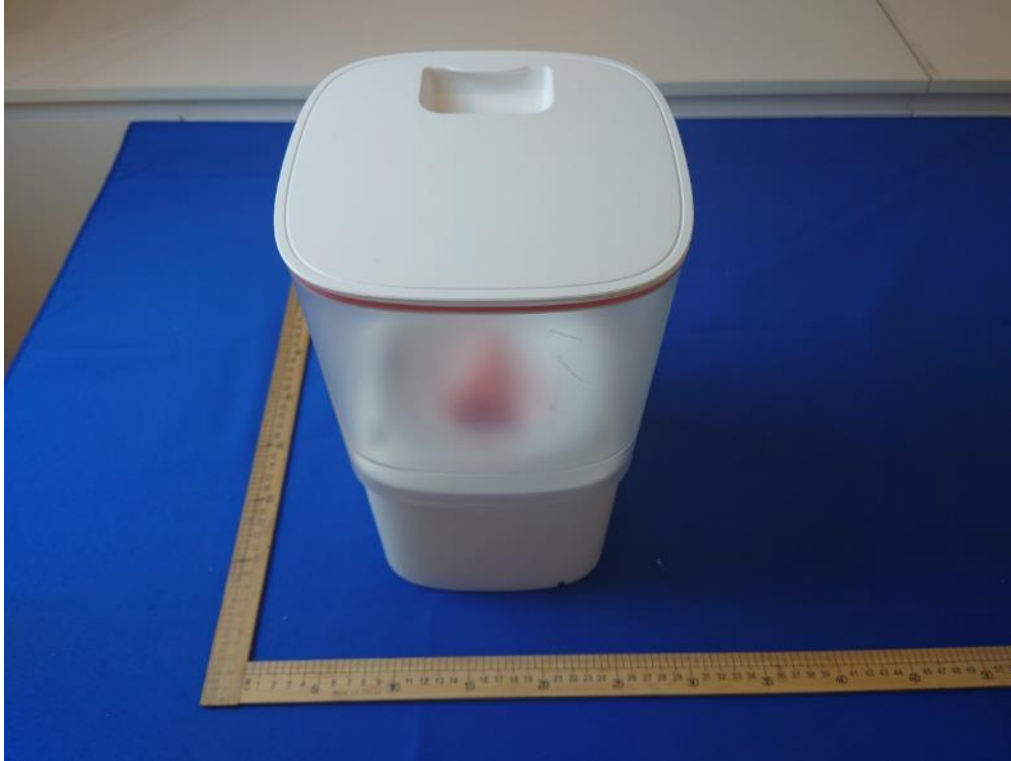
