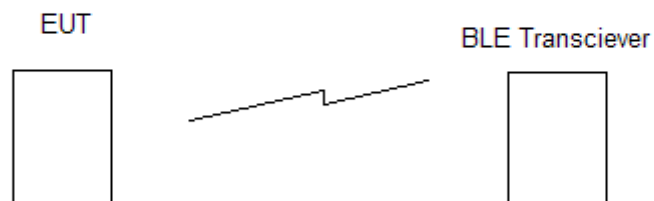

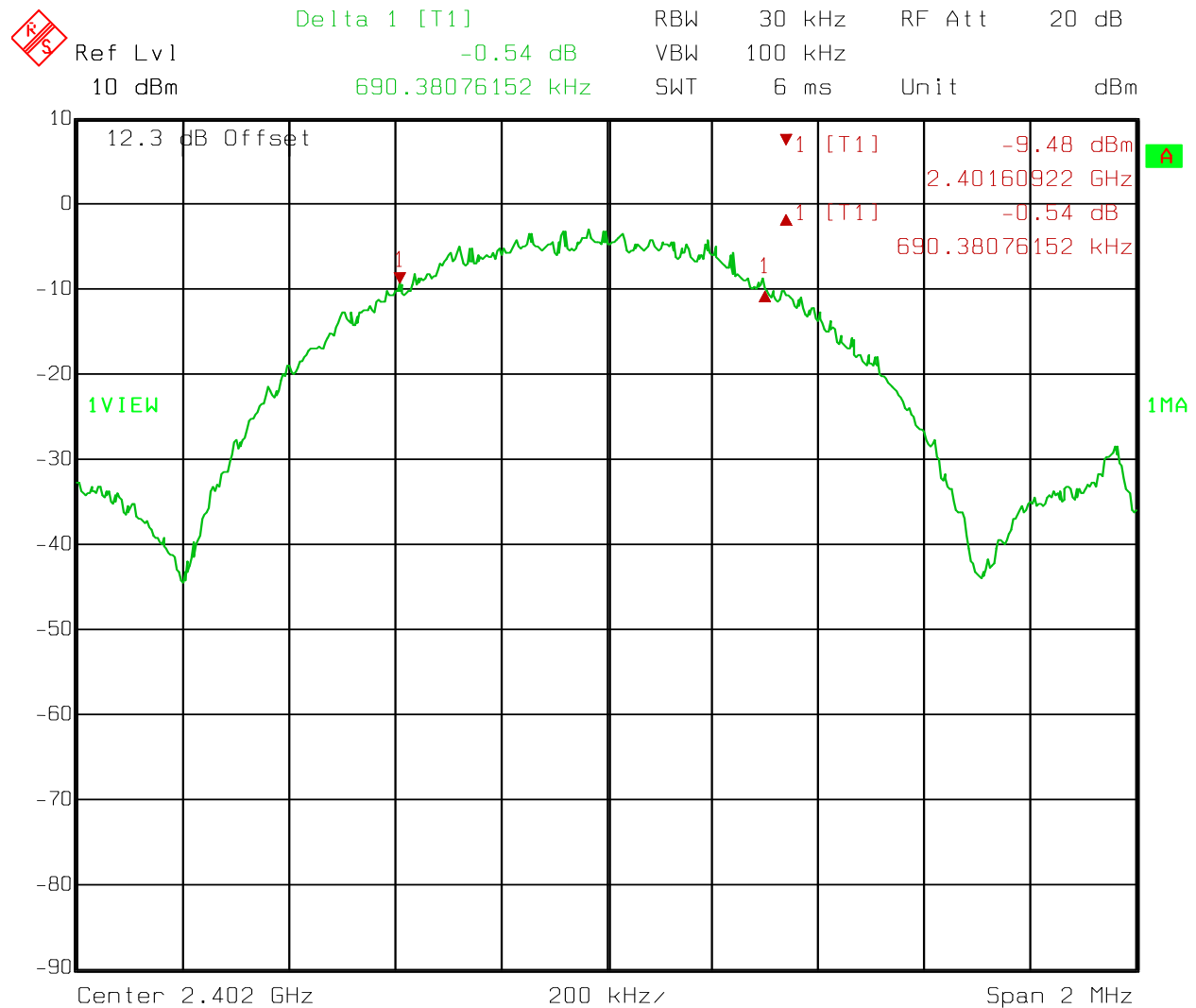

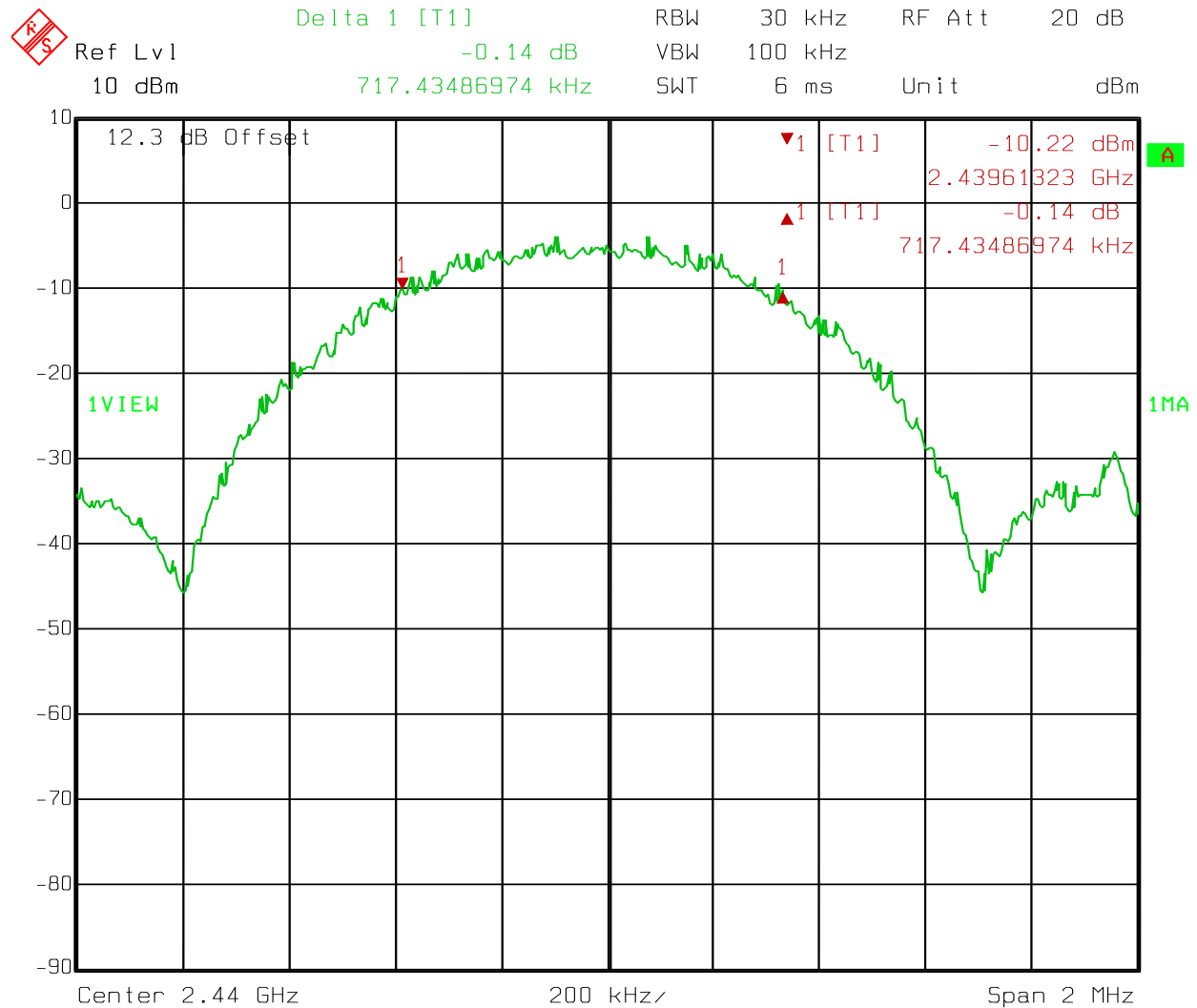

Middle Channel

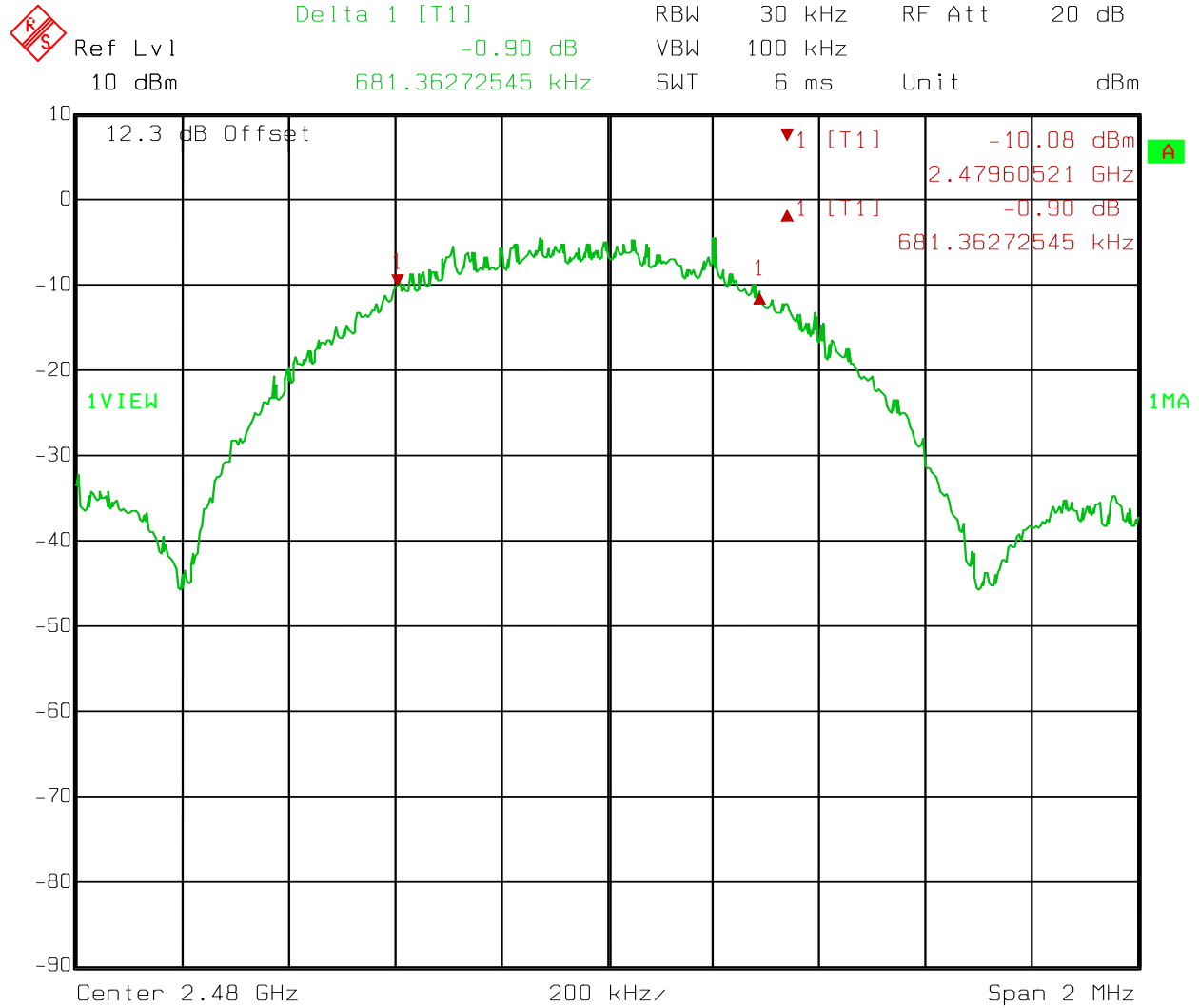

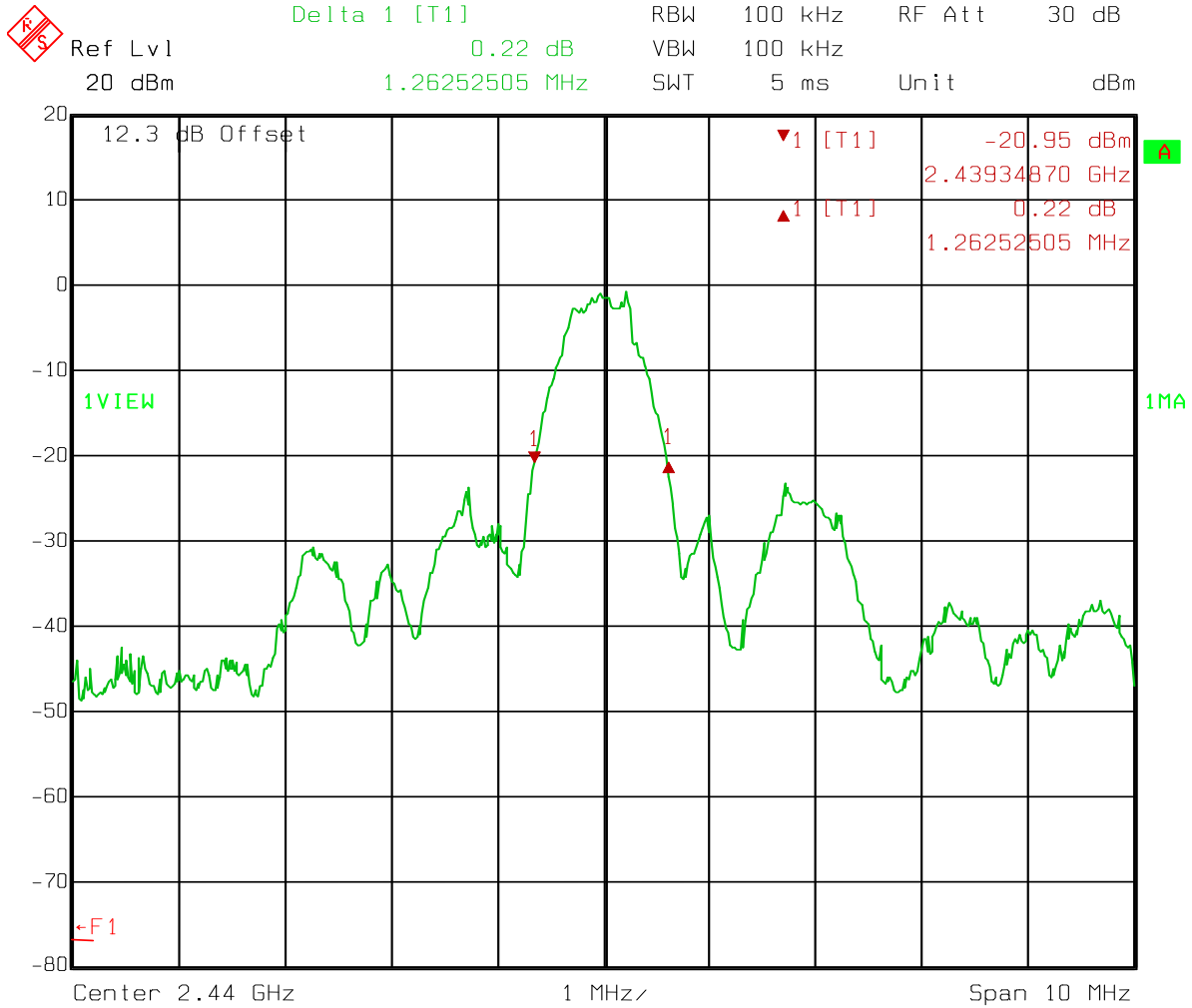
High Channel

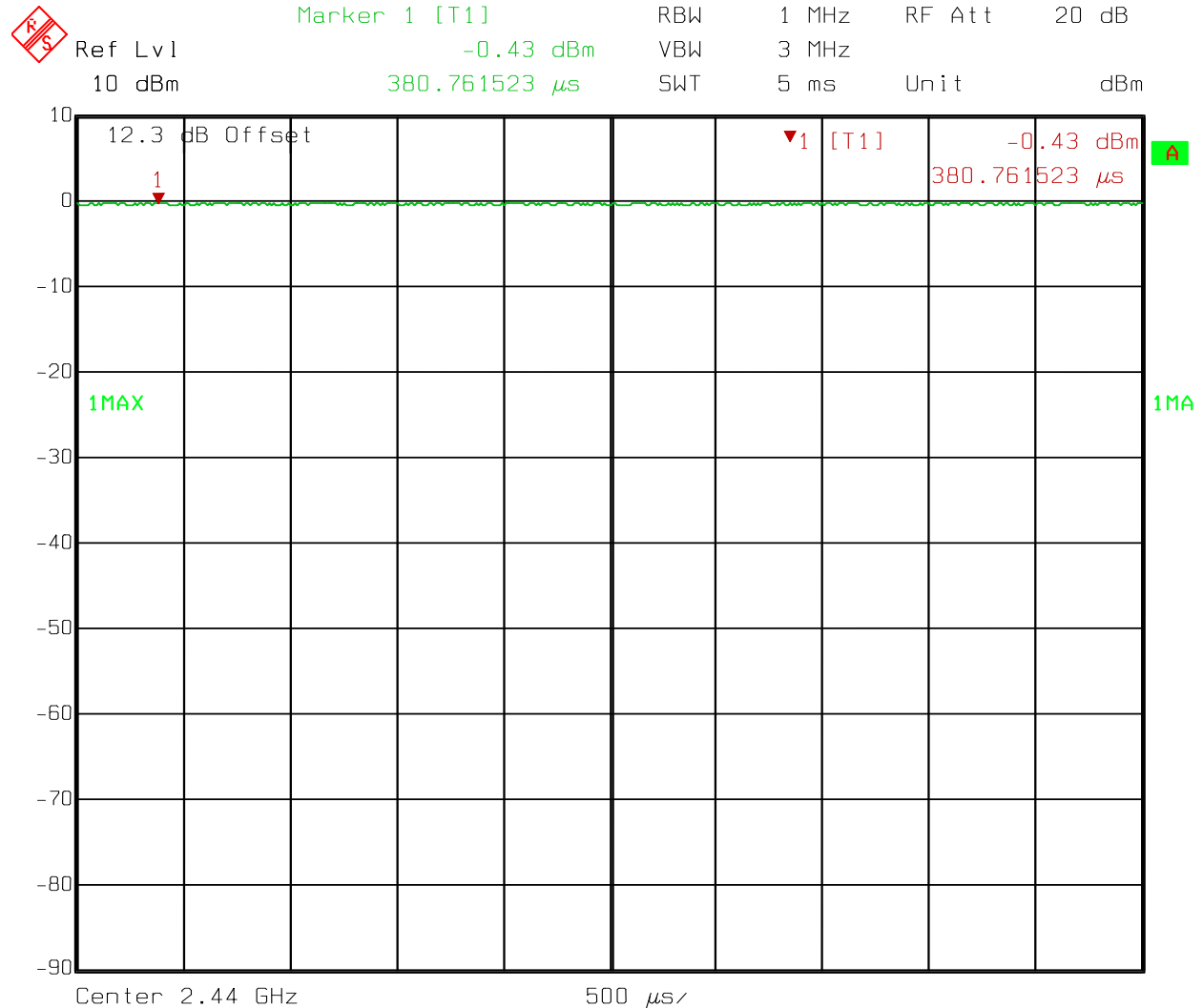

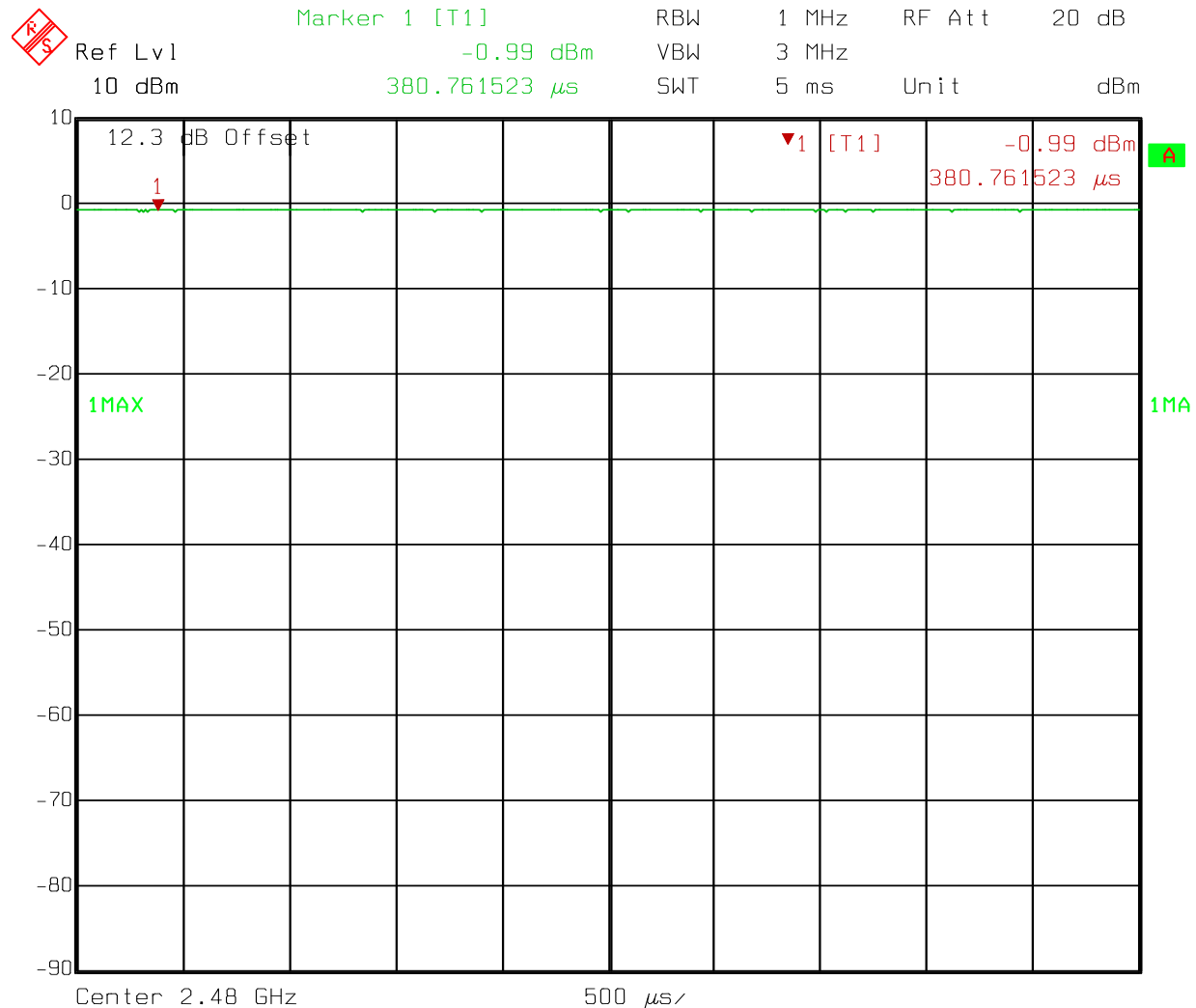

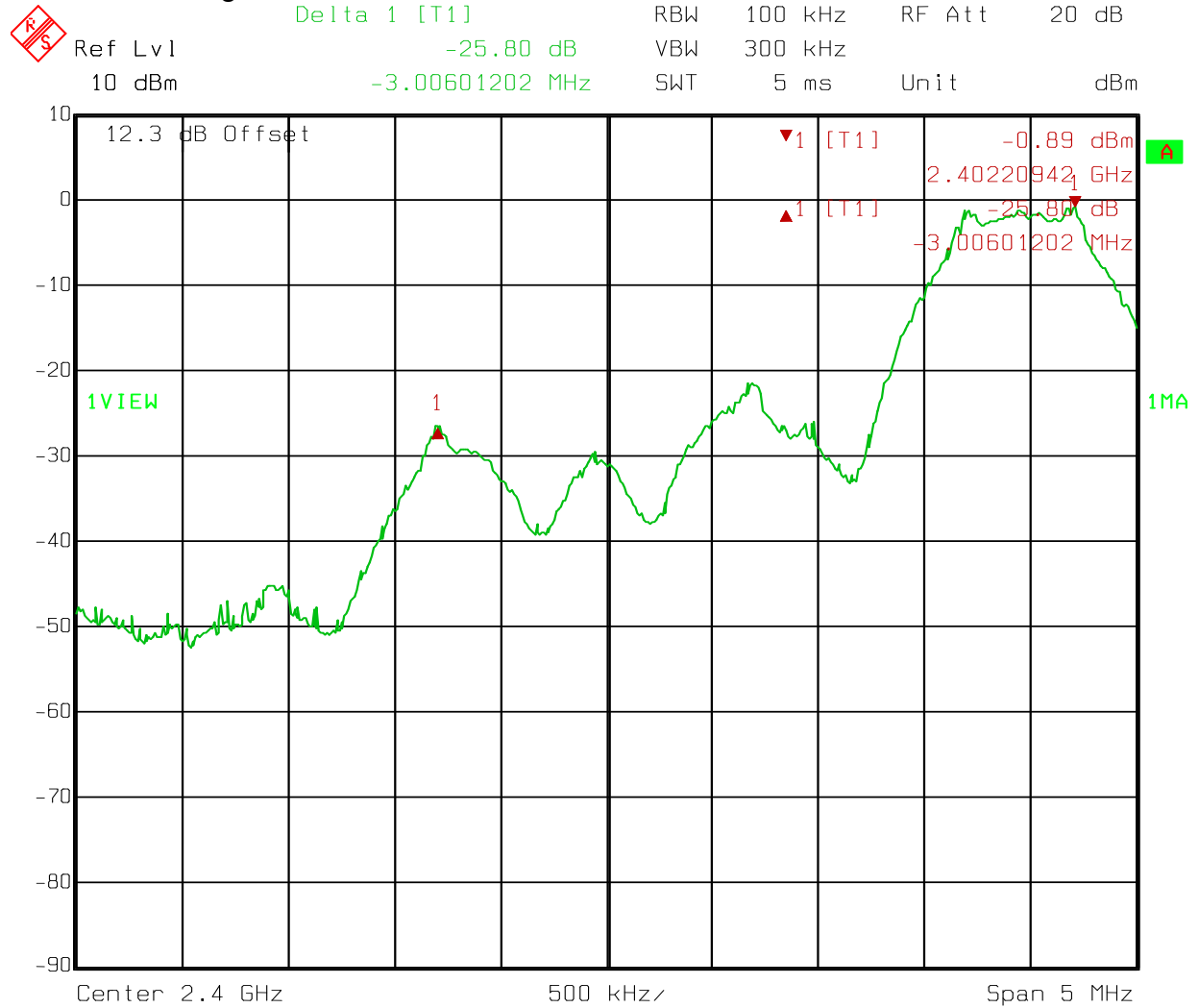

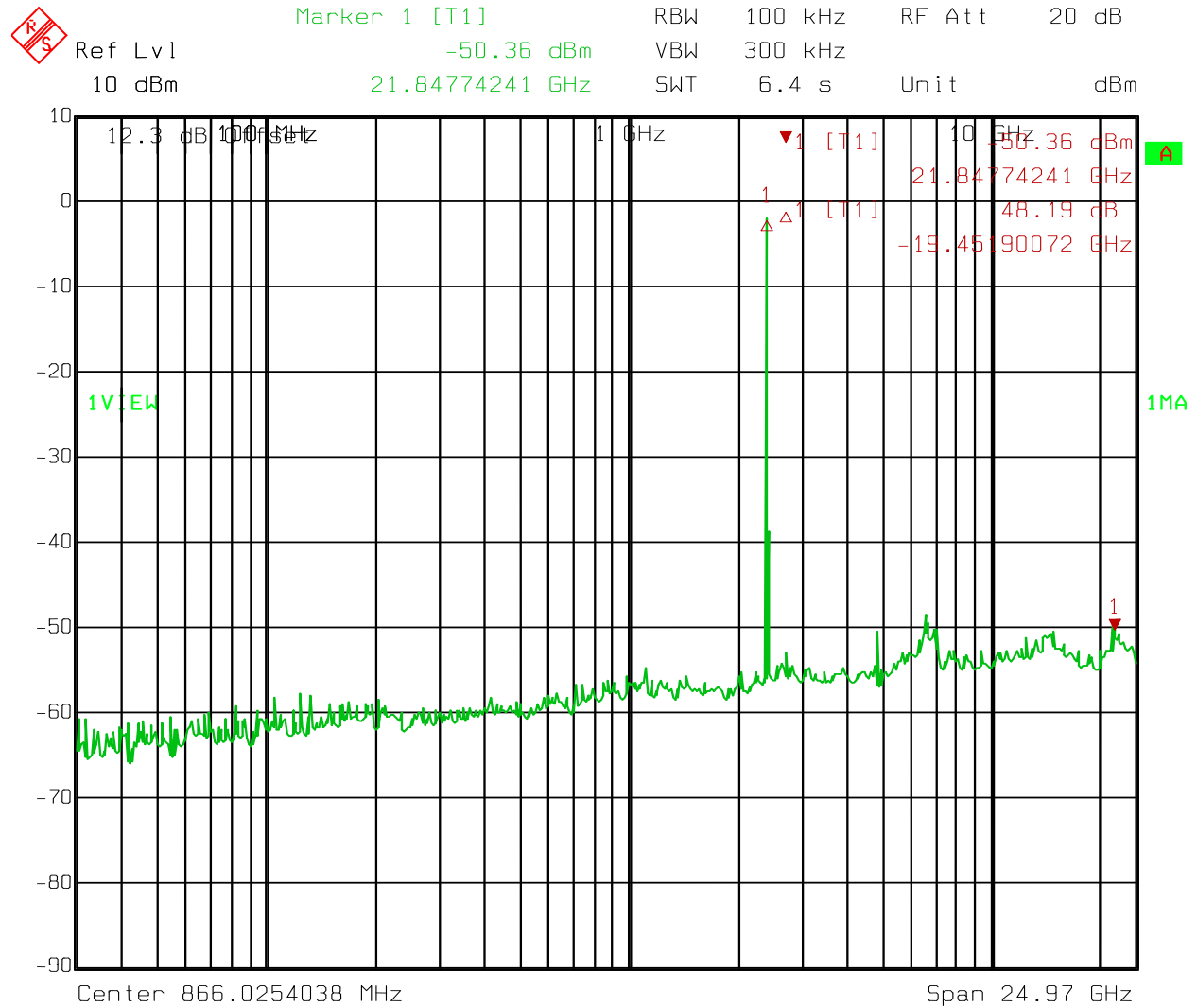
Lower Band Edge

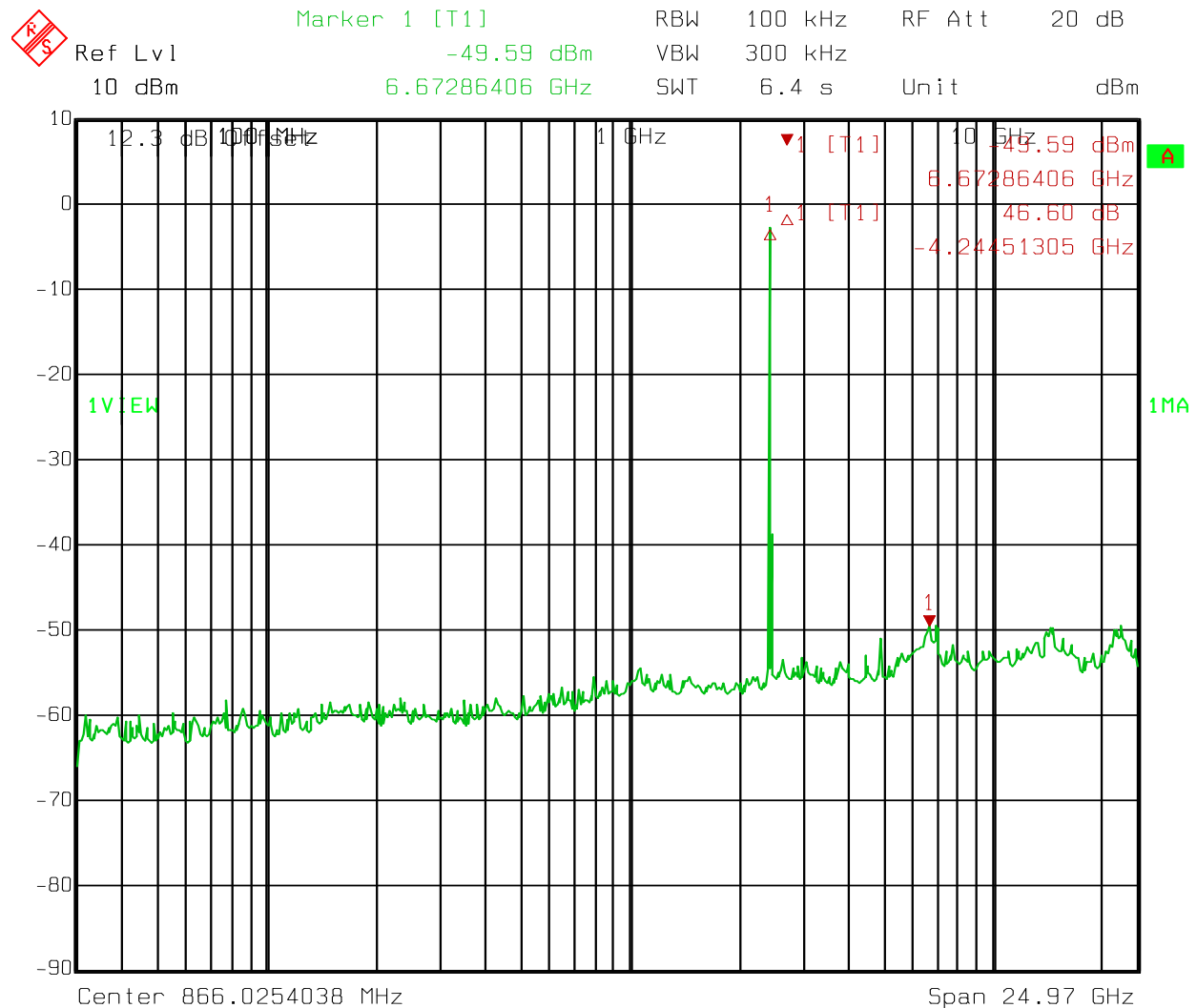

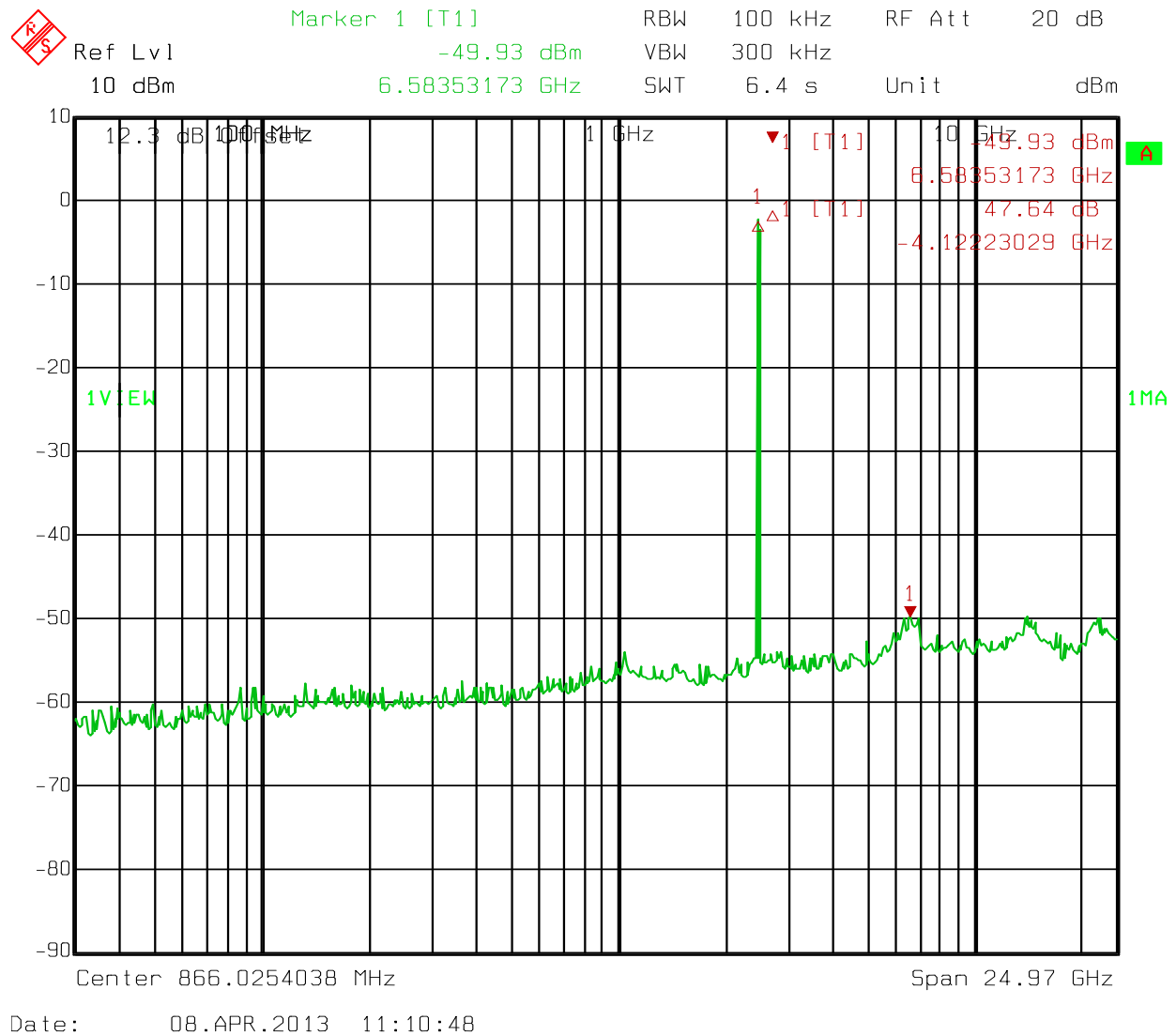
Mid Channel

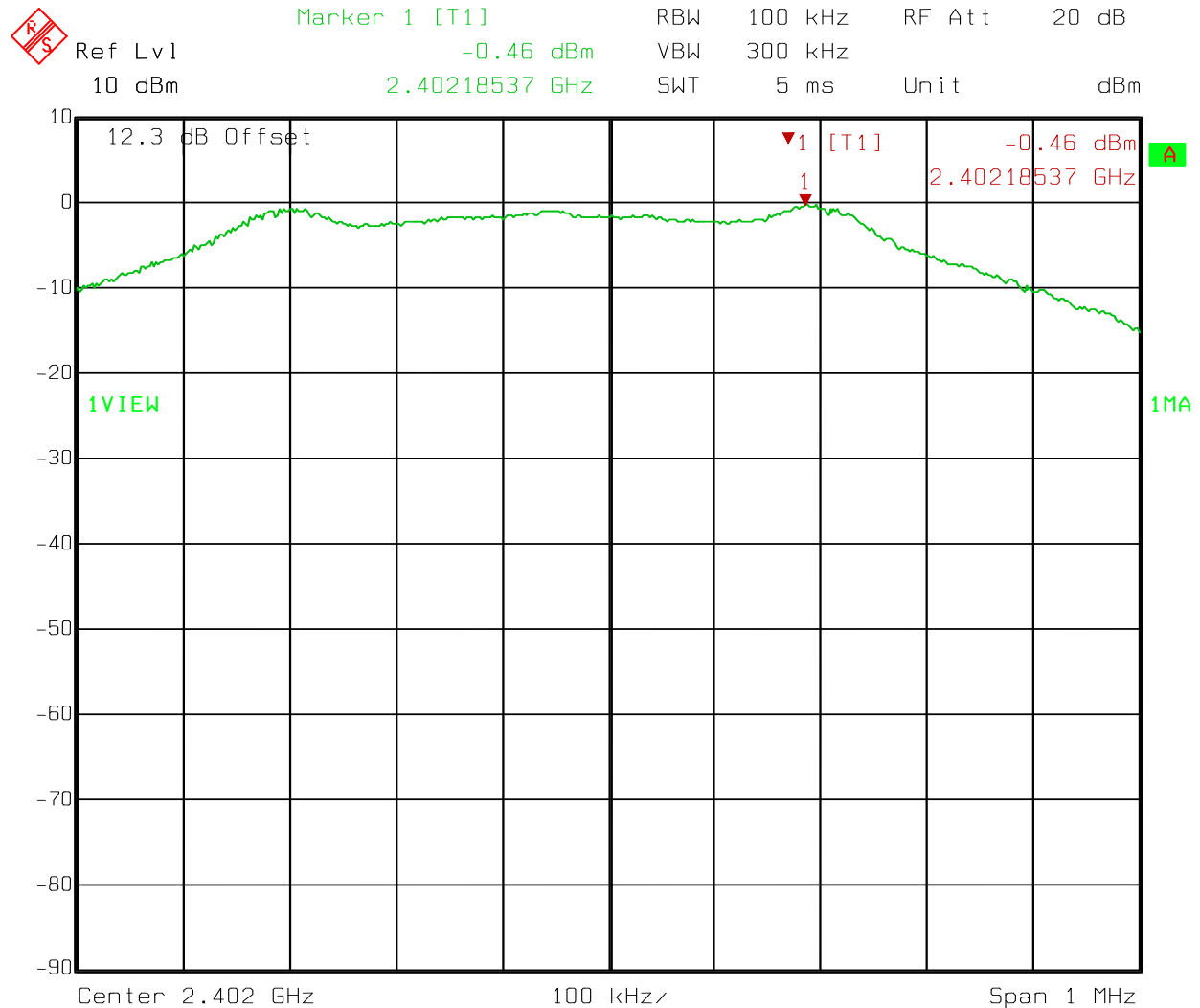

Lower Channel



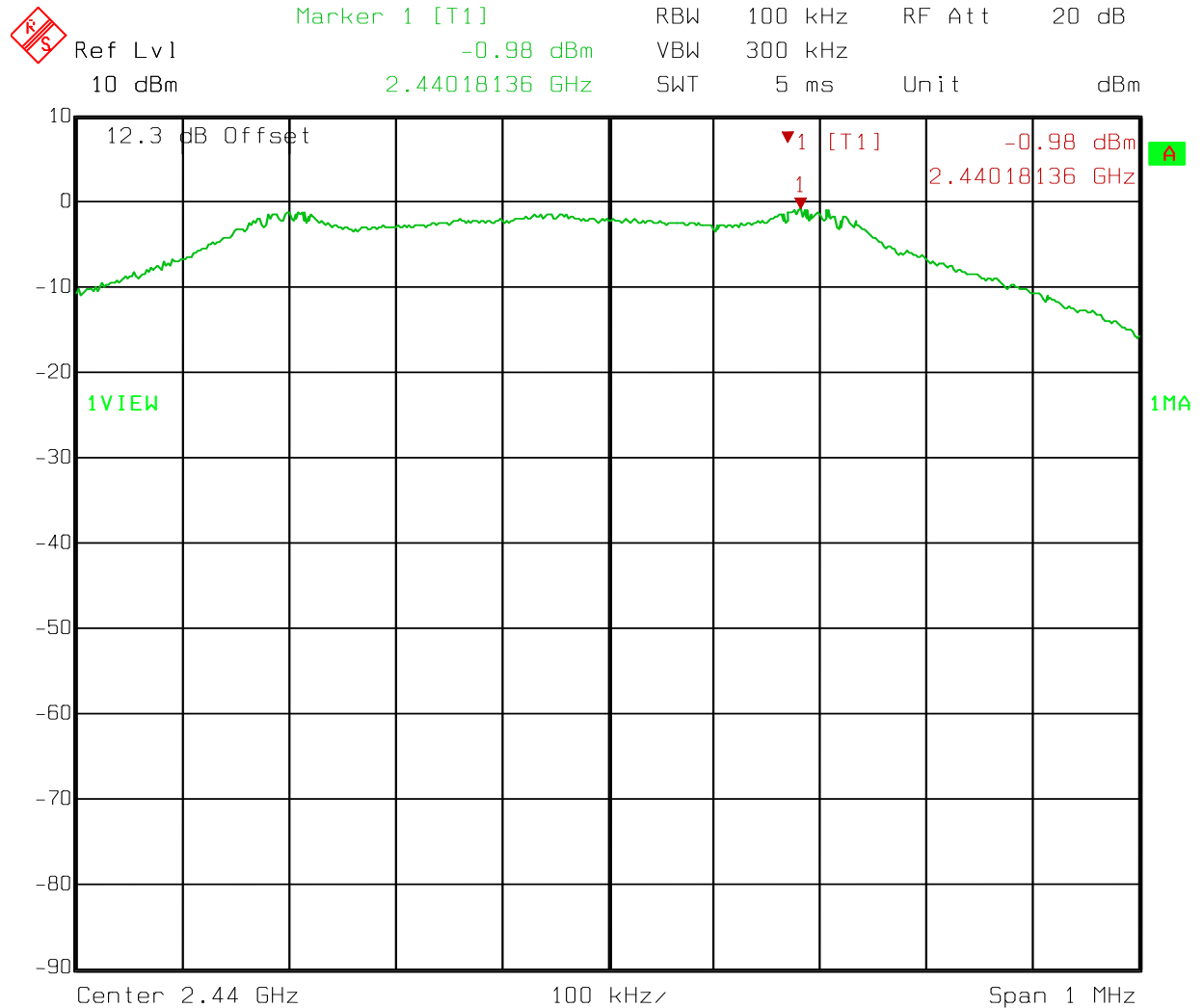

Mid Channel



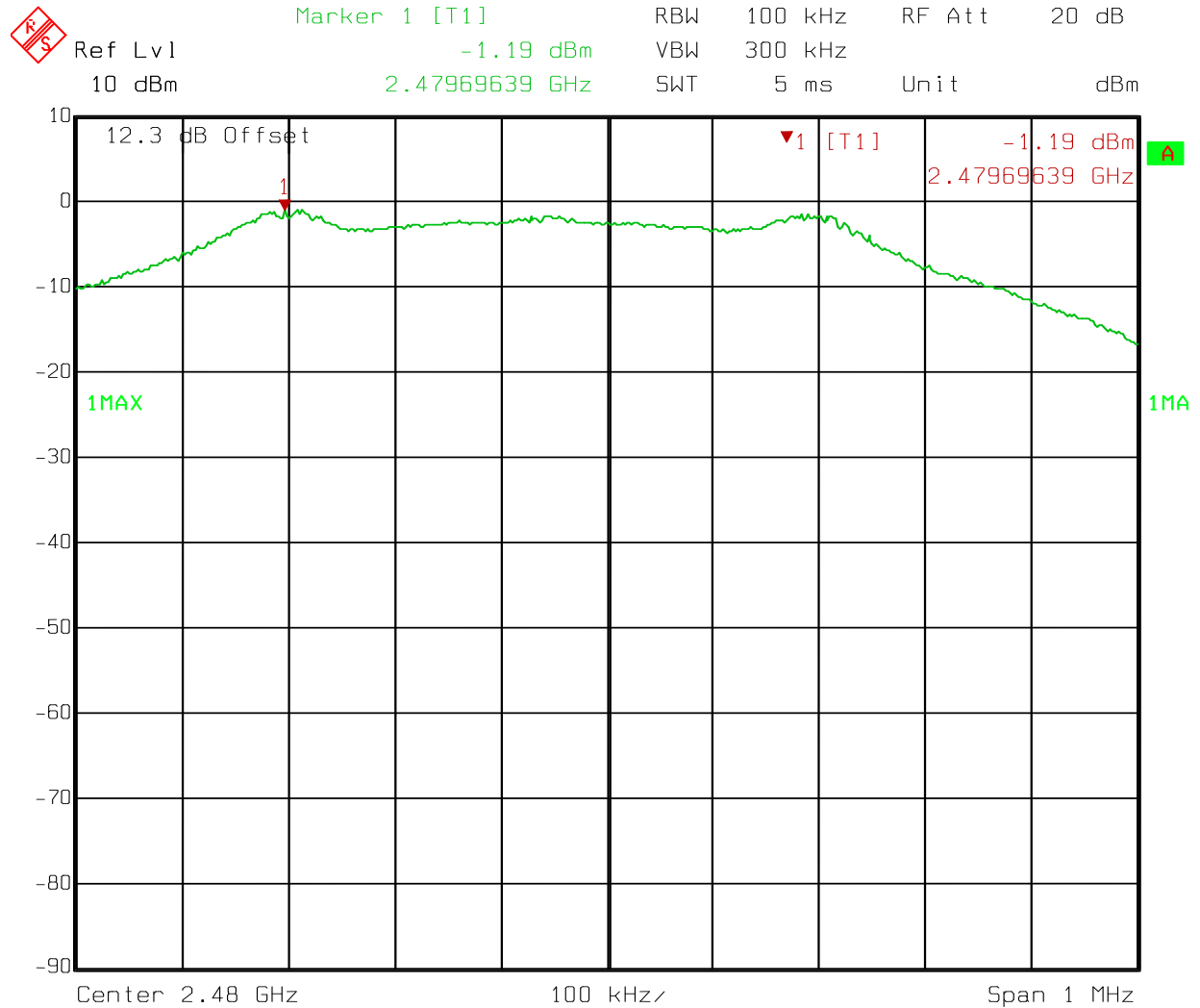

ANNEX A - TEST DETAILS

NAME OF TEST: Maximum Peak Output Power	PARA. NO.: 15.247(b)(3)/A8.4(4)
---	---------------------------------

Minimum Standard: The maximum peak output power shall not exceed 1 watt.

If transmitting antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Systems operating in the 2400-2483.5 MHz band that are used exclusively for fixed, point to point operation may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum peak output power is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceed 6 dBi.

Systems operating in the 5725 – 5850 MHz band that are used exclusively for fixed, point-to-point operation may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter peak output power.

Direct Measurement Method For Detachable Antennas:

1. This procedure requires availability of a spectrum analyzer resolution bandwidth that is \geq EBW.
2. Set the RBW \geq EBW.
3. Set VBW $\geq 3 \times$ RBW.
4. Set span = zero.
5. Sweep time = auto couple.
6. Detector = peak.
7. Trace mode = max hold.
8. Allow trace to fully stabilize.
9. Use peak marker function to determine the peak amplitude level within the fundamental emission.

Minimum Standard:

Systems using digital modulation techniques may operate in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

Method Of Measurement:

EBW Measurement Procedure:

1. Set resolution bandwidth (RBW) = 1-5 % of the emission bandwidth (EBW).
2. Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
3. Detector = Peak.
4. Trace mode = max hold.
5. Sweep = auto couple.
6. Allow the trace to stabilize.
7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission. Compare the resultant bandwidth with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is 1-5 %.

Minimum Standard: The transmitted power density averaged over any 1 second interval shall not be greater than +8 dBm in any 3 kHz bandwidth.

Method Of Measurement:

Measurement Procedure PKPSD:

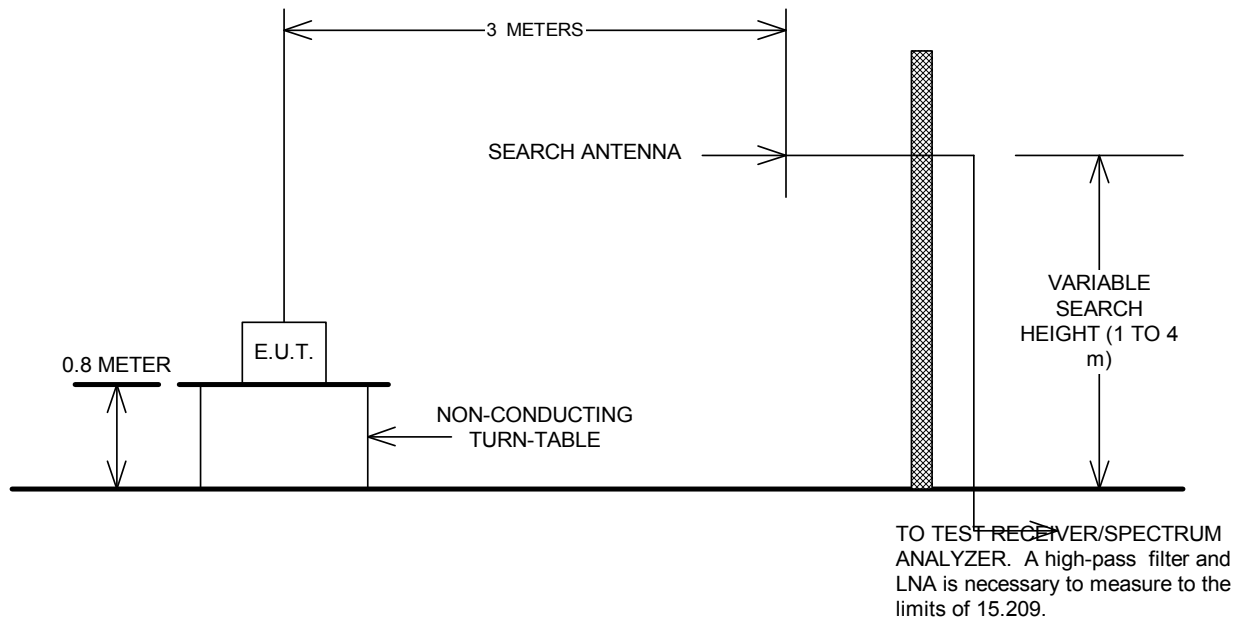
1. Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.
2. Set the RBW = 100 kHz.
3. Set the VBW \geq 300 kHz.
4. Set the span to 5-30 % greater than the EBW.
5. Detector = peak.
6. Sweep time = auto couple.
7. Trace mode = max hold.
8. Allow trace to fully stabilize.
9. Use the peak marker function to determine the maximum power level in any 100 kHz band segment within the fundamental EBW.
10. Scale the observed power level to an equivalent value in 3 kHz by adjusting (reducing) the measured power by a bandwidth correction factor (BWCF) where $BWCF = 10\log(3\text{ kHz}/100\text{ kHz} = -15.2\text{ dB})$.
11. The resulting peak PSD level must be $\leq 8\text{ dBm}$.

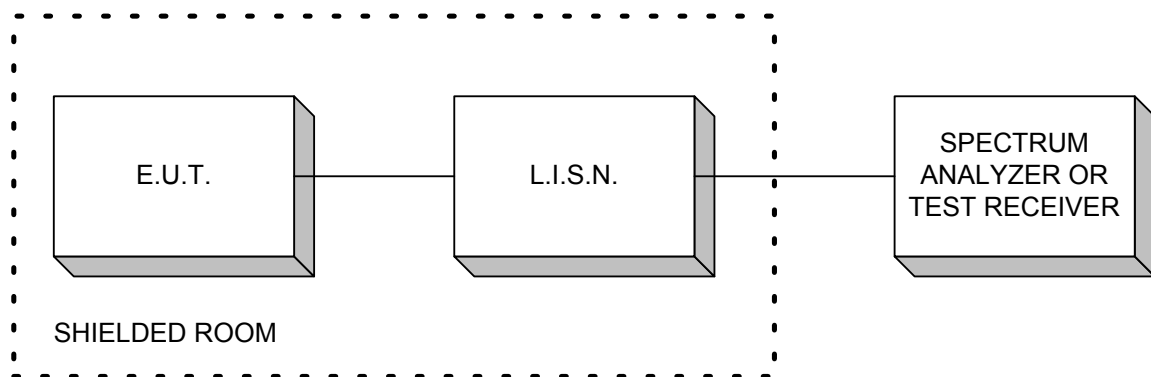

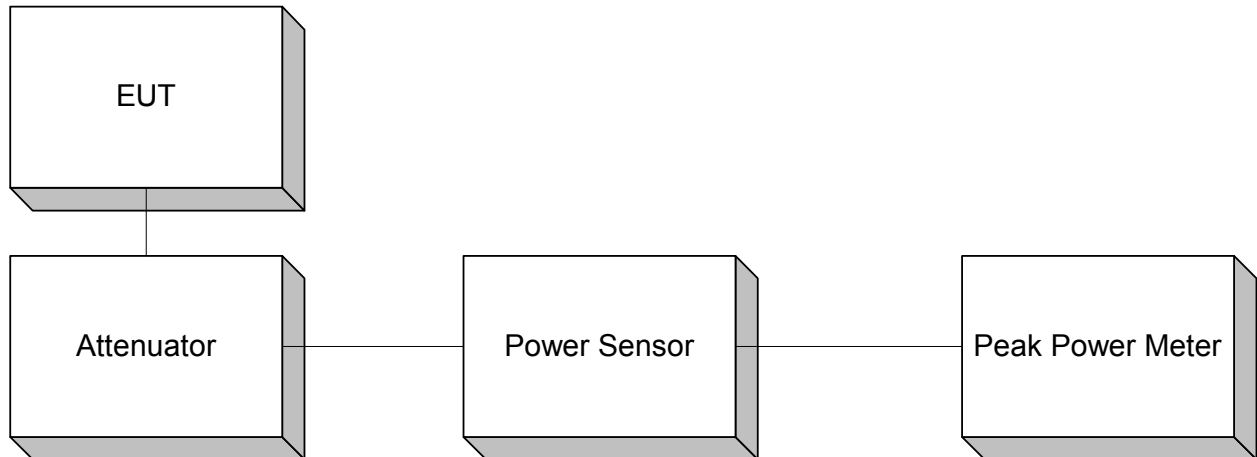
Test Site For Radiated Emissions
