According to 447498 D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

Worse case is as below: [2480 MHz, 6.52 dBm, (4.49 mW) output power]

 $(4.49/5) \cdot [\sqrt{2.48}(GHz)] = 1.41 < 3.0 \text{ for } 1-g \text{ SAR}$
