The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

Estimation Result:

Worse case is as below: [2402 MHz, 4.76 dBm, (2.99 mW) output power]

 $(2.99/5)*[\sqrt{2.402}(GHz)] = 0.93 < 3.0 \text{ for } 1-g \text{ SAR}$

Then SAR evaluation is not required.

Note: Both ears have been tested, only recorded the worse case (right ear) in this report.
