Compatible with devices that have a magnetic sensor.

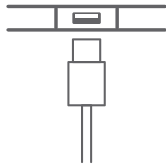
HOW TO USE

1. Connect your charging pad to a certified USB power source using the USB-C cable included.
2. Open your charging pad.
3. Place your device(s) on the charging pad over the lightning bolt icon(s).
4. Adjust your device(s) as needed until you see them charging.
5. Once you’re done charging, remove your device(s) and disconnect charger from power source.

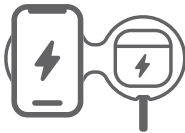
